Out of the 3,444 contracts sent out, 1,181 program confirmation forms (34%) have been returned to the program. That is an increase of 360 over yesterday. And now that we've also issued a flat PDF for providers who were having trouble accessing the online form, uptake should increase substantively over the weekend.

Of the 1,181 forms, 563 have been put into base pay for CCOF funding (48%).

Of the 563 put into base pay, 495 have opted in to the parent fee reduction program (88%) (note: this may include a small group of duplicates as some providers have responded again with the new form – staff will weed them out this weekend).
