Hi Minister Chen

It was nice to touch base briefly over the phone this past Friday. I trust the visit to Chilliwack was enjoyable and informative. Chilliwack MCFD has long standing partnership and relationships with community partners and local/provincial government, inclusive of Early Years and CYSN services. As suggested that I pass on additional feedback regarding Supported Child Development and CYSN service please note a # of issues. Please preference these issues are my perspective and that of SDA MCFD.

## SCD issues:

- -funds for new daycares means many new day care operators, new staff. This won't make spaces available for SCD children unless there is a significant investment in training for daycare operators and staff to support children with special needs.
- -each child who receives SCD support by either receiving funds to the daycare operator through disbursements to pay for support staff for the child, or a staff person from a centre to support the child, must already be supported by a SCD consultant. Even if there is money for the disbursements, if the child cannot be supported by a SCD consultant, the child cannot go to daycare. There is a lack

of funding for SCD consultants so children remain on waitlists.

- a lack of SCD consultant funding means those children on the waitlist have not been assessed for SCD needs or other needed therapies.
- as referenced wait list data at best may not be totally accurate as per self-reporting. i.e. Indigenous communities where children/families who have not been assessed for SCD would not be within our data.

#### CYSN issues:

- -the most needed support requested by parents of children with special needs is regular dependable respite. There is a lack of skilled caregivers in the community, both for parents to hire with direct funded respite funds, or for agencies to hire to provide respite.
- -even with recent funding there are still families on the w/l for respite funding for over a year.
- -parents may have autism funding but cannot find behaviour interventionists. If they train BIs they often leave to work in the school system or for agencies, and the family must start again to find someone to hire.
- -there is a need for respite in staffed agencies or skilled foster homes to provide parents with a break from full time caregiving their youth who has challenging and aggressive behaviours r any children/youth who have high medical needs.
- -there is a lack of staffed residential resources for youth with challenging and aggressive behaviours when the youth needs to come into care. CYSN brought into care are often critical with limited resources and we crisis manage residential placement. System of care is being developed and the work with Placement Review has helped.
- Nursing support services beyond 55 hours per month (Health Authority) are and is the responsibility of MCFD. I.e. child with high health needs in care MCFD would pay for nursing services beyond 55 hours thus cost impact (tens of thousands \$) and from my perspective this is a health service.

Thank you again Minister Chen for attending and meeting Chilliwack community this past Friday.

**Subject:** Concerns with Child Care in BC

Hi Katrine,

I wanted to voice my opinion on the struggles in Child Care in BC. I mean this email with the most respect to everyone's efforts to solve struggles for families within BC. I only voice these concerns as a dedicated ECE who feels I am watching daycare's fail. I'm doing everything in my power to ensure I am able to continue running an exceptional program but fear my efforts can only go so far if changes aren't made. I would happily sit down with someone to discuss my experience in the field and my thoughts on changes that could be made to better shape our children's futures.

I'm a passionate Early Childhood Educator who is certified in three Provinces in Canada, currently running a new daycare in North Vancouver. I have only lived in Vancouver for a year and a half now and in this short time I have come to recognize many flaws in Child Care in BC. I'm writing this email to express the main one. Daycare's are closing down and families and the city don't understand why. The Government is working diligently to make child care more affordable to families which is great, however, if they don't have anywhere for there

children to attend, this doesn't really matter. The real issue with Child Care in BC is the lack of qualified teachers, or just teachers in general! Teachers will come in with their entry level of Education and make more than someone who has worked hard to achieve their Infant and Toddler or Special Needs Certificate above their Basic Early Childhood Education. This is because daycare centres are so desperate to find teachers that they will offer any level of teacher any amount of money, even if they are not qualified, just to meet their ratios. The BC Government has so proudly announced that they are putting \$221 million to open 22,000 new daycare spots but this will do nothing if we don't have teachers to fill those ratios. In Alberta, where I previously lived and worked for 6 years, they have the staffing issue figured out! Childcare is known for its high turn over rate but at least in Calgary that is up to the Directors to run their daycare's to appreciate their staff and have an environment where the teachers want to be. Here in BC, it doesn't seem to matter what you do to show your teachers appreciation and support, the cost of living is high and the pay for ECE's is low. Their is no incentive to further their education so most teachers will remain at the entry level of education and think of their work as just a job and not a career, with that thought process, it is easy to bounce around from work place to work place finding whichever daycare is willing to pay them the most no matter of their education. In Calgary they have an Accreditation program that sets out an extra set of guidelines in addition to the provincial Licensing regulations. The Accreditation program ensures Daycares are being inclusive and multi-cultural and involved within their community along with many more expectations that set a higher standard of care. With this program, the teachers are given a wage top up for every hour they spend working with children. This top up amount depends on the level of Education the teacher has. In Alberta, ECE teachers will have their Level 1, 2 or 3, with Level 3 being the highest supervisor level. Depending on these levels the top up will be anywhere from \$2.14 to \$6.62 additional per hour that they spend working with children. Level 1 will receive \$2.14 per hour, Level 2 will receive \$4.05 per hour and Level 3's will receive \$6.62 per hour spent with children on top of their regular wage. This is a huge incentive for teachers to further their education to make more money while also gainning knowledge in the process and become better teachers.

If BC took a page from Alberta's book and channeled funding money towards the teachers, encouraging them to further their education and also draw more teachers in to the field, not only would we have more teachers to fill the classrooms we already have but we would have more educated teachers to better encourage the development of our children in BC. The issue is not that we don't have the physical daycare spots to accept children, it's that we don't have the teachers to fill the classrooms we already have. Creating more daycare spaces at this point will only add another daycare into the rotation of teachers causing more stress on the facilities we already have. We are grateful that more thought is being put towards the needs of Early Childhood Care and Education but the planned solution will only play more into the real issue.

**ISSUE:** Distribution of the Federal Early Learning and Child Care funding for Early Childhood Educator (ECE) professional development training (\$6.3M)

## **BACKGROUND:**

In B.C., Early Childhood Educators (ECEs) and ECE Assistants are required to complete professional development training (among other requirements) to keep their certification valid. The quality, availability, and accessibility of professional development opportunities across the province can be a challenge for early care and learning staff, particularly those who have been in the sector for several years and are looking for more in-depth, reflective, and advanced professional learning.

As part of the Canada-British Columbia Early Learning and Child Care (ELCC) Agreement, \$16.3 million is being allocated to Priority Three of the Action Plan: a training fund to support recruitment and retention of Early Childhood Educators (ECEs), with the intention to "support individuals to become ECEs or to upgrade their ECE training and to enhance the quality of care provided in child care settings." This priority area is intended to help address the current and anticipated future workforce shortage of qualified ECEs.

This federal funding has been targeted by the Province to support 1) ECE certification, 2) flexible staff development, and 3) new professional development opportunities. \$10 million has already been allocated to ECEBC in fiscal 2017/18 to expand and enhance the newly re-branded ECE Education Support Funding programs, which is supporting targets 1 and 2. This note recommends the remaining \$6.3 million is allocated to a variety of initiatives, which will help achieve targets 2 and 3.

## **DISCUSSION:**

Professional development opportunities for ECEs vary across the Province in terms of availablity and quality. The residual federal funding is recommended to be allocated to increase the availability of high quality professional development opportunities for ECEs working in the child care sector to upgrade their skills and remain current on best practices. The Provincial Child Care Council's (PCCC) Quality Working Group has reviewed the identified priorities, and signaled agreement with many of the proposed initiatives/streams (some

of the proposed initiatives emerged after consultation with the PCCC). Additionally, the Ministry of Advanced Education, Skills, and Training (AEST) have provided input and suggestions to help inform the proposed initiatives. Further consultation/engagement with key stakeholder organizations will commence upon approval of the proposed initiatives.

Based on the advice of PCCC and AEST, and in alignment with the terms of the federal ELCC Agreement, the following streams and/or programs are proposed to distribute the remaining \$6.3M in federal ELCC funding (see Appendix A for further details):

- ECE Standards of Practice and Occupational Competenices Project (\$0.075M);
- Leadership, Administration and Management (\$1M);
- Ethics (\$1M);
- Family Child Care training and professional development (\$0.75M);
- Early Childhood Environment Rating Scale-Revised (ECERS-R) Aboriginal Addendum Project (\$0.5M);
- ECE Mentorship Project (\$0.75M);
- New Relationship Trust Foundation Early Years Bursary Program (\$1M); and
- Professional Development Bursaries (\$1.2M)

The specific contractors, funding amounts, and development/delivery of the recommended professional development programs will be defined through targeted consultations with sector partners over fall 2018, including Indigenous stakeholders, once the proposed initiatives are approved, with contracts in place early by early 2019.


