Hi Kat,

I will be down in Victoria for my course at RRU towards the end of this month. The course runs from February 22-24.

While I am in Victoria, I wanted to use this opportunity to hopefully meet with Minister Heyman, and possibly his Deputy Minister Mark Zackarias, to share with them the work that Living Lakes Canada is

doing in BC. We have some great projects and initiatives on the go, including groundwater monitoring in the Columbia Basin, environmental DNA testing (eDNA) throughout the province, and a Columbia Basin Water Monitoring Initiative.

The Columbia Basin Water Monitoring Initiative is facilitating a collaborative, systemic guiding framework for addressing priority water monitoring data collection and data storage needs in the Canadian Columbia Basin, including the development of a data hub. With the participation of all levels of government, including First Nations, this initiative is building upon the backbone of water monitoring data from Federal and Provincial governments to fill water monitoring gaps and needs. The resulting data will be open and accessible and will facilitate easier public access for all decision-makers making climate relevant water and land use management decisions that affect ecosystem and community health.

I have some flexibility with setting up this meeting. It could be before or after my course at Royal Roads. So either Thursday, February 21; Monday, February 25; or Tuesday February 26. The

Executive Director of Living Lakes Canada, Kat Hartwig, would also like to participate in this meeting. I understand the 25th or 26th works best for her, but the 21st may still be possible.

Depending how it all works out, I would be interested in sitting in on QP one day as well. Or whatever else you would suggest participating in while I am in Victoria.

Let me know what else you need from me to set up the meeting with Minister Heyman.
