The power was out across all of Powell River yesterday so I'm just getting to this now. Please see the attached Consent for Release of Information for and the TWO attached emails from \$.22 s.22

No doubt you've heard of Isaac's case here in Powell River. It was all over twitter and on the news (See: <a href="https://www.mycomoxvalleynow.com/47015/powell-river-teen-with-special-needs-airlifted-to-vancouver-for-care/">https://www.mycomoxvalleynow.com/47015/powell-river-teen-with-special-needs-airlifted-to-vancouver-for-care/</a> AND <a href="https://globalnews.ca/news/4761552/powell-river-teen-with-special-needs-desperately-awaits-medivac-to-vancouver/">https://globalnews.ca/news/4761552/powell-river-teen-with-special-needs-desperately-awaits-medivac-to-vancouver/</a>)

MCFD, and I believe SDPR, are also aware of the current situation right now in Powell River regarding the placement and care of another youth with a disability (see <a href="https://www.prpeak.com/news/wildwood-residents-express-concern-about-inclusion-powell-river-residence-1.23482983">https://www.prpeak.com/news/wildwood-residents-express-concern-about-inclusion-powell-river-residence-1.23482983</a>). Some community members are displeased about where the young man lives. This young man's story brings to light the situation of caring for youth with disabilities who are

non-verbal, potentially aggressive, have a history of SiB, low-functioning autism, etc.).

- s.22 situation is similar but he is currently under the care of his mother.
- s.22 is currently in Vancouver in the hospital but they want to discharge him back to Powell River.
- s.22 does not think this is a good idea, for a number of reasons (INCLUDED IN THE TWO EMAILS).
- is hoping that a STAY can be put in place to keeps.22 in Vancouver until the necessary steps are taken to better care for Isaac back home in Powell River.
- believes that CAPE (Child and Adolescent Psychiatric Emergency unit) has not sought community collateral. No investigation has been made into what happened to \$.22 at school, etc. She believes that although Isaac is stable, family and community capacity must be considered when planning to return a child to the community.

She is requesting that \$.22 remain in CAPE until the end of January. She says "this will allow the agency (STRIVE, in Powell River) time to hire and train staff, retain a behavior consultant, develop a plan of intervention, and for mcs.22 to seek alternate housing arrangements as \$.22 needs cannot be safely met in our current housing."

Alternatively \$5.22 states: "Alternatively, I suggest that Arcus Community Services under the direction of Dr. Glen Davies {ABLE clinic} be contracted to provide a short term emergency placement with a family development response plan while our home community undertakes to acquire enough staff to fulfill contract deliverables."

truly believes tha \$.22 will deteriorate rapidly if he is removed prematurely without the proper things in place and a comprehensive plan.

MLA Simons is away until the end of December, back early January. He is aware of this situation.

Our office is sharing the concerns of \$.22 and I hope that something can be done to help this family and their situation.

This has been a long road for \$.22 and as Isaac gets older, his needs are becoming more complex.

- The program is optional for child care providers. As of December 2018, 90% of eligible child care organizations had applied to opt-in to the program.

- Each child care provider that applies for the Child Care Fee Reduction Initiative (CCFRI) is asked to provide their historical, current and planned monthly fees in order to ensure the intended benefit for parents is not unreasonably diluted through fee increases.
- If the provider has planned fee increases that are higher than expected norms, they are asked to provide supporting evidence to explain why such an increase is necessary.
- •Current and planned fee increases will be reviewed to see if the increased fees are in line with other provider fees in the area and if the reason for the fee increase is because of a genuine, unexpected expense.
- •Before raising fees, child care providers are expected to first explore other funding options, such as the Childcare BC Maintenance Fund.

HI Katrina,

Hope this finds you well and enjoying this beautiful day. I'm following up on my earlier conversation with you where we touched on 1-2 ideas for possible projects between Douglas College and the Ministry. I will be coming to Victoria this month, (arriving mid-afternoon of Jan 21<sup>st</sup> and departing end of day Jan 22<sup>nd</sup>) and would like to continue our discussion as your time allows. Alternately, we could meet or connect by phone whenever is convenient for you, when you are in Vancouver. My thought is to have a brief brainstorming conversation with you to see what areas/issues might benefit from some applied research. My intention is to set up a brief, preliminary meeting with you, to give you an overview of how we might work together and to discuss any issues of concern/interest to your Ministry that might benefit from some applied research activity. This would be followed by a full length meeting with the head of the Applied Research Initiative, Eamonn O' Laocha, to meet with you and your team to narrow the focus to 1-2 specific projects.

I am including here the Vision, Mission and Objectives of our Applied Research group, known as DARE (Douglas Applied Research and Education).

'ision: "Dare will be recognized as a world class applied research center."

Aission: "To positively and measurably enhance student learning and faculty development through the high impact learning practice of applied research and to positively and measurably impact our wider community through the commitment, expertise and passion of our faculty, students and research partners."

## )bjectives

- To create high volume, high quality and high impact student learning through applied research and education practice opportunities
- To make a positive, significant and measurable impact through our applied research projects with and for our partners
- To create, apply and disseminate new and useful knowledge through the delivery and evaluation of applied research projects
- To create opportunities for faculty to develop and enhance their expertise through engagement in applied research activities
- To increase the levels of applied research capacity within Douglas College and within our partner community organizations

About Applied Research at Douglas College – projects and process

Projects generally evolve out of an issue which has been "sitting on the side of a desk" for a while, and which is not being attended to for lack of time, expertise or resources. Project ideas often start out with the words, "It would be great if we could..." or "What our community needs is a way to..." A

project would be driven by a level of urgency but would not be mission-critical to ministry operations. The results of the project should offer enough value to justify the research partners' participation in the project in terms of briefing, funding and oversight as arm's length partners. We are good at ensuring that we have a fit in terms of expertise and resources. We usually second an instructor to the project as research lead, along with research assistants and project management inside the Applied Research Project Management Office.

While the process may seem a bit vague at the beginning, our process does not start with us formulating a project (this would be a bit like tailoring a suit without measuring the client) Rather we meet to see where our partners have ideas, issues or concerns in operations or planning that would benefit from faculty and student expertise to take a step forward, and co-create the project with them - it is truly a partnered approach from start to finish. We have a system in place within Applied Research where we have a small pipeline of projects, and a process to ensure a good match between industry and Douglas College capacity.

In the broadest terms, we perform best on applied research involving **economic development**, **community healthcare**, with an overall focus on co-creating social good. The research itself could be anything from designing an app or new process, recycling and modifying technological waste for use by marginalized populations, *analyzing data to identify innovative initiatives*, addressing issues of communication or marketing, *etc.*. The process involves introducing our AR team to a range people who share interests in the above-mentioned general areas for a preliminary brainstorm to see where the needs are. In summary, our focus is the generation of positive social impact through partnered, project based applied research.

Let's chat to discuss how we might go forward. I would be happy to meet as required with teams within the ministry for a brief advance discussion along the lines noted above, to see whether participation in the larger brainstorm session is desired. We could then engage with the resulting group for a brainstorm on their vision(s) for a working with a problem in the general topic areas, and narrow down to a more contained project.

This is devastating news to the ECE's of our program. > In response to these additional costs we have increased our financial contribution from \$240,450 to \$460,000 by taking a larger construction loan/mortgage but still have a budget shortfall of \$280,000. We have applied and reached out to other sources of funding and asked for additional funds but were unsuccessful.

> We are now at a point where we need to urgently get confirmation of funds and start construction on January 3rd, 2019. Otherwise we may have to cancel this project, resulting in these new, much needed, early age spaces not being created, and potentially also affecting our current program.

>

> We are thus asking for your assurance that the BC Provincial government can help us and can provide our Society the additional \$280,000 required to complete our project because of changes to the BC building code. We would never have signed the funding agreement with the government if we knew that, because of forthcoming legislative changes, it would be impossible to complete the project.

> We hope to discuss this with you this month and discover how we can work together to ensure our project and similar ones in the Province can be successful within the new constraints.

Apologies for the delayed response. We were waiting on some information from the City of Victoria.

In the fourth intake of Child Care Major Capital Funding the James Bay Child Care Society was awarded \$388,548 in funding to create 16 pre-school spaces (3 to 5 years old) and 8 infant spaces (0 to 18 months old).

The project is located in a house that was to be renovated and expanded to accommodate the new spaces. In discussion with City of Victoria staff, they indicate that they have met, on a few occasions, with representatives from the Society to explain the zoning and building code requirements. The City's position is that they've been clear with the Society from the very beginning about the by-law requirements (which have been in effect since 2012 and have not recently changed as suggested below) and most of the concerns are related to safety and inclusion aspects of the proposed renovation, which the City is simply not willing or able to waive. The Mayor was also approached and provided the Society with the same response.

As identified below, cost escalation is a factor here, but unfortunately under the terms of their funding agreement with the ministry, all cost overruns are the responsibility of the Society and there are no other avenues for the Ministry to offer additional funding. Gaming Grants would be the next option, and the project would likely fall within their eligibility requirements; however, the Capital Gaming Grants don't open up again until April and the maximum funding award is up to \$250K, which according to the figures below won't cover all of the additional costs.

I've asked my team to provide me with more information related to original Major Capital Funding proposal to help to confirm the information from the City and whether the Society had completed its due diligence during the planning phase of this project. However, there simply aren't immediate provincial funding mechanisms available to address this particular situation.

As an aside, I would also want to work with the society to better understand the cost

escalation – given the society has put forward an additional \$200K of their own funding (bringing to the total to \$460K) and there is still a \$280K shortfall, indicates there is something very wrong with the overall project. I would be concerned about how over extended the Society may be and how they plan to recoup the additional costs while remaining viable over the term of the service commitment.

> We are writing to ask for your help, urgently and as a last resort, to ensure the completion of our project, which will result in the creation of much needed early child care spaces in downtown Victoria. (Attached are details of our project and a summary of the work completed and hurdles faced to date.)

> Our project aims to construct a new facility to provide quality child care spaces and an innovative Early Childhood Educators (ECE) training centre, resulting in the expansion of an exceptional group childcare and aid in the recruitment and retention of qualified educators. We will expand by adding 16 pre-school spaces (3 to 5 years old) and 8 infant spaces (0 to 18 months old) to our current 8 toddler spaces (18 months to 3 years old).

> In January this year, after 4 years of applying, we succeeded in securing a BC Government Child Care Capital Grant of \$388,548 (Agreement Number C185406006174, now called Childcare BC New Spaces Fund) to help fund our expansion project.

>

> Our grant and rezoning design (and budget) were for a Part 9 (BC Building Code – Residential) building, as applicable at the time, in which the new requirements for fire and safety, including sprinklers, of Part 3 (BC Building Code – Commercial building) for a childcare center were already added. However, the building code changes that occurred after the design covenant and rezoning were completed, now classify childcare center as public commercial buildings (i.e. requires full compliance with Part 3, including full accessibility and an elevator). These changes, the time elapsed, and the cost for commercial grade material, have increased the project cost significantly and have caused unanticipated stress and hardship on the local families who are counting on this built.

>

> In response to these additional costs we have increased our financial contribution from \$240,450 to \$460,000 by taking a larger construction loan/mortgage but still have a budget shortfall of \$280,000. We have applied and reached out to other sources of funding and asked for additional funds but were unsuccessful.

>

> We are now at a point where we need to urgently get confirmation of funds and start construction on January 3rd, 2019. Otherwise we may have to cancel this project, resulting in these new, much needed, early age spaces not being created, and potentially also affecting our current program.

> We are thus asking for your assurance that the BC Provincial government can help us and can provide our Society the additional \$280,000 required to complete our project because of changes to the BC building code. •The Child Care Fee Reduction Initiative (CCFRI) is intended to support families by providing child care providers with funding to lower their monthly child care fees.

- •The program is optional for child care providers. As of December 2018, 90% of eligible child care organizations had applied to opt-in to the program.
- •Each child care provider that applies for the Child Care Fee Reduction Initiative (CCFRI) is asked to provide their historical, current and planned monthly fees in order to ensure the intended benefit for parents is not unreasonably diluted through fee increases.
- •If the provider has planned fee increases that are higher than expected norms, they are asked to provide supporting evidence to explain why such an increase is necessary.
- •Current and planned fee increases will be reviewed to see if the increased fees are in line with other provider fees in the area and if the reason for the fee increase is because of a genuine, unexpected expense.
- •Before raising fees, child care providers are expected to first explore other funding options, such as the Childcare BC Maintenance Fund.
- •Although the ministry is not able to share the specific details of a provider's application, parents are encouraged to report any concerns about the CCFRI or their provider's fees to the Child Care Operating Funding Program. The Program will review the information provided by the parent and, where the information conflicts with the provider's application, the Program will refer the information to the Verification and Audit Unit for follow-up and/or investigation.
- •Parents are also encouraged to speak with their providers about their participation in the CCFRI, and can also view the list of all CCFRI participating providers on the web.
