During the summer and fall of 2018, the Government of Canada has been actively engaging with national, regional, and community organizations representing First Nations, Inuit and the Métis Nation, as well as Treaty Nations, self-governing First Nations, provinces and territories, experts and those with lived experience. Over 65 engagement sessions have been held with nearly 2,000 participants.

On November 30, 2018, Minister Philpott, together with Assembly of First Nations National Chief Perry Bellegarde, Inuit Tapiriit Kanatami President Natan Obed, and Métis National Council President Clément Chartier, announced that the Government of Canada will introduce co-developed federal legislation on Indigenous child and family services in early 2019.

In anticipation of introducing this legislation, please find attached a document summarizing the content for your consideration. In addition, we are pleased to advise you that we are in a position to share the entire text of the draft proposal in advance of a face to face meeting. The

document containing the text of the draft proposal will be sent to you by courier to your respective addresses. As such, we would ask that the material be treated as confidential and that it not be widely distributed or published

I would also like to invite you to attend a meeting on January 29 and 30, 2019, in order to hear your initial thoughts and go through the proposal clause by clause. The meeting will be held in Salon Châteauneuf at the Crown Plaza Hotel, 2 Montcalm Street, Gatineau. This would be a technical conversation. The meeting is scheduled to begin at 9 am each day. Refreshments and lunch will be served.

We've been asked to review some bullets to be included in speaking notes for Parliamentary Secretary Glumac during his two-day PNWER Capital Visit. PS Glumac will be speaking at a lunch panel on the first day of his visit. The panel will be held next Tuesday Jan. 29, 2019 in Washington State. He's been asked to talk about Cascadia Innovation Corridor, Columbia River Treaty (CRT) and the importance of collaboration.

Kathy has reviewed and made a couple of tweaks – are you okay with them from the CRT perspective?

Columbia River Treaty

- Collaboration is also important in other fields like water management.
- The Columbia River Treaty is another example of strong cooperation among our governments.
- For over 50 years, this agreement has helped reduce flood risks in the U.S. portion of

the Columbia River Basin and has helped manage water flows to generate carbon-free electricity, among other benefits.

- This treaty has also become an important component for recent efforts to protect and enhance U.S. endangered salmon.
- Although the agreement has provided some benefits to Canada, there are ongoing significant costs and impacts for managing water flows on the B.C. portion of the river basin.
- Canada's Indigenous people and local communities have dealt with drastic fluctuations in reservoir levels, which cause environmental, economic and cultural losses to meet treaty requirements of our U.S. neighbours.
- We're working with the U.S. to modernize the Columbia River Treaty and ensure that benefits created are equitably shared in both countries.
