I have some notes for the meeting MLA Leonard was having with a constituent regarding non-apprehension.

Please see below:

The Constituency Assistant for MLA Leonard is planning for a meeting with a constituent who is asking for the MLA's support of the "No Apprehension Policy" in Duncan.

- In Duncan, advocates have requested that the community become a "no apprehension zone" in relation to child removals.
- The Ministry of Children and Family Development (MCFD) is mandated to uphold the provisions of the *Child, Family and Community Service Act* (CFCSA) in the Province of British Columbia.
- The Designated Director under the CFCSA of Child delegates the provision of child protection services across the province to child protection social workers.
- The CFCSA requires that anyone who has reason to believe that a child may be abused, neglected, or is for any other reason in need of protection, must report it to a delegated social worker.
- Reports are investigated by social workers who take the most appropriate action that is least
 disruptive for the child, including providing or arranging the provision of support services to
 the family, supervising the child's care in the home, or protecting the child through removal
 and placement with relatives, a foster family or specialized residential resources.
- It would be contrary to the CFCSA to place a blanket prohibition on child removals in any geographic area of BC.
- If children are removed, the Ministry understands the significance of connection and endeavors to place the children with extended family, people known to them or within their cultural community prior to considering foster care.
- The Ministry must also demonstrate to the court that least disruptive options have been considered when a removal occurs.
- Throughout child welfare involvement, MCFD is very open to meeting with parents, extended families, community partners and service providers in an effort to ensure planning meets the best interests of the children.

I am writing today, to you both about the need for a Canadian investigation and report for Canadians like the U.S. did in their Interior Columbia Basin

At first read, it almost felt like we (B.C.) were relying on the U.S. for data, within our own country.

Also, in the Columbia River Treaty negotiations, do not let the U.S. prioritise U.S. net benefits over BC and Canadian benefits.

We too should, "Integrate restoration of terrestrial and aquatic ecosystems with other management actions (e.g., roads, recreation, and timber harvest)." This would help us, to stop killing off our entrusted, endangered species, for example the Mountain Caribou.

Also, these are good ideas, we could implement;

"Riparian management areas, Riparian management areas are designated based on the best available science and appropriate ecological and geomorphic criteria.

Planning Principles: •

Provide for physical integrity of aquatic ecosystems. •

Provide an amount and distribution of wood sufficient to sustain physical and biological complexity. •

Provide adequate summer and winter thermal regulation. •

Provide appropriate amounts and distributions of source habitats for riparian- or wetland-dependent species. • Restore or maintain water quality and hydrologic processes. •

or maintain naturally functioning riparian vegetation communities. • Protect the structure and function of features outside riparian areas that are important to the integrity of riparian areas and water bodies, such as landslide-prone areas. •

Provide for management of riparian areas for protection and restoration of

aquatic/riparian habitats, water quality, and drinking water. • Provide for treatments that meet aquatic/riparian objectives and balance short-term ecological impacts (e.g. temporary reduction in shade on streams) against long-term gains (e.g. increased resiliency to disease within riparian stands) for the enhancement of aquatic and riparian resources while providing economic and social benefits."

In closing, thank you both for all you do.

Also, we want our fish back in the Slocan valley, and we need effective Water use planning (WUP) and Operations on the Arrow Lakes reservoir, to include a stable Mid-Arrow so we can get back 100 square kilometers of riparian zones for all species, but especially for our failing fish stocks!



Each Ministry may obtain a maximum of 12 named passes. In addition to the 12 named passes, the ministry can request an additional three generic "Staff" passes. The three "Staff" passes are the responsibility of each Minister's office, and it is recommended that they be **returned to your office after each use**. **More than three Staff** passes will not be issued.

All passes are valid for the entire 4th Session of the 41st Parliament. Please make your Ministry officials aware that they should <u>retain their passes until a new Throne Speech</u> heralds the commencement of a new Session. A lost or misplaced Floor Pass will not be replaced.

Every individual named on a Floor Pass must pick up and sign for their pass **in person** in the Speaker's Office. The generic "Staff" passes may be picked up by Ministers' office staff. We are located in the Speaker's Corridor (Room 207).

Please forward any names to my attention, either by e-mail or by telephone. If you have any questions now or in the future, please don't hesitate to contact the office at 387-3952.

For your information I am attaching guidelines regarding protocol and etiquette for Ministry officials while present in the Chamber. The guidelines are provided to Ministry officials when the Floor Pass is picked up.

I believe you asked Ministerial Assistant Alisma Perry for an update on the Japanese Adoption program.

I have been sent information from staff for you to share with MLA Eby.

- The Ministry of Children and Family Development (MCFD) is committed to resolving the Japan Adoption Program suspension as soon as possible. We acknowledge the heartache and stress this situation is causing many families and their friends.
- The reason for the suspension is that significant concerns were brought to the attention of the
 ministry in May 2018 regarding possible legal irregularities involving adoption of Japanese
 children by Canadian families. We immediately suspended the program and it remains
 suspended until there is confirmation that all processes align with the laws of both countries.
- On January 30, 2019, the BC Assistant Deputy Minister, Child Welfare, and the Provincial Director of Adoption met with the Director General, Immigration Program Guidance Branch, Canada, to review the documentation received from the Japanese Government regarding adoption and to discuss a plan to implement a strengthened BC Japan Adoption program.

The following next steps were agreed to:

- BC will strengthen its BC Japan Adoption Program to ensure that all parties are acting in the Spirit of The Hague Convention and that additional safeguards (eg. additional oversight), is in place to support Japanese birth parents when providing consents.
 Ways to achieve this are currently being explored and will be reviewed and agreed to by BC and Canada.
- o Agreements between BC and the Japanese Adoption Agencies will only be made with those Japanese adoption agencies that are licensed by the Japanese Ministry of Health, Labour and Welfare (MHLW).
- Given the complexity of this matter it is difficult to estimate when the strengthened BC Japan Adoption Program will open.
- BC and Canada agree that resolving this matter in a collaborative and timely manner is a priority.
- In addition, prospective BC adoptive parents can choose to adopt through the Japan Special Adoption Program which is independent of the BC Japan Adoption Program.

- The B.C. Government is committed to undertaking a comprehensive look at the financial supports for caregivers.
- As part of the work to understand the financial supports for caregivers, Ministry of Children
 and Family Development staff have spoken with caregivers, community organizations and
 social workers and completed a comprehensive jurisdictional scan to understand how
 caregivers are financially supported in other provinces and territories across Canada.
- Ministry of Children and Family Development staff have already begun efforts to accumulate needed information and collaborate with community partners to develop potential solutions.
- Consideration has been given to innovative payment models from across Canada, including the Alberta payment model.
- Many foster families, support organizations and social workers around the province spoke of
 the need to provide more funding to caregiving families. We are taking their feedback, as well
 as approaches taken by other provinces and territories, into consideration as we develop
 potential changes to the caregiver payment model.
- Currently, recreation is included under the foster family care rate.
- In B.C., caregivers may be eligible for exceptional payments, which provide additional funding beyond the care home payment to meet the needs of the child or youth in their care.
- Camp fees for children and youth may be provided as one-time-only exceptional payments.
- Exceptional transportation costs may be provided when transportation costs exceed what can reasonably be expected to be covered by the foster family care rate.
- Approved exceptional transportation costs are paid at \$0.51 per kilometer that exceeds 325 km of driving per month.
- The Ministry of Children and Family Development is aware of the per diem rates provided to caregivers in Alberta. Currently, any per diem rates for caregivers are negotiated by caregivers.

I know I've emailed you in the past asking if there will be an increase of payment to foster parents from the current (roughly) \$800 a month.

I've had another constituent ask me if your ministry can provide me with some questions to the following:

- 1) Like Alberta (see attached Caregiver Rate Schedule), are there plans for MCFD in BC to give a yearly recreational allowance to foster care families? In Alberta, a child can get anywhere from \$675 to \$775 a year for recreation activities. Currently, it's my understanding that in BC, foster families often have to pay these expenses.
- 2) In Alberta there is a \$500 per 12 months period "Camp Fees and Vacation Allowance" are there plans to have something similar in BC?
- 3) In Alberta, if a foster family has to drive their foster child to and from 'visits' (with biological family, etc.), families get \$0.505 per KM. I don't believe this happens in BC.
 - a) The person I spoke with told me that she spends 400-700 per month on gas driving their foster child to and from these visits or mandatory appointments (counselling, etc.).
- 4) In Alberta, there is also coverage of Breakfast Lunch and Dinner when travelling are there

plans to have this in BC?

I am looking for clarification on the point about caregivers receiving support equal to that of foster parents:

The Budget Highlights page has two paragraphs about this (page 3):

"Family-based caregivers looking after children will see their support payments increase by \$179 per month starting April 1, 2019 . . . "

"Extended family, like grandparents and aunties who support children and keep them out of care, will have their support payments increased to match those of foster parents"

We have met with Grandparents who are raising their grandchildren and have legal custody or

guardianship of them. Will this group be affected by these changes.

I am concerned because if the second group noted above in the line "Extended family, like grandparents etc" refers to those who are part of the Extended Family Program – then grandparents who have legal custody or guardianship will not receive the foster parents support because they are not eligible for the EFP. The Extended Family Program reads like the intent is to get the children reunited with their parent(s) ...

Here is the wording from the Extended Family Program:

The person looking after your children is called their care provider.

Your children are placed with their care provider through an <u>Extended Family Program agreement</u> (sometimes called an **EFP agreement**). This program gives your children's care provider financial support and other support services.

Not everyone is eligible for the program:

• If your children are already with a care provider who has court-ordered **custody** or **guardianship** of them, they're *not* eligible.
