This letter is to notify you that the above noted Agreement will terminate as of March 31, 2019 pursuant to the *Terms and Conditions of the Service Agreement* clauses 47 (b). Please note you will receive a Modification Agreement highlighting the contract term change.

Our Ministry appreciates the work that you and your colleagues have done over the past years to improve coordination and share community-based information with families. We recognize it takes an array of partners and levels of government to support young children and their families.

Over the past 12 months, the Ministry of Children and Family Development has worked to examine how we support early years services. Our main goal is to improve consistency and access to direct early years services across our province. As a result, the Ministry has created an *Early Years Service Framework* outlining the services supported by the Ministry in the early years. To support implementation of the Framework, a decision has been made to realign Ministry investments to reinvest these funds to direct early years services effective April 1, 2019. Given the scope and mandate of Early Years Centres, it has been decided that this initiative will conclude March 31, 2019 and funds will be reallocated to direct services via a Request for Proposal (RFP) process.

A Notice to Vendors is currently posted on BC Bid (<u>bcbid.gov.bc.ca</u> Notice to Vendors: Early Years Service Framework) outlining our Ministry's commitment to implement the <u>Early Years Service Framework</u> through a RFP process which will see newly established early years Service Agreements in place for April 2019.

The Ministry believes that having additional services such as parent/child drop-in programs, parenting supports and early childhood development programs will increase support to parents, build stronger peer to peer relationships, and promote families' sense of belonging. Agencies are invited to submit a proposal to the RFP planned for direct early years services in November 2018.
