ISSUE: Hospital alerts

BACKGROUND:

MCFD/Delegated Aboriginal Agencies (DAA's) receives calls from the public, families, communities, public bodies and service providers about expectant parents (predominantly vulnerable and marginalized women, frequently Indigenous) who may be involved in behaviours that might put the infant at risk, once born.

These calls frequently trigger an investigation and subsequent notification (hospital or birth alert) between MCFD/DAA and hospitals that directs the hospital to notify MCFD/DAA immediately upon the birth of the baby. Approximately 28% of the time hospital alerts result in removal of the infant from both Indigenous and non-Indigenous mothers. Hospital alerts include personal information about the expectant parent and are issued without their consent.

On June 4, 2019 the *National Inquiry on Missing and Murdered Indigenous Women and Girls* (MMIWG) released their final report which describes hospital alerts as discriminatory and racist based on the disproportionate rates of apprehension of Indigenous infants and children. The report included the following Call for Justice: *We call upon provincial and territorial governments and child welfare services for an immediate end to the practice of targeting and apprehending infants (hospital alerts or birth alerts) from Indigenous mothers right after they give birth.* Additionally, the report addendum identifies the need to examine the legal basis of hospital alerts. Although there has been no legal action taken in BC since the practice of hospital alerts began, this may create a future litigation risk.

DISCUSSION:

MCFD has made the decision to end hospital alerts as of October 1, 2019. The ministry will move to a voluntary services model in their work with expectant parents designed to provide them with preventive and support services. This will only be done with their consent. In addition, also with their consent, information may be shared with service providers and Indigenous communities before birth.

MCFD will continue to work with the First Nations Leadership Council, the federal government and a transitional governance structure still to be confirmed to design a new policy and legislative framework to implement Bill C-92 in BC. This may include further work around the role of MCFD in the prenatal period.

NEXT STEPS:

MCFD and the Ministry of Health are implementing a communication plan and change in practice for the health sector, e.g. health authorities (including the First Nations Health Authority), physicians and community health nurses, and health services providers, around the cessation of hospital alerts and the new voluntary services model.

Other stakeholder communications will include: Delegated Aboriginal Agencies, Métis Commission, Métis Nation BC, the Representative for Children and Youth, and provincial and territorial child welfare agencies under the *P/T Child and Family Welfare Protocol Agreement*.

GCPE is engaged and will be providing materials for public messaging including a potential public announcement in September 2019.
