I just wanted to circle back with you about the request for thermometers from MLA Rice's Office as I know you were interested in the outcome.

- Some child care centres also indicated a desire for thermometers. At this time, the Provincial Health Officer (PHO) does not recommend temperature testing as a screening device. s.13; s.22
- The PHO recommends diligence in hand hygiene and keeping a clean environment as best practice in protection against the spread of COVID-19.
- The Ministry of Children and Family Development (MCFD) is aware that child care centres throughout the province have reported difficulty accessing some cleaning supplies.
- MCFD is heartened by the number of providers who have chosen to remain open to provide care for the children of essential service workers and other families who need it throughout British Columbia.
- The Ministry is exploring options for supporting child care providers to access these supplies.
- The Ministry will communicate directly to providers if they are able to source supplies in a way that supports their organization and operations.

I have also shared this information with MLA Rice's Office as well as let them know about the checklist that we are working on as an alternative to this request. I told them I will share the checklist with them when we are done.

I understand you are getting a lot of information in your inbox right now. It is hard to keep up with everything we need to know. Today I want to share a few updates with you that you should be aware of.

March 31st The Provincial Government announced that <u>School Districts will now be responsible</u> for offering care for school-age children of Tier 1 workers in schools at no cost.

Tier 1 workers include Health and Health Services, Social Services, Law Enforcement, First Responders, Emergency Response workers. List of essential service workers here

What this means in Vancouver: VSB is opening several schools to provide this service. We are waiting for a contact person to refer families to register for this care. VSB intends to have an online form or website for parents with more information.

Westcoast Child Care Resource Centre (WCCRC) has an online portal to our referral service for essential workers on our website here: https://forms.wstcoast.org/s3/childcare-needs. We are asking all parents living or working in Vancouver who are essential workers with children aged 0-12 register for a referral through our website. We will refer the parents to the appropriate resource for their families. We will also help families with access to the BC Affordable Child Care Benefit to help pay for child care.

The Ministry of Education has been working closely with school districts and independent schools to identify and support children, aged five to 12 years (kindergarten to Grade 6), whose parents are essential service workers, with a focus on public health and health services, social services, law enforcement, first responders and emergency response sectors. School districts and independent school authorities have been asked to ensure students whose parents work in these fields have access to care during regular before-, during- and after-school hours.

Hours of care will vary by school district and independent school. If essential service workers who have school-aged children need before-, during- and after-hours care for their children, they are asked to contact their school district directly. Most school districts have already reached out directly to families through surveys to gather information on urgent child care needs.

Note: in Vancouver don't contact the school district, but go through the WCCRC portal at www.wstcoast.org

I understand you are getting a lot of information in your inbox right now. It is hard to keep up with everything we need to know. Today I want to share a few updates with you that you should be aware of.

March 31st The Provincial Government announced that <u>School Districts will now be responsible</u> for offering care for school-age children of Tier 1 workers in schools at no cost.

Tier 1 workers include Health and Health Services, Social Services, Law Enforcement, First Responders, Emergency Response workers. <u>List of essential service workers here</u>

What this means in Vancouver: VSB is opening several schools to provide this service. We are waiting for a contact person to refer families to register for this care. VSB intends to have an online form or website for parents with more information.

Westcoast Child Care Resource Centre (WCCRC) has an online portal to our referral service for essential workers on our website here: https://forms.wstcoast.org/s3/childcare-needs. We are asking all parents living or working in Vancouver who are essential workers with children aged 0-12 register for a referral through our website. We will refer the parents to the appropriate resource for their families. We will also help families with access to the BC Affordable Child Care Benefit to help pay for child care.

The Ministry of Education has been working closely with school districts and independent schools to identify and support children, aged five to 12 years (kindergarten to Grade 6), whose parents are essential service workers, with a focus on public health and health services, social services, law enforcement, first responders and emergency response sectors. School districts and independent school authorities have been asked to ensure students whose parents work in these fields have access to care during regular before-, during- and after-school hours.

Hours of care will vary by school district and independent school. If essential service workers who have school-aged children need before-, during- and after-hours care for their children, they are asked to contact their school district directly. Most school districts have already reached out directly to families through surveys to gather information on urgent child care needs.

Note: in Vancouver don't contact the school district, but go through the WCCRC portal at www.wstcoast.org
