***Whether we should provide bullets for the MLA depends on where the emphasis is placed on the issues outlined below.***

***Just this morning we received complaints from child care operators about the processing timelines in the Criminal Records Review Program which is administer by PSSG. As you can see from the link, their processing time is 2-3 weeks, which is creating issues for child care employers. For this issue, we should direct the MLA to PSSG for bullets.***

***For all other child care related issues MCFD could probably draft some bullets, although the incoming is a bit vague (and Anne may recognize the name below,<sup>s.22</sup>***

***Can you share this note with CM as well, as I'm certain the MO is going to hear complaints about the CRC check delays sooner rather than later (and MO staff may want to check-in with their counterparts).***

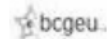
