

A new CYSN delivery model will soon be announced publicly Key information for you to know today: 1 Providing more services and better meeting the needs of CYSN children/youth & families 3 Implementation will begin in two Service Delivery Areas - the Okanagan and the Northwest - in early 2023 2 Eligibility based on needs - no diagnosis required 4 Individualized Autism Funding will stop taking new intakes in September 2024 and the program will sunset in 2025

- In the weeks ahead, the ministry will be announcing the first step towards a new model
 of service and support for children and youth with support needs, and their families
 across the province.
- Rooted in the voices, expertise and experiences of Indigenous and non-Indigenous
 parents, care providers, advocates and self-advocates, service providers and health care
 professionals, this new community-based service delivery model is about us doing
 better for the children, youth and families we serve.
- In the new model, there will be a network of family connections hubs across the province. Families will go to these hubs to access goal focused services and supports such as OT, PT, etc.
- children and youth won't have to wait for a diagnosis to receive services.
- Eligibility will be based on needs, which removes barriers to services in our current diagnosis-based model including those with FASD, Down Syndrome, brain injury and other support needs.

- Families often are forced to wait for intervention services while they wait to get a diagnosis, the new system will be more flexible and responsive by focusing on needs based rather than diagnosis
- In the current system some families struggle to find services with the funding they
 receive, maintain consistent services and some communities do not have
 adequate services. Creating family connections hubs will open up more services
 for more families
- We have learned over time that autism is a spectrum, and each child/youth has unique needs and require different and varying levels of support to reach their potential
- We know shifting our existing system is going to be complex, it's going to take time and there are going to be bumps in the road. We are deeply conscious of maintaining as much stability as possible for the many families we serve.

Opening the doors for more children and youth with support needs

- Every child deserves a good start.
- The right services at the right time.
- No long waits for a diagnosis to receive services.
- Consistent core services across the province.




Why change the CYSN Service Delivery Model?

- We know that our current programs and services are out of alignment with the needs of the families we serve. Eligibility criteria for supports and services favors some more than others – and working within a system that reinforces inequities is trying.
- Social workers and our contracted community partners go to great lengths to be creative
 and navigate a piecemeal system of supports to do what they can for the families they
 service.
- It is time for us to change this system to make it work for families to be simpler, more equitable, and more effective.
- The COVID-19 public health emergency shone a light on the cracks in our system what is not working and what needs to changed.
- The new family connections hub model is rooted in the voices and experiences of families and service providers

across the province – and will provide a one-stop centre for supports, services, therapies, and information for families of children and youth with support needs in communities throughout B.C.

 The services supports and expertise of MCFD and DAA front-line workers and provincial office staff remain central to this new model. Your hands-on skill and expertise is, and will continue to be, critical to supporting children and youth with support needs, and their families.



- Over the past two years, the ministry has been engaging and partnering with Indigenous and non-Indigenous parents, caregivers, service providers, health care professionals and organizations, and self-advocates about how we can do better for children and youth with support needs, and their families.
 - This includes outreach and consultation with over 1,500 Indigenous and non-Indigenous families, advocates, self-advocates, service providers, health care professionals and others, across B.C
- While there is still much to learn and more to do as we work to thoughtfully and
 carefully implement a new CYSN service delivery model-that is rooted in the voices and
 experiences of children and youth with support needs, and their families, we have been
 able to take a few small steps down this path.



What we've heard

- Our existing diagnosis-based system excludes children who have significant functional needs impacting their day to day lives.
- The current system of services requires children/youth & families to navigate.
- The current system is complex and can be difficult for families to navigate
- Families of children with complex needs, including those with Autism Spectrum Disorder, can feel overwhelmed.
- Historical and experiential trauma may prevent Indigenous families from approaching the ministry for help.
- Covid has amplified the significant challenges families face with the current CYSN System in meeting the needs of their children and youth.
- We've known for many years that B.C.'s current Children and Youth with Support Needs (CYSN) system hasn't been working as well as it should, and that some children and youth with support needs – for example those with FASD, Down Syndrome or brain injury – aren't able to access the kinds of services and supports they need to help them reach their goals.
- Over the past two years, the ministry has been engaging and partnering about how we can do better for children and youth with support needs, and their families.
 - This includes outreach and consultation with over 1,500 Indigenous and non-Indigenous families, advocates, self-advocates, service providers, health care professionals and others, across B.C
 - We've held focus groups with 200 Indigenous families, leaders and service providers; and
 - Established the Minister's Advisory Council; members include an Indigenous Elder, parents, a youth representative and representatives from a variety of CYSN umbrella organizations.
- We have heard from parents, caregivers and professionals that our existing system is
 fractured and difficult to navigate. The piece-meal system of services requires families
 navigate private and public system and take on role as case manager, advocate, and

parent.

- · Too many children, and their families, have had to scramble to piece together the kinds of individualized supports they require to achieve their potential.
- We know rural and remote communities often cannot access service.
- And, we know that Indigenous families have experienced racism and trauma that prevent them from making use of ministry services
- While there is still much to learn and more to do as we work to thoughtfully and carefully implement a new CYSN service delivery model that is rooted in the voices and experiences of children and youth with support needs, and their families, we have been able to take a few small steps down this path.

Specialized Homes & Support Services

The CYSN transformation is linked in many ways to the work already underway to

- transform our specialized homes and support services across BC.
- · Pathway to Hope
- Early Years

By addressing these pieces of work together, in a coordinated way, we will break down silos, acknowledging that children, youth and families need our services to operate as an integrated network.

MCFD is taking action to address urgent and long-standing systemic challenges within the CYSN and contracted residential care systems by building and prototyping a network of integrated services and supports. These changes are intended to transform the current system and support improved outcomes for the children, youth and families we serve.

The proposed changes represent overlapping and mutually supporting pieces of the BC's child welfare system and are closely tied to the contracted sector. The success of these initiatives relies on robust engagement and change management with overlapping groups of children, youth, families, ministry staff, DAA staff and external partners (particularly within the contracted sector). Due to differing origins and timeframes these projects are unfolding at different speeds and on different timelines - however the success of both is dependant on

the success of the other. Engagement for these two initiatives is currently planned to proceed separately, more information on SHSS visit $\underline{iConnect}$ or $\underline{govTogetherBC}$.


VISION

MCFD's goal is that children, youth, and their families in every part of B.C. will have access to culturally safe, gender inclusive, nondiscriminatory, and traumainformed support services that help them meet their social and developmental goals.



The vision is for children, youth, and their families in every part of B.C. to have access to culturally safe, gender inclusive, non-discriminatory, and trauma-informed support services that help them meet their social and developmental goals.

In order to achieve this, we are responding to what we've heard and what we know as a ministry and embarking on a transformative change. This includes some important strategic shifts, which form the foundation the CYSN transformation process and are key enablers of future state success.



- Partnered delivery: CYSN services are accessible to all BC families through a family connections hub model. Services are provided by contracted family connections hub staff and where required, subcontractors
- 2) Assessments and Functional Needs: Need is determined through intake, screening, and where required, discipline specific clinical assessments
- **3) Tool Standardization**: Standardized provincial tools drive **consistency** across BC in terms of eligibility as well as service delivery.
- 4) Integrated Service Plan: Each child will have an integrated My Support Plan across CYSN Goal Focused Services and Disability Services to enable coordinated service delivery.
- **5) One Primary support coordinator**: One primary support coordinator coordinates with all providers in the child's network of care.
- 6) Service Integration: The program design integrates services of all the core and enabling services offered through CYSN: Disability Services, Goal-Focused Services through the family connections hubs, and Provincial Services.

- In the new model, MCFD will directly work with families and coordinate both disability services for children and youth with more complex needs including service management, respite and in-home supports, parenting and professional supports and transition planning -- and provincial services, including information services, medical equipment and supplies, and provincial contracted services including the Provincial Deaf and Hard of Hearing program, the Community Brain Injury Program, and Provincial Outreach and Medical Supports.
- The family connections hubs will provide families a single access point for developmental services – this includes needs-based screening, developmental monitoring, information, education and guidance – as well as goal-focused services such as family support, service planning or behaviour supports, intervention services and therapies which may include occupational, physical or speech/language.
- It is at the family connections hub that a family receiving goal-focused services would be assigned a Primary Support Coordinator - a primary professional – a point person who would coordinate all services with the family. This is considerably different from our current state where families are not provided this coordination and support unless they are deemed eligible for a CYSN social worker

- For CYSN social workers and teams, the new model at a high level -- will mean a continued relationship with the more complex families with whom you work most closely, or those transitioning to adult services, along with a shift of some families to the goalfocused therapies – which may include speech/language, occupational and physical therapies, and behavioural consultation and intervention -- and supports available through the family connections hubs.
- · We want to reassure you that changes are not happening over night, but rather over a period of years to help ensure a seamless transition to the new model for children, youth and families.

How will family connections hubs benefit children, youth and their families? 1 Easy to access services based on each child and youth's functional needs. 2 Programs and supports will promote social inclusion overall quality of life. 3 Access to services that are culturally safe and trauma-informed and reflect the needs of their children/youth, families and communities. 4 Services and programs will be consistent with government's commitment to anti-racism and reconciliation with Indigenous peoples. 5 children/youth & families can expect consistent core services and quality of services across communities.

- Despite the best efforts of staff and front-line workers, our current system by its very design -- has challenges in meeting the needs of those children and youth, and their families. And that's not okay.
- Once available across the province, the new family connections hubs will be available to people in all regions of the province.
- The services will be easy to access and based on each child and youth's functional needs, programs and supports will challenge the stigma against disabled and neurodiverse people by focusing on the strengths and goals.
- The new model moves away from our diagnosis-based system where children can sometimes wait over a year before being eligible for funding or services -- to one which is child, youth and family-centred, needs-based, and responsive.
- Diagnosis may still provide important and more in-depth information for families and therapists but not having one won't prevent a child, youth or family from receiving services.
- That means important services such as speech/language, occupational and physical

therapies, behaviour consultation and family support can be put in place following a needs-based assessment, and a child and family's goals can be defined earlier and achieved more quickly.


- · Families will be able to have services and supports coordinated by professionals, offering a much-needed opportunity for family members to step away from the role of case worker.
- In addition, children, youth and families will have access to services that are culturally safe and trauma-informed and reflect their individual needs.
- · The services and programs will be consistent with government's commitment to antiracism and reconciliation with Indigenous peoples.

Early Implementation Areas

- Moving toward a new way of delivering services to children/youth & families with support needs
- Early implementation areas will be operational in the Okanagan and Northwest Service Delivery Areas by 2023
- Service Providers in the early implementation areas will have the opportunity to begin engaging in the RFP process in 2022.
- Provincial Autism funding program will remain operational across the province during the early implementation areas and up to fall
- The Autism Funding program will stop taking new intakes as of September 2024 and the program will sunset in March 2025. This is to allow children/youth & families time and choice to transition.
- Over the next few years, the ministry is moving toward a new way of delivering services to families of kids with support needs, including autism, starting with two early implementation areas – in the Okanagan and the Northwest service delivery areas.
- The first two early implementation areas will be up and running in 2023.
- Until that time, nothing will change for families.

• Early Implementation areas allow us to learn from the first-hand experiences of families, staff and service providers, and adjust prior to the model being rolled out in other communities across the province.


• Family connections hubs will be in place across B.C. by early fall 2024. New applications for the Autism Funding Program will no longer be accepted in September 2024 with the Autism Funding Program sunsetting in spring 2025. Until that time, parents will have the option of continuing to receive individualized funding through the Autism Funding program – or choose to make the transition to a local family connections hub.

- Is there a specific dollar amount attached to each child who applies for funding?
- If fundings for autistic children was \$22,000 before will they have access to the same level of funding?
- What will the criteria be for applying for this funding? I know there doesn't need to be a referral or diagnosis now but I'm guessing not everyone who applies will be granted funds.
- How many children had been accessing funding before this? I see that a further 8,300 will be able to access so I'm just curious what totals will look like.
- Will this put a strain on families who have been getting funding for autism? As in, will they be able to access as many resources and support as they once did? Or are all the resources now being spread out over a wider group of people? The Minister got this question yesterday but the answer was unclear.
- Will anyone who previously qualified now not qualify? If there's any chance I can get answers (or even some of them) by 5pm today that would be so helpful I'm off tomorrow and Monday. If that's not possible please let me know so I can get another reporter assigned to the file. Thanks!

Recommendation

To clarify, we are moving away from an individualized funding system to one that is accessible, easier to navigate and will support more children, youth and their families. We are bringing services together in family connections hubs to help families get services more quickly and ensure more children and youth benefit from the therapies and supports they need as early as possible.

We've seen that many families of children with autism who are receiving individualized funding can't always access the services they rely on — and this was especially challenging during the pandemic. While they are receiving money, some can't spend it where and when they need it. The new system is designed to address these challenges. Families of children with autism can continue to receive individualized funding from government until 2025. As the family connections hubs open their doors throughout the province, the Ministry of Children and Family Development and hub operators will work with families to transition, over a six-month period, from individualized funding to services and supports through the family connections hubs.

Families of children and youth with disabilities or other support needs, or families that suspect their child may need extra support, will be able to go to a family connections hub to access services, either with or without a referral and without the need for a diagnosis, making it much easier to get the help they need in their local community. The new system will also serve children and youth with a much broader range of needs, for example children and youth with Fetal Alcohol Spectrum Disorder and brain injury, as well as children and youth with Autism Spectrum Disorder. Supports will be determined based on the needs of the child and youth, as well as information from the family. Families, parents, and caregivers will play a central role in setting service goals for their children.

Approximately 30,000 children and youth with support needs are eligible for services offered through the Ministry of Children and Family Development and its contracted service providers. The new system will provide help to approximately 8,300 additional children and their families.

Aside from autism, services are not diagnosis-specific so a breakdown of these categories (FASD/Down syndrome/ brain injured) is not available. Children and youth with severe disabilities may be eligible for the At Home Program (AHP) which assists parents with some of the extraordinary costs of caring for a child with severe disabilities at home through a range of health supports and services. Children and youth who are eligible for

AHP Medical Benefits can access the School Age Extended Therapy (SAET) benefit, which provides occupational therapy and physiotherapy services as well as speech-language pathology, chiropractic and massage services to school-aged children. With SAET, the billing rate caps of \$80/hr, where therapists bill \$120-\$160/hr for these services and families are put in the position of paying the difference to access the therapies.
