Hi Rob and thanks again for your help with the PHO order for child and youth with special needs services.

I am now trying to sort out how the order relates to child development centres. These provide health services to children and youth with special needs e.g. Occupational Therapy, Physiotherapy, Speech Language Therapy, plus other services.

As I understand, some child development centres are funded by health funding, and some are funded by MCFD funding. If funded by health, the health funded employees would be covered by the order, and MCFD funded would not covered.

Can you explain how these are funded, whether health services provided in these centres are all funded by health, or are some health services funded by MCFD?
