Truthfully, I'm not sure about how its alignment to Autism. However, I can see the linkage to Autism Information Services BC. This was previously a contracted service. After a procurement process that did not produce the responses needed, the Ministry made the decision to bring these services (information, outreach, and training) in house and manage the service as a provincial service.

Also in the new CYSN approach, we are looking to broaden the focus of Information Services as well as exploring the key services that may be more specific and specialized in nature that will be needed to support the provincial network of FCHs. These would be provincial held contracted services.

ISSUE: Sharing the CYSN Funding Model with Sector Stakeholders

SUMMARY:

The Procurement Strategy team intends to share high level information about the funding model approach for the CYSN transformation with the Social Services Sector Roundtable, Sub-Committee on Procurement Strategy (SSSRTSC)

BACKGROUND:

The Procurement Strategy (PS) project is a transformation initiative run out of the Corporate Operations Support Branch of the Finance and Corporate Services Division of MCFD. The PS project is responsible for an integrated set of deliverables that, together, transform the way MCFD procures and administers contracted service delivery. The PS is partnered with the CYSN transformation as an enabler of the CYSN program's improvements. The PS team led the development of the CYSN funding model—a framework for determining how service providers will charge for their services in the new program model.

The SSSRTSC is a group of stakeholders who represent organizations from across the sector with interests in the transformation of procurement. The terms of reference, including a member list, is included in Appendix A. This table was created to provide a forum for senior executives and social services sector representatives to maintain good relations through ongoing communications, discuss matters of importance with relation to the Procurement Strategy, and address any issues in a coordinated and collaborative way.

The intended cadence was to host this group every other month. However, only two meetings have been held: in February and in April this year. After that, the content of proposed agendas was deemed to be confidential or that it would lead to sensitive inferences made by the group.


