2. In April 2012, the Ministry introduced the Child Protection Response Model and replaced the BC Risk Assessment Model, which had been in place in since 1996/97. Under the new child protection model, some forms of family support services are now provided as part of the response to a child protection incident and are directly recorded on the incident in ICM rather than on the Family Service file as had been done previously in MIS/SWS.

[^]The increase in the number of Open Protection Reports in 2012/2013 results primarily from (1) Incidents coded as Family Development Response being able to remain open for a maximum of four months if the family is receiving protection services under the new Child Protection Response Model introduced in April 2012; (2) Ministry After Hours offices now recording intake calls in ICM whereas previously these calls were recorded in the After Hours computer system and not counted as open protection reports in MIS/SWS
