ISSUE(S): The Centre of Israel and Jewish Affairs (CIJA) Canada contacted the office of the Honourable Minister, Grace Lore, to discuss children and youth with support needs, the work done by their community partners who support them, and how we can work together to improve the system for all.

BACKGROUND:

CIJA is a Jewish advocacy organization. CIJA is an agency of the Jewish Federation of Canada located in Ontario, Canada. The Jewish Federation of Canada has ten Federated Jewish Communities and four regional council partners across Canada. There are two Federated Jewish Communities in BC located in Victoria and Vancouver. Each Federation assumes responsibility for local community planning, financial resource development, and allocations which support a network of social service agencies, schools, and community centres.

CIJA represents the Jewish Federations across Canada. CIJA designs and implements strategies to ensure leaders in government, media, civil society, business, and academia understand the Jewish perspective and that it is considered in Canada's public policy discussion.

The Jewish Federation of Greater Vancouver is located within the Jewish Community Centre (JCC) in Vancouver. The role of the Jewish Federation of Greater Vancouver is to fundraise to provide support services to their members through the JCC and other Jewish organizations. The JCC provides a range of family services that include early childhood support for children and parents, out of school care, and physical activities.

DISCUSSION:

The Ministry of Children and Family Development (MCFD) in Vancouver does not have a direct working relationship with CIJA, the Jewish Federation of Greater Vancouver, or the JCC. We do not contract with them directly for services. Families with a Jewish background receiving MCFD's mandated services also access supports through the JCC. There may be more families of Jewish background accessing MCFD's voluntary services through Child and Youth with Support Needs, that are connected to the JCC for supports, of which we are not aware.

The JCC has a good reputation in the community among Jewish and non-Jewish service recipients. The JCC is inclusive to all backgrounds regarding most of its community services.

Recently we have seen a \$25 million investment for the Jewish Community Centre redevelopment project, the announced rollout of the racist incident helpline and the inclusion of mandatory Holocaust education in the provincial K-12 curriculum. We thank you for your partnership and hope to continue our collaborative relationship with all parties represented at the BC Legislature.

Discussion Topics for Meeting with Minister Grace Lore, CIJA, and JFS

Wednesday April 10, 2024

re: Jewish Community Priorities Guide and Emerging Issues

Introduction

- B.C.'s Jewish community is comprised of approximately 40,000 people, with its largest communities in Metro Vancouver and the Capital Regional District.
 - Victoria is one of the fastest growing Jewish communities in the country.
- The community has 38 distinct organizations that serve its childcare, education, housing, programming, cultural, food dignity, spiritual, and other needs. However, these services are open to the wider public.
- According to the previous census, the poverty rate in the community is 18.2% which was consistent with the provincial poverty rate at the time.
- Our community organizations are seeing an increase in demand for services while operating in a more challenging fiscal environment.
- Consistent with the wider non-profit sector, 75% of employees in our community organizations identify as women.

Discussion Topics

Economic Challenges for Families

- While affordability is a concern for many British Columbians, the challenges are often acute for families with children and youth with support needs.
- Measures to ease economic barriers such as support for appropriate childcare services and raising income and disability assistance may provide some relief.

Cultural Appropriateness

- Families with children and youth with support needs in the Jewish community may face barriers to participating in community life and require additional resources to meaningfully include their children.
- In March, MCFD opened two calls for response for CYSN Agency Respite Services and Parenting and Family Supports. These two measures would provide relief to both service providers and families.
- Widening access to support through more readily available assessment services may alleviate barriers for families.

Antisemitism

- After October 7, the Jewish community in B.C. faced a rapid increase in antisemitism but had broad government support. However, the recent weeks and months have been challenging for the relationship between the community and government.
- The most vulnerable in the Jewish community rely on a strong relationship between its service providers and the B.C. government.

- A provincial government plan to address antisemitism in K-12, post-secondary institutions, and the BC Public Services would enhance the work between the government and our partner agencies.

Recommendations

- Provide resources to meaningfully include children and youth with support needs in childcare and increase financial support to families.
- Ensure that respite opportunities are inclusive of the experiences of racialized and ethnocultural communities.
- Increase resources so families can access timely assessments for their children.

Next Steps

- MCFD is currently in a period of deep consultation for its redesign of its system of support for children and youth with support needs, and our network of partner agencies want to provide their experiences. Can MCFD advise how we can meaningfully engage in these consultations?
- There are other service providers and institutions in the community who interface with children and youth with support needs who may want to contribute to this conversation. We may want to consider a roundtable or more in-depth conversation.
- Can MCFD provide us with any advice on any possible applications for their March calls for response on CYSN Agency Coordinate Respite Services and CYSN Parenting and Family Supports?

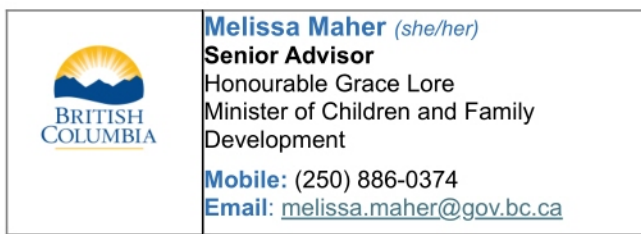
