 - There have been ongoing complaints from a resident of Vancouver regarding vehicles (e.g. motorhome) that sometimes park in the UEL across from s.22 with potentially persons sleeping in the vehicle at night. The border between UEL and Vancouver is the middle of Blanca St. It does not appear that any UEL residents have complained.
 - That part of the UEL is within Area C, which is single family residential; there is no requirement for a permit to
 park on the UEL side of Blanca as such permits are not required anywhere in Area C. To the extent that UEL does
 have parking permits in single family residential areas, they are in Areas A and B (which are the areas adjacent
 to UBC, to alleviate the high volume problem of students taking up all on-street parking spaces from UEL
 residents).
 - As such, the only provision of the UEL bylaw that comes into play with this complaint is the prohibition on any person parking a boat, trailer, motor-home or vehicles over 10,000 lbs on any street within the UEL between 10:00 p.m. and 6:00 a.m. s.13
 - In past responses to the Vancouver resident, UEL staff have on occasion been able to call the RCMP to "rattle
 the doors" of the motor home, but as there are no safety concerns from the RCMP's perspective, this is not
 something on which they willingly expend such resources. As well, time was put into tracking down owner's
 information and letters sent, with no response.
 - The UEL's parking bylaw enforcement capacity consists of one contracted attendant. Given those limited resources, the focus of UEL's parking enforcement is on the parking meters in the commercial "village" in Area D with the main interest there being encouraging turn over so that customers continue to frequent the shops and the businesses survive. Ensuring turn over is important when there are complaints from Area A and B residents regarding people parking without permits. Ensuring that UEL residents are not interfered with in going about their business is a key interest. Even with focusing limited resources, however, there are a number of parking issues just in Area D and the permit areas that remain outstanding.
 - If additional action were to be taken in response to the most recent complaint from the Vancouver resident (and the UEL were prepared to take possible risk of legal challenge to its bylaw provision), it would involve at least the following steps (with accompanying costs ultimately paid for by UEL residents):

- sending a staff person or the contracted attendant out at night to observe if in fact the motor home is parked during the prohibited hours
- o having a specialized tow truck dispatched (capable of hauling a motor home) if there is any chance that there is a person inside the motor home, the tow truck driver cannot haul the vehicle
- o if there was any effort to dislodge the person inside the motor home, the staff person/contracted attendant/tow truck driver would face a safety risk (i.e. irate person creating a confrontation) and it is not clear under what authority they would take such action
- If there were interest in taking a more system-wide approach to UEL parking enforcement (e.g. changing the bylaw in some way), the resulting enforcement costs to make that effective would likely be at least \$100,000 (for additional contracted enforcement attendant resources). Providing the UEL with ticketing authority would require some relatively complex legislative change (and would require even further enforcement resources at additional costs). Jonn, if I have misinterpreted or left anything out, please add in your thoughts when you come up for air. I'm heading out this afternoon to LGLA, and Jonn is "head down" putting together s.13

- s.13 plus other pressing issues (and I know that you are busy with Minister's briefings) -- so I was hoping that beginning of next week would be soon enough to regroup on this issue if needed. Cheers Nicola
 - There have been ongoing complaints from a resident of Vancouver regarding vehicles (e.g. motorhome) that sometimes park in the UEL across from s.22 with potentially persons sleeping in the vehicle at night. The border between UEL and Vancouver is the middle of Blanca St. It does not appear that any UEL residents have complained.
 - That part of the UEL is within Area C, which is single family residential; there is no requirement for a permit to
 park on the UEL side of Blanca as such permits are not required anywhere in Area C. To the extent that UEL does
 have parking permits in single family residential areas, they are in Areas A and B (which are the areas adjacent
 to UBC, to alleviate the high volume problem of students taking up all on-street parking spaces from UEL
 residents).
 - As such, the only provision of the UEL bylaw that comes into play with this complaint is the prohibition on any
 person parking a boat, trailer, motor-home or vehicles over 10,000 lbs on any street within the UEL between
 10:00 p.m. and 6:00 a.m. s.13
 - In past responses to the Vancouver resident, UEL staff have on occasion been able to call the RCMP to "rattle
 the doors" of the motor home, but as there are no safety concerns from the RCMP's perspective, this is not
 something on which they willingly expend such resources. As well, time was put into tracking down owner's
 information and letters sent, with no response.
 - The UEL's parking bylaw enforcement capacity consists of one contracted attendant. Given those limited resources, the focus of UEL's parking enforcement is on the parking meters in the commercial "village" in Area D with the main interest there being encouraging turn over so that customers continue to frequent the shops and the businesses survive. Ensuring turn over is important when there are complaints from Area A and B residents regarding people parking without permits. Ensuring that UEL residents are not interfered with in going about their business is a key interest. Even with focusing limited resources, however, there are a number of parking issues just in Area D and the permit areas that remain outstanding.
 - If additional action were to be taken in response to the most recent complaint from the Vancouver resident (and the UEL were prepared to take possible risk of legal challenge to its bylaw provision), it would involve at least the following steps (with accompanying costs ultimately paid for by UEL residents):

- o sending a staff person or the contracted attendant out at night to observe if in fact the motor home is parked during the prohibited hours
- o having a specialized tow truck dispatched (capable of hauling a motor home) if there is any chance that there is a person inside the motor home, the tow truck driver cannot haul the vehicle
- o if there was any effort to dislodge the person inside the motor home, the staff person/contracted attendant/tow truck driver would face a safety risk (i.e. irate person creating a confrontation) and it is not clear under what authority they would take such action
- If there were interest in taking a more system-wide approach to UEL parking enforcement (e.g. changing the bylaw in some way), the resulting enforcement costs to make that effective would likely be at least \$100,000 (for additional contracted enforcement attendant resources). Providing the UEL with ticketing authority would require some relatively complex legislative change (and would require even further enforcement resources at additional costs). As well, given the other pressing priorities facing the UEL e.g. s.13

I appreciate your offer of assistance. The UEL focuses parking enforcement on the needs of UEL residents in the areas most affected by a high volume of parking-related matters which may affect public safety or other neighbourhood needs -- for example, in Areas A and B close to UBC, ensuring access for emergency and other service vehicles and that driveways are not blocked by non-resident parking; in the Area D commercial "village", ensuring sufficient turn over for parking outside local businesses and that there is sufficient parking available to those residents whose buildings do not have onsite parking.

In other areas of the UEL, parking situations are monitored and action taken appropriate to the scale of the situation. At this time we do not have and cannot justify 24/7 parking enforcement. While I appreciate the level of enforcement on Blanca does not meet the needs of at least one resident of Vancouver, I am satisfied it is protective of public safety. We have taken active steps to reduce the number of such vehicles along that street and, on occasion where staff have been called-out late at night in the area for other reasons, they have knocked on the doors to see whether anybody is staying in the vehicles (no response). I will continue to monitor the parking situation on the UEL side of Blanca Street and take action as appropriate, consistent with the UEL's role, enforcement tools and the many and varied work priorities for the community.
