Background:

The issues of homelessness keep councillors, staff, police and social agencies very busy and expenditures on managing the issues are well documented. Providing grants to support the development of supportive and affordable rental housing aligns with and supports Council's strategic priority of Making Victoria More Affordable (Objective 6). Support for the rent supplement to provide housing also aligns with Council's strategic priority to Facilitate Social Inclusion and Community Wellness (Objective 7).

The Streets to Homes (S2H) program is based on the "Housing First with Supports" model, which aims to move people directly from homelessness to permanent market housing and provide customized supports to help them stay housed. The program secures housing, integrates services, and improves coordination to effectively delivers services to people with mental health and substance use issues who are experiencing homelessness. The S2H was originally piloted as a collaborative effort on the part of the Greater Victoria Coalition to End Homelessness and eight partner organizations. As of Jan 1, 2012, the pilot was proved successful and the program was officially transferred to the Pacifica Housing Society.

Recommendation:

Whereas, Pacifica Housing is reaching out to community partners to leverage funding to move an additional 40 chronic and episodically homeless adults into stable market housing by the latest, summer of 2016,

And whereas, Pacifica Housing has reached out to other funders to successfully leverage the total amount to reach this goal,

And whereas, the City of Victoria's Strategic Objectives Account currently has approximately \$110,000.

Therefore, that Council support this initiative by providing \$75,000 from the Strategic Objectives Account to *Pacifica Housing to help move homeless adults into stable housing*, conditional on other partners coming on board *with additional funding*.

STREETS TO HOMES PROGRAM

For more than 30 years, Pacifica Housing has been a leading provider of supported, subsidized, market and near market housing options in Greater Victoria, Duncan, and Nanaimo. Pacifica Housing has acquired, built, and/or renovated a total of 842 units, and currently houses more than 1500 people annually. In addition to housing, Pacifica Housing provides support services, youth groups, community gardens and community meals to address additional needs of education, and food security that assist in building capacity and strong community connections.

The Greater Victoria Streets To Homes Program (S2H) addresses homelessness by employing a 'Housing First' model that provides integrated, client-centered support by combining low barrier housing with financial and individualized support services.

Every year The Greater Victoria Streets to Homes (S2H) Program moves 120 homeless adults directly into permanent market housing while providing customized support to help them stay there. The program secures housing, and integrates support services to effectively deliver services to people with mental health, substance use issues, generational poverty, brain injury, and other significant health concerns who are experiencing homelessness. By tailoring the supports to the unique needs of each client, the vast majority of clients are successful in maintaining long term housing. The stabilizing effect of housing reduces a client's use of law-enforcement and emergency medical services.

The Greater Victoria Streets To Homes Program uses an integrated and immediate approach to addressing the homelessness crisis in our region. Through the use of private market landlords, rental supplements, individualized case management and integration with community resources, S2H works to set up a framework of support services that lead to independence. Since 2009, Streets to Homes has housed 179 people with a high-level of success. 82% of the people S2H is currently supporting have been successfully housed for more than a year, while 63% percent of all people housed through Streets to Homes prior to 2013 continue to retain stable housing with S2H today. 46% of the people who have left S2H, have obtained social and financial independence, and 33% have moved into a higher level of service and housing support. S2H currently works with 58 landlords (16 of whom are property management companies) providing 86 buildings in which program participants are housed.

High housing retention rates combined with almost half of the clients exiting S2H moving on to social and financial independence directly supports Pacifica Housing's mandate "to be a leading innovative provider of affordable homes and support services that contribute to the independence of individuals and families".

The need for a range of housing and support services for people experiencing homelessness has been clearly laid out in The Mayor's Task Force on Breaking the Cycle of Mental Illness, Addictions and Homelessness (2007) and supporting studies and surveys from 2005 - 2014. These studies include the

Homelessness Count/Needs Surveys (Victoria Cool Aid Society) and reports from Greater Victoria Coalition to End Homelessness (GVCEH) and Centre for Addictions Research of British Columbia (2012). The above research found that 1,617 individuals utilized a shelter bed during the reporting period indicating a need for additional housing options and support services. The 'Evidence-based Best Practices' section of the Mayor's Task Force Report leads off with the following three points, which are fundamental to S2H:

- Integrated, client-centered support services for the homeless, addicted and mentally ill population not only work better, they cost less than our current uncoordinated and fragmented service delivery system.
- Low barrier housing with supports is the key to addressing the public disorder resulting from homelessness, mental illness and addiction.
- Support services for the homeless must be connected with housing for either to work effectively.

Our goal for this program is to move adults directly from homelessness into long-term, private market housing while offering customized support services so that they are successful in maintaining stable housing. The program provides experienced staff for one-to-one customized ongoing support to secure housing, support and training to assist with navigating complex social systems and self advocacy in order to meet personal needs. S2H staffs are involved in intensive case planning, community referrals and direct support services to address mental and physical health as well as substance use issues. The program also assists clients in accessing new and/or increased government benefits, acquiring financial literacy through budgeting and employability skills, and finding meaningful ways to strengthen social inclusion. Finally, S2H develops mutually beneficial relationships with landlords and provides education to the broader community to address stigma and attitudes that reinforce disenfranchisement of the target population.

S2H is committed to being part of the solution to end homelessness and not merely "manage" it. For a percentage of our clients the sustained impact means moving into social and financial independence. For clients who are unable to achieve complete financial and social independence and require some level of ongoing services case management plans include connecting clients with existing permanent programming. Clients dealing with profound and persistent mental health issues, brain injury or other severe conditions that require ongoing comprehensive supports will continue to be referred to applicable resources such as permanent supported housing, Assertive Community Treatment (ACT) teams and comprehensive mental health facilities. When considering 'sustained impact' it is important to keep in mind the process in which the transition from homelessness to stable housing encompasses. Initial client-centered contact with the most vulnerable populations is often the first step, of many complex steps, on a journey of healing.

Dear Mayor and Council,

I am writing to you on behalf of Pacifica Housings' Greater Victoria Streets to Homes Program and the adults in our community experiencing episodic and chronic homeless.

As an Agency whose priority is housing, our responsibility lies in collaborating with our community partners to end the homelessness crisis in The Capital Region. We are reaching out to community partners to leverage funding to move an additional 40 chronic and episodically homeless adults into stable market housing by the summer of 2016.

The Victoria Foundation is actively considering a request from Pacifica Housing for \$70,000 that will result in an additional ten people in Greater Victoria being housed through S2H. Integral to the Victoria Foundation's decision to award S2H funding, is the ability to leverage other partners and increase the impact their contribution will have on the community.

We have under active consideration matching funding from the CRD (\$75,000), along with our application to the Victoria Foundation, to contribute a combined total of \$145,000 for the supports that make Streets to Homes successful. In addition, BC Housing is currently reviewing a request towards rental supplements (\$75,000).

In order to successfully leverage the total amount to provide another 40 homeless adults with permanent housing, we need the City of Victoria to match BC Housing for \$75,000.

I am confident that with the support of the City of Victoria, The Victoria Foundation, CRD and BC Housing we can make a measurable difference in our community's initiative to end homelessness in the Capital Region by 2018.

Thank you for taking the time to consider our request. I have attached a brief budget reflecting the increase that would result in another 40 homeless adults moving to homes, as well as a general descriptor of the program and its successes.

Thank you for your email of October 22, 2015 to Mayor Lisa Helps. Mayor Lisa Helps redirected your email to Honourable Minister Virk for response. I have been asked to respond on behalf of Minister Virk regarding your request to extend the vacate date of 28 Bastion Square by two or three months.

As previously communicated to you by my staff, we anticipate that the relocation of artefacts and effects from 28 Bastion Square to the interim storage locations will be completed by the end of October.

In addition, the Royal BC Museum has provided consultation and professional advice to the Maritime Museum of BC's Board of Directors to assist them with cataloguing and inventorying their collection. It has also provided logistical support by providing advice on best practices for storage, packing and moving the collection, especially large objects.

Additional funding will not be forthcoming from the Province beyond the commitment for October, which brings the total interim funding contribution balance to \$100,000.

As you know I am back East on CCG business but am advised that the despite the very best efforts of Museum staff and your contractors too much work remains to be done in the Bastion Square Courthouses to achieve your "vacate date" of 23 Oct or even one of 30 Oct. I want to underline that the moving story thus far has been a positive one. Our core staff and volunteers have been working hard to meet the goal of clearing the collection out and your contractors have been professional and cooperative. We are however concerned about the stress being placed on our small core staff and volunteers by the process. There are several reasons why achieving the deadline will not be met including the fact that staff assistance promised by RBCM at the meeting of the ADMS MTICS and MCSCD with the Museum on 30 June did not come through. However we are now faced with the issues that much needs to be done to complete the inventory, pack and transfer the remainder of the collection. Please find attached the following documents pertaining to the transfer of the property at 28 Bastion Square (Provincial Law Courts Building) from the City of Victoria to the Province in 1977 as well as in regards to the future welfare of the Maritime Museum of British Columbia (MMBC).

I would particularly like to draw your attention to Clause C of the document dated February 11th and Clause 4 of the Agreement also dated February, 1977 by which the province "assumes the responsibility for the location of the maritime museum whether in the Courthouse building or in another situation."

For almost 40 years the MMBC has relied on this arrangement whereby the City of Victoria transferred the building to the Province of British Columbia for the sum of \$1 with the tacit understanding that the Province would maintain a sustainable home for the MMBC and its collection over time.

It would appear at this time that the Province is no longer following the intent of this agreement with the inevitable result that the very future of the MMBC as one of B.C.'s keynote cultural attraction is at stake.

I have forwarded these documents to your office for consideration considering the recent decisions in regards to the future of Provincial support for the MMBC, keeping in mind that these documents are in the public domain.

In conclusion, I would like to thank both yourself and your staff for the assistance provided by your Ministry to date, it has been very much appreciated.

- (b) The Province relinquishes its right to acquire the James Bay Firehall site.

New lease on life for Maritime Museum: under provincial control. Victoria Colonist - Jan 29, 1977, p 17:

After having been a political football for years, Victoria's Maritime Museum has been given a new and apparently permanent lease on life. The city of Victoria and the provincial government have reached an agreement which places the museum under provincial control. The agreement calls for transfer of the old courthouse building in Bastion Square, housing the Maritime Museum, from the city to the province for \$1. The agreement also states that the province would assume responsibility for the museum, whether in the courthouse or at another location. The agreement stipulates that the provincial government will pay the 15-mill tax levy, customary for provincial holdings.

The agreement, endorsed by city council and Provincial Secretary Grace McCarthy, lays to rest a contentious issue. For years, successive city councils have complained about an inordinate burden placed on the shoulders of Victoria property owners by the museum. The museum occupied the premises rent-free and tax-free; the city even threw in the maintenance cost. Total subsidies have been estimated at \$50,000 to \$60,000 a year.

Museum curator Capt. Keith Cameron said Friday the agreement was splendid. "Frankly, I was hoping something like this would materialize," he said. The city bought the old courthouse building from the province 14 years ago for \$110,000. Several years ago, when Peter Pollen was mayor of Victoria, city council ordered the museum to vacate and in the summer of 1975 the building was offered for sale. There were no takers, however, and the city subsequently took the building off the market. Since then, the Maritime Museum has occupied the building on a month-to-month basis.



At such time as the museum may move from the Building Her Majesty will within ____ months thereafter effect such repairs and alterations to the Building as will bring it in to conformity with the construction standards and fire safety requirements then applicable under the By-laws of the City governing building standards and fire prevention.
- 6. Her Majesty covenants and agrees that she will retain title to the said lands to the intent that the same will remain in public ownership. Her Majesty further covenants that upon any relocation of the museum taking place, if the building

is not occupied by Her Majesty for the purposes of the Crown Provincial any tenancy or lease thereof to any person or Corporation will be for a use permitted by the Zoning By-law of the City.

7. Notwithstanding the immunity conferred upon the Crown under the provisions of Section 44 of the laws Declaratory Act with respect to the use of Land or improvements Her Majesty agrees to be bound by the terms and provisions of this Agreement according to it tenor.
