I have been working with PSA to find information following your query on mileage re-imbursement. As suspected, you

cannot claim both mileage and a DM car allowance. As noted below, there may be opportunity to claim a percentage of care/maintenance/gas.

I have provided a link to the top-level information on automobile and motor vehicle allowances from the CRA website. You can drill down from there to find additional information. As noted in the material, it would be helpful if you keep a log and receipts related to your driving, including distance driven, from, to, purpose and repairs and maintenance.

Hi Philip, as far as I can see, and I have followed up with a few people about this as well, it appears that if Jill is getting DM Car Allowance, she is not entitled to mileage on top of that. The DM car allowance of \$6960 yearly is in lieu of leasing a vehicle. \$6960 divided by 12 months = \$580 as referred to in Schedule 6 below.

Jill maybe able to claim as expenses, when she files her personal taxes, a percentage of care/maintenance and gas – as it relates to using her vehicle for work. She would have to talk to her financial advisor on how to best do this. I would think she would have to track her work mileage and hold on to all receipts for gas/maintenance etc. I have been searching for a mileage tracker template, however I am not having much luck.

I have sent you documentation below from Core Policy Manual and from Directive 4.5 – Terms and Conditions for Excluded Employees and Appointees. I have also been in contact with agency staff that deal with posting info on MyHR. I will forward you whatever they are able to find as soon as I get it.

#### Where DM uses own car:

#### D.8 Payments of Deputy Minister Car Allowance

Each deputy minister (and associate deputy minister), who does not have an automobile provided by the Government, is entitled to an annual allowance of \$6,960 to defray the costs of using a personal vehicle for business purposes.

Canada Revenue Agency has determined that this allowance is taxable to the extent of that portion of the allowance that is not expended on business travel.

The full amount of the allowance must be included in the individual's taxable income and reported on the employee's T4 slip. The total amount is subject to payroll deductions of tax, CPP contributions and EI premiums.

When completing his or her individual income tax return, the employee can deduct the relevant expenses provided they are deductible under paragraph 8(1)(F) or 8(1)(H) of the Income Tax Act and the employee files Form T2200, Declaration of Conditions of Employment.

The individual is responsible for submitting any offsetting claim for business automobile travel by personal vehicle when submitting a tax return. The offsetting claim for business use when submitting a tax return must be supported by receipts and a daily log of kilometres travelled for business purposes.

The ministry chief financial officer is responsible for preparing a letter authorizing payment for each deputy minister (and associate deputy minister) receiving a car allowance. Each letter of authorization is to be submitted to the payroll office for processing prior to the first bi-weekly or monthly payment. The chief financial officer is required to notify the payroll office to end payment when the deputy minister (or associate deputy minister) ceases employment.

STOB 5220 - Taxable Benefits has been added to the CHIPS Account Code Table effective July 9, 2000. Deputy minister car allowance payments are to be coded to this STOB. Enter STOB 5220 in the account code field on the payline.

**Note**: The vehicle distance allowance does not apply when a deputy minister or associate deputy minister elects to receive a vehicle allowance.

Schedule 06 - Executive Vehicles

## Last updated April 12, 2016

1. Deputy minister and associate deputy minister leased vehicles

Deputy ministers and associate deputy ministers will be provided with a government leased vehicle as follows:

- 1. The maximum monthly lease payment exclusive of tax will not exceed \$625 per month.
- 2. The amount of the lease is not to be augmented by personal payment.
- 3. The insurance and operating costs of the leased vehicle will be paid by the province.
- 4. The lease will provide for buy out at fair market value (should either the province or the deputy minister or associate deputy minister wish to do so).
- 5. The maximum lease period will not exceed 48 months.
- 6. The deputy minister or associate deputy minister may elect to receive a vehicle allowance in lieu of taking a leased vehicle. The allowance is equivalent to the average lease and vehicle operating costs noted above, and is equal to \$580 per month.
- 7. Where the employee leaves the position of deputy minister or associate deputy minister:
- and foregoes the option of buying out the lease, the leased vehicle will be surrendered on the employee's last working day (inclusive of any paid leave not to exceed an amount equivalent to the current year's vacation balance); OR
- 2. the payment of the allowance in lieu of a vehicle will cease on the employee's last working day (inclusive of any paid leave not to exceed an amount equivalent to the current year's vacation balance).
