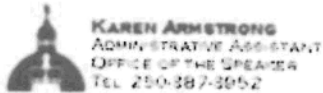

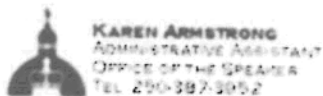

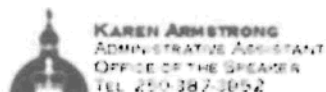

Stephanie Lamy is a French photographer who has been living and working in Vancouver since 2013. From March 15 to April 25, the Centre culturel francophone de Vancouver will present "Cargo", an exhibition of the photos she took during her crossing of the Atlantic from Le Havre to New York on a freighter.

Driven by her boundless curiosity, fascination for the sea and passion for travel and for human connections, this artist uses the medium of photography and her love of colours to recount the raw and gritty experience of her long, slow voyage between two worlds and two chapters of her life.

Stephanie Lamy about Cargo

I took this voyage on a cargo ship in October 2012, after receiving my permanent resident status in Canada. A photographer at heart and by vocation, I have always been drawn to the ocean and for a number of years I have been working in the nautical environment.

The idea for this trip developed over a number of years until it suddenly emerged as something I just had to do, with no more than a few weeks for last-minute preparations. An eternal traveller at heart, a devotee of nature and the great outdoors, and a fan of the raw and gritty industrial scene, I felt the calling of this symbolic crossing, a symbol of the voyage in its simplest, most archetypal form, a timeless myth.

Travelling on a cargo ship is a total adventure, an opportunity for introspection and above all a hiatus in a world where life streams past in a constant and frenetic sequence. I allowed myself to enter into this hiatus and for me, this voyage took on the meaning of a perfect transition between two lives. The outcome was that for nine days, I disappeared completely from the connected world to cross the Atlantic, sailing from Le Havre to New York, and in this process, I discovered myself anew, and reconnected with who I am.

This new life in Canada, where nothing was predetermined or waiting for me, and everything would have to be rebuilt from scratch, was the perfect catalyst for living this adventure. There was never a moment of boredom, with wonderful encounters and the immense expanse of this calming ocean.

Working with colours and materials, the images in this exhibition present moments and details that transcribe the industrial realm of the cargo vessel and the atmosphere of my crossing, leaving full sway to the imagination and to reverie. As I left "my" cargo ship, I had only one thought: to get back someday on one of these Leviathans and experience new adventures on other seas and oceans under new skies! I hope that you will enjoy this little escapade and that it will incite you to go on your own adventure.

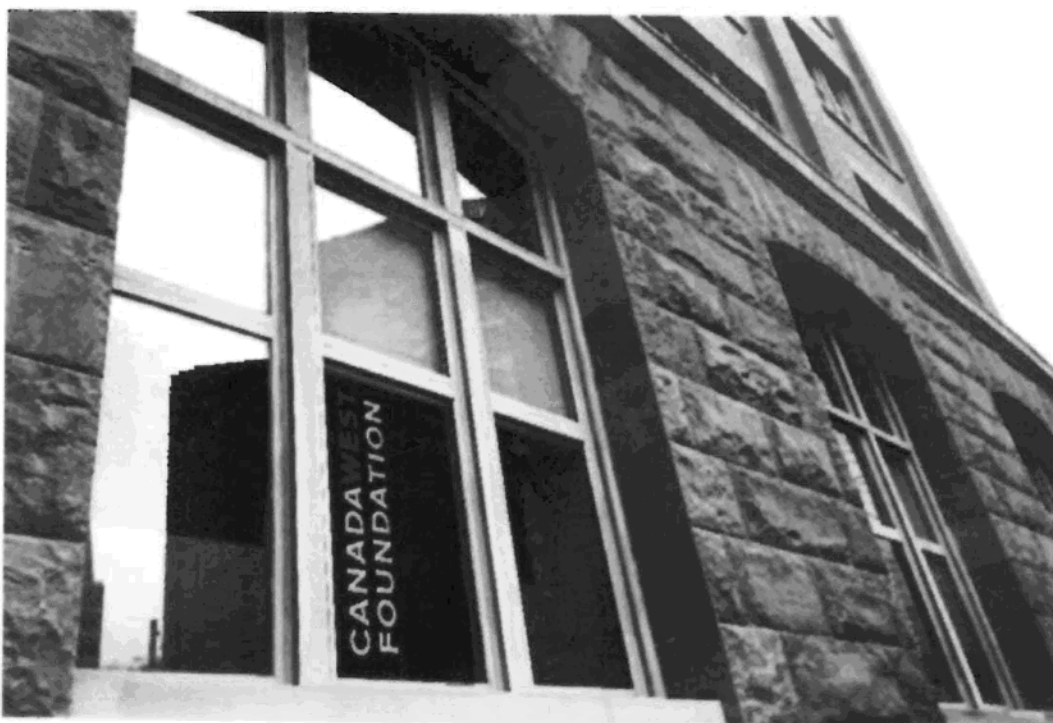

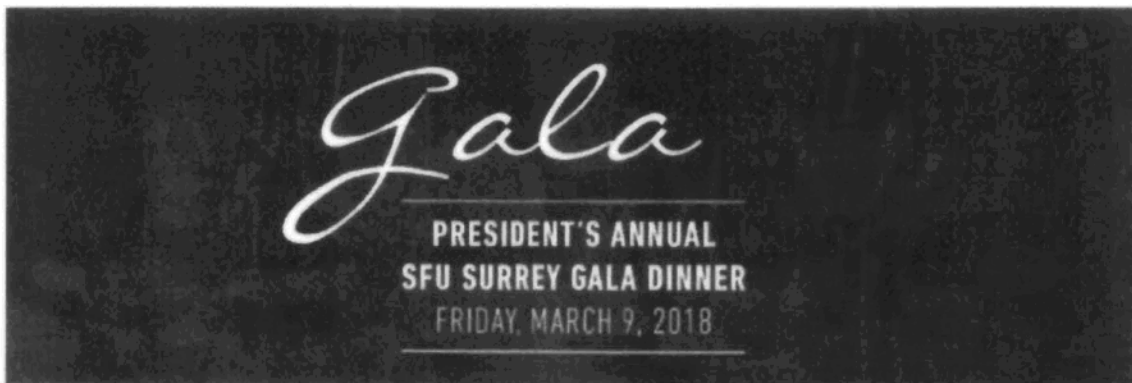
