I am disappointed that you have invoked a 45-day delay that was endorsed by the OIPC. This is wholly unnecessary and contravenes the Minister's own mandate letter, in which the Premier ordered her to: "Improve response and processing times for freedom of information requests." As such, I have copied Minister Sims.

Your office never attempted to begin releasing records in phases.

IAO's own policy and procedure handbook, which is published online, is plain and clear about Duty to Assist:

https://www2.gov.bc.ca/gov/content/governments/services-for-government/policies-procedures/foippa-manual/duty-assist

The access "partnership" between public bodies and applicants covers both the formal rights and duties under the Act and the informal contacts during the request process. Employees, members and officials of public bodies must work with applicants in a partnership to process every request: both parties have an interest in the efficient, timely processing of requests. Informal contacts between both parties should extend well beyond the formal duties imposed by the Act and regulations.

The behaviour of IAO and OOP on this file is reprehensible. The records should have been provided to me in January, but now you want to delay them until mid-May.

Is this what "Better B.C." really looks like?
