ADVICE AND RECOMMENDED RESPONSE:

- Government is committed to ensuring the FOI system in B.C. is transparent, accountable and provides timely service to British Columbians.
- FOI supports accountability and transparency into public bodies' activities. It also
 enables the media to access government information to share with the public and helps
 lawyers build cases, academics perform research, and entrepreneurs grow the
 economy.
- The Freedom of Information and Protection of Privacy Act (FOIPPA) contains a clause that protects the FOI system from requests that could inappropriately overload the system.

 In order to ensure the FOI system operates effectively for the many people who depend on it, we have asked the Information and Privacy Commissioner to give government the authority to disregard this request.

IF PRESSED:

•

- This latest request would require government to process more than 850 individual FOI requests, at costs that could potentially exceed \$2 million.
- The applicant in this case has been filing many requests for large volumes of records and using the system in a way that diminishes government's ability to provide a quality FOI service to British Columbians.
- Through the first three months of 2018, this applicant has submitted more than 1,750
 FOI requests, or 73% of all general requests received by government. The estimated
 cost of processing these requests is \$4.7 million.
- Political parties play a critical role in our democracy, but the large volume of requests impacts our ability to provide timely FOI service.

BACKGROUND REGARDING THE ISSUE:

 Government, through its Legal Services Branch (LSB), has written to the Office of the Information and Privacy Commissioner (OIPC) to request authority to disregard an FOI request submitted by a political party. The letter has also been copied to the applicant.

- The applicant requested through FOI "All emails sent to, or received from, [specified non-government email addresses] including cc's and bcc's (Date range for records search: From 07/18/2017 to 05/15/2018)".
- The requests name more than 35 personal email accounts that may be associated with government staff, and were submitted to every government ministry, including the Public Service Agency, GCPE and Office of the Premier.
- Processing this request requires government to create more than 850 individual FOI
 requests in order to gather the records. Government has not yet worked with the
 applicant to attempt to narrow the request and awaits the OIPC's decision.
- There are currently approximately 2,200 general FOI requests open in the system.
 Including this latest request, the applicant accounts for more than 1,700 of them, or nearly 80%.
- Section 43 of FOIPPA enables government to disregard a request as either 1) frivolous
 or vexatious, or 2) representing an unreasonable interference with the operation of
 government because of the systematic or repetitious nature of the request. Use of the
 section requires OIPC approval.
- Additionally, staff have identified a privacy risk associated with attempting to respond to the request, as some of the private email addresses listed contain the names of the account holders. There is a risk that responding could disclose the personal information of government employees named in the requests.
- IAO staff advise that there is limited precedent for responding to FOI requests involving the personal email of government employees.
