It is our constituent's understanding that these logs disclose information about the types of health services that individuals are accessing, including how much the government has spent on them. He is worried and concerned that if this is the case, it means that the public can have access to the types of healthcare services that he and his family is receiving, if the public searched for it. From my knowledge, and I shared this with the constituent, these logs are disclosing the salary of employees who's worked in the ministry, and it is unlikely that these records are disclosing information about the types of services individuals are receiving.

Any type of information you have on the Public Accounts and the attached records would be appreciated.
