A draft of the news release is attached, and we've included the current (but not final) funding break down below:

NDIT granted \$2,507,737 for projects totalling \$7,032,460. This is one of two large scale projects that resulted from phase 1 of the program (\$10 million back in 2015) with 28 communities benefitting. The Columbia Basin Trust one we sent a minister quote for was the other. Network BC will be working with NDIT to expedite a final report to give us the confirmed funding figures.
