One of our constituents called because he and others have been treated very poorly by a trailer park retailer. s.22

From my own quick search, it looks like licensing is required if the manufacturer is dealing with land and leasing but not if they are simply selling from a lot or showroom to be moved to another location. Can you confirm that understanding? Apparently due to this possible lack of regulation, this retailer and others are very slow to honour warranty agreements (if they do at all) and frequently demand large portions of the payments up front. Then once money is received, the retailer cannot be reached to repair or consult about issues.

Just wondering if you can clarify the rules on trailer manufacturer/retailers, and if there is a way that people can ensure their interests are looked after when they are purchasing these homes?
