The Ministry of Education and the Ministry of Citizens' Services are looking to host an engagement session within the next month to provide an overview and hear feedback on recent government developments to improve B.C. public sector privacy and access-to-information rules and enable service modernization.

The focus of the session will be on how government is responding to issues raised by key stakeholders during previous engagement sessions and through comments provided to the Special Committee of the Legislative Assembly appointed to review the *Freedom of Information and Protection of Privacy Act* (FOIPPA).

The following topics will be of particular interest for School Districts:

Session purpose:

 Hear feedback on opportunities to improve B.C.'s public sector privacy rules with a focus on data residency, privacy protection requirements, and subsidiary entities.

Key themes:

- Current data residency flexibility has generally not changed practices
 - Need to limit the number of tools available so students/teachers/parents do not get overwhelmed
 - O Do not have enough IT support in districts to ensure proper privacy/security practices are in place
 - Last amendment to FOIPPA created confusion regarding use of Azure AD in districts which has not been solved. Want to ensure any future amendments takes into consideration the school district setting.
 - Want to do everything possible to encourage innovation while managing risk and supporting teachers to follow the rules.
- Capacity for supporting technology implementation varies across school districts; limits opportunities
 - For example, data centres can be self-hosted in larger districts, not in smaller, leading to varied uptake in technologies. If could leverage data centres elsewhere, could bring some equity.
 - Smaller districts don't have capacity and expertise to be able to negotiate with vendors and review contracts thoroughly to ensure data is being managed appropriately
- Concerned about practicality of implementing Privacy Management Programs
 - School Act gives teachers large amount of authority on what they can do in classrooms need to balance autonomy with requirements
 - If required to implement large scale programs, would need more resources across all districts
 - Capacity problem in smaller districts some don't have privacy officers yet
 - Would need to understand data and have teachers on board before could implement. Many higher priority topics for the limited teacher professional development time.
- Subsidiary entities less prevalent now than historically



- Districts have changed the way their International Education and Distanced Learning programs operate; most are now departments in district rather than subsidiary entities.
- o Would need to define subsidiary entity for the school district context before moving forward.
- Leverage existing conduits to support implementation
 - o ERAC for training material
 - o Encourage use of myEd environment and tools to support compliance
