To change the company's registered and records addresses you will have to file a Form 2. (I have attached a blank form for your use).

Whichever email address is provided on the form will be the address that the account password is sent to which will allow access to proceed with other online filings. (Please see the attached document for filings that are done online and where to file).

Things to note when filing a Form 2:

- Please ensure you fill out all sections of the form.
- The delivery addresses cannot be PO Boxes
- There is a \$20 filing fee for which can be paid using a BC Online account in which you just need to provide us the account number, alternatively, you can send in a cheque payable to the Minister of Finance
- The director's name given and signed on the form must match the director on file.

Once the Form 2 has been filed and you have been sent the account password, you can file a Form 10 for a Change of Directors and other filings online.
