Hi Darcy et al.,

Thanks again for connecting today. In our conversation, you had indicated that it would be difficult, if not impossible, for your team to properly respond to the 2,700+ comments and information requests by March 20th. You had asked if an extension of that timeline is feasible. EAO had expressed that the quality of responses in adequately addressing the issues is a key priority rather than rush for unsatisfactory resolution. However, as Nathan noted, there are challenging cascading implications for our own timelines and the capacity for the working group, including First Nations, to have a fair opportunity to review and engage in the required following steps in this EA. The Collaboration Agreement plays an important role in this process. Upon further reflection, in addition to the consultation activities, I do also note that the public comment period ends March 9, and EAO will also need responses to those comments in a reasonable timeframe to support our assessment. Another critical target in my mind is that EAO has been aiming to have a solid draft assessment report for review by Nexen and the working group by the end of April. This target is supported by the information and consultation requirements outlined in my

December 14th screening letter to Nexen, as well as your responses to all the comments. You are all experienced in our EA process, so I will not belabour this ongoing process equilibrium.

All said, there are a number of factors we need to carefully consider and balance along the way. One thing that can help me understand what this means to EAO's app review workplan is to get a better sense of what new submission target you had in mind or options you may have in finding a balance in timing. As discussed, perhaps there are options to release key topics on March 20, then 1-2 further batches? Could you please give further thought to a plan forward and be ready to discuss on our Tuesday call? If you could send me a proposed plan Monday, I would be better prepared to reflect on a solution in time for the call.

Thank you for your letter of March 20, 2017, regarding the Environmental Assessment (EA) of the proposed Aurora LNG Digby Island Project (Aurora LNG Project). Nexen Energy ULC (Nexen) has requested that the Environmental Assessment Office (EAO) suspend Application Review in order to provide additional time for Nexen to respond to the comments received from the Working Group and public on the Application.

As noted in the EAO's initial evaluation decision letter to Nexen, dated December 14, 2016, it is important to ensure that Nexen fully considers and adequately responds to questions raised by the EAO, Working Group members, including Aboriginal Groups, and the public. The comments submitted during Application Review expand on many of the same questions identified during the initial evaluation of the Application, and raise additional inquiries. Your letter outlines a set of consultation activities and deliverables that are intended to represent the balance of the work required by Nexen to adequately address these questions. These issues are important to inform the EAO's assessment of the Aurora LNG Project, and the EAO expects that the meaningful fulfilment of the activities and deliverables identified in your letter will completely or considerably advance resolution of these issues.

The Prescribed Time Limits Regulations, BC Reg. 372/2002 establishes a time limit of 180 days for review of an Application under the *Environmental Assessment Act* (the Act). Pursuant to Section 24(2) of the Act, and after considering your request and reasons, I have granted your request to adjust the review schedule and suspend the

review time limit for the Aurora LNG Project effective today, March 20, 2017, on day 70 of the 180-day review period. The 180-day timeline will resume once I am satisfied that the following deliverables and associated engagement activities have been completed, specifically:

- a) Nexen must meaningfully respond to all round one comments received from the Working Group, including Aboriginal Groups, using a combination of a tracking table and memos, as appropriate. Responses to key issues must be informed by the engagement of selected Working Group members through topic-specific sessions and other meetings as directed by the EAO Project Lead.
- b) Nexen must meaningfully respond to all public comments using a combination of a tracking table and memos, as appropriate.

I note that Nexen committed to the above deliverables and associated engagement activities in your letter, and indicated that it anticipates completing these on May 15, 2017. Please inform the EAO, as soon as possible, if you anticipate a delay in this timing. I also note that Nexen committed to submitting batches of responses to the EAO as they are finalized. I encourage this approach, as it will support the timely consideration of responses and advancement of issues resolution.

As the Aurora LNG Project is undergoing a substituted EA, the EAO has notified the Canadian Environmental Assessment Agency of the timeline suspension, in accordance with the Memorandum of Understanding between the Canadian Environmental Assessment Agency and the British Columbia Environmental Assessment Office on Substitution of Environmental Assessments (2013).

This email provides an update regarding the Application Review schedule for the environmental assessment (EA) of the proposed Aurora LNG Digby Island Project.

Today, March 20, 2017, at the request of Nexen Energy ULC (Nexen), the EAO suspended the application review time limit for the Aurora LNG Digby Island Project (Aurora LNG Project) under Section 24(2) of the Environmental Assessment Act. The application review time limit has been suspended on day 70 of the 180-day Application Review period to provide additional time for Nexen to respond to the comments received from the Working Group and public on the Application. The 180-day Application Review time limit will resume once the EAO is satisfied that the deliverables and associated engagement activities have been completed. Please take a moment to read the suspension decision letter from Kevin Jardine, Associate Deputy Minister, which outlines the required deliverables.

Although the 180-day time limit is formally paused, the EA will actively continue and we will be seeking to involve the Working Group and Aboriginal Groups during this time. Notably, the EAO will be aiming to schedule key-issues sessions with select Working Group members and Nexen starting the week of April 10th. Your participation in these sessions will be necessary to completely or considerably advance the resolution of these issues and for the EAO to be able to conduct an informed assessment.
