Re: Consultation on the proposed Trans Mountain Expansion Project and Response to Musqueam Indian Band's Questions to the Joint Federal/Provincial Crown Consultation Team

Thank you for your letter of August 31, 2016 to Ross Neil, federal Crown Consultation Lead at the Major Projects Management Office (MPMO), in regard to the request for additional time for Musqueam Indian Band (Musqueam) officials to provide written comments on the draft Consultation and Accommodation Report for the proposed Trans Mountain Expansion Project (Project). As you are aware, the federal and provincial governments (Crown or Governments) are jointly consulting on the Project and as such have collaborated on this response to Musqueam's recent correspondence. Nathan Braun of the BC Environmental Assessment Office (EAO) is leading consultation on behalf of the provincial Crown.

As noted in an email from Ross Neil on September 1, 2016, the Crown respects the fact that the summer months are a time when many Musqueam members are practicing established fishing rights and other traditional activities. In light of your concerns, the Crown will extend the timeline for Musqueam to review this initial draft report and now welcomes comments by September 30, 2016. Please note that the Crown will be reviewing and incorporating any comments we receive on this initial draft and providing Musqueam with a revised draft and a further opportunity to review and comment in mid-October.

The next opportunity to comment will likely be somewhat more condensed in order to allow sufficient time to consider and incorporate all comments received into the final version of the Consultation and Accommodation Report.

In mid-October, along with a request for final comments on the revised draft report, Musqueam will be invited to provide a separate written submission by early November, that will be attached directly to the information informing Government decision making for the Project. This separate submission from Musqueam, that we suggest be no more than two pages in length, can address any outstanding issues or concerns that Musqueam has at that time in respect of the Project, the review process, consultation or the Consultation and Accommodation Report. This separate submission, along with two rounds of written comments on the draft Consultation and Accommodation Report, will ensure the Crown has had the ability to fully consider Musqueam's comments, outstanding issues and the adequacy of the consultation process with Musqueam.

We are also writing to further follow-up on the Crown's meeting with Musqueam on July 18, 2016. Enclosed are Crown responses to questions provided by Musqueam at this meeting regarding consultation and decision making processes. To begin, however, it may be useful to highlight a few key features of the draft Consultation and Accommodation Report that will help to address some of the general themes raised in Musqueam's questions.

The MPMO and EAO are preparing the Consultation and Accommodation Report to ensure that federal and provincial decision makers are fully informed of the procedural and substantive concerns raised by Aboriginal groups in respect of the Project, the Crown's assessment of the potential seriousness of the impacts of the Project on asserted or established Aboriginal rights, including title, and treaty rights (Aboriginal Interests), proposed mitigation/accommodation measures to address any potential impacts from the Project on Aboriginal Interests, and the Crown's views on the adequacy of the consultation process. We are seeking to clearly present Musqueam's perspectives within this report, as well as the Crown's analysis and conclusions.

The Crown Consultation Team's objective is to work with Musqueam and other Aboriginal groups to put forward the best information possible to decision makers via this Consultation and Accommodation Report. Comments and input sought from Musqueam will help the Crown Consultation Team to accurately convey Musqueam's issues, concerns, and any proposals to decision makers.

On behalf of the Crown Consultation Team, we trust you will find the enclosed answers to Musqueam's questions informative and we look forward to our ongoing dialogue. We

acknowledge that your letter of August 31, 2016 expressed a request to meet to discuss questions Musqueam currently have regarding the draft report, including the strength of claim assessment. We would be pleased to meet with Musqueam again to discuss your questions and concerns. A tentative meeting date of October 13th has been proposed and a member of the Crown Consultation Team will be following up shortly to confirm meeting arrangements.

As the Crown consultation team mentioned during our April 21st meeting, we would like to continue a dialogue with your community following the release of the National Energy Board (NEB) recommendation report on May 19, as part of Crown consultation on the proposed project. I am contacting you to determine your community's interest in meeting with the Crown and to identify a potential meeting date. The Crown consultation team is planning to be on Vancouver Island between July 18-22. Is there a preferred date and time during this period that would work well for Esquimalt Nation?








Dear President Cootes:

The Major Projects Management Office provided me with a copy of your December 16, 2016 letter regarding the Crown consultation for the Trans Mountain Expansion Project. Please accept my apologies for the delay in responding.

I understand that there is a misunderstanding about the location and size of the oil spill response bases on Vancouver Island associated with the project. I would like to offer a clarification of my comments from our September 29, 2016 meeting.

The location and capacity of each spill response base associated with the Trans Mountain Expansion Project are at the discretion of WCMRC, as part of the NEB's condition 133, and are based on WCMRC's determination of the most effective strategy to respond to oil spills near Vancouver Island and in the Juan de Fuca Strait. The discussion on September 29, 2016 reflected Transport Canada's understanding of WCMRC's plans at the time, and this caveat is noted in the minutes, i.e. "Best available information is that..."

Further, I acknowledge that I misspoke in my reference to five "full" bases on Vancouver Island, as the minutes' previous paragraph, recopied below, indicates that I was aware that the Ucluelet base was not planned to be a "full" base. I regret the misunderstanding.

Best available information is that WCMRC will set up a spill response base in Ucluelet if TMX goes ahead, which is meant to be a rapid response base – capable of delivering 2,500 tonne response capacity within 6 hours – that would work in tandem with the Port Alberni and Beecher Bay bases to bring in cascading resources in the event of a larger spill.

It may be helpful to restate that, while Transport Canada requires WCMRC to meet the regulated planning standards, the NEB's condition 133 sets requirements on Trans Mountain that go above and beyond Transport Canada's regulations by more than



double. It is therefore at the discretion of Trans Mountain, and by extension WCMRC, to determine the best location and equipment capacity to meet condition 133.

To that end, the discussion about cascading resources found in the minutes of November 29, 2016 may be helpful in understanding how the different bases and caches work in concert to protect the waters of Vancouver Island and the Juan de Fuca Strait.

With respect to Lincoln Heaney's remarks, Transport Canada defers to WCMRC's latest information on the status of their plans.

It is worth noting that, under the Oceans Protection Plan announced on November 7, 2016, the Government of Canada will work closely with Indigenous groups to enhance their response capacity in their territories, creating opportunities for Indigenous groups to take a more active role in emergency response and waterway management. There is still a lot of work to do to launch the initiatives, and we look forward to working with you and others as we implement the Oceans Protection Plan. The South Coast Marine Safety Workshop in Sidney earlier this week was a first step, and we were pleased to see Maanulth members in attendance there.

Thank you for seeking clarification and I trust this addresses your question.

TMX ISSUES BASED TRACKER

Introduction:

This document has been prepared by the Major Projects Management Office (Natural Resources Canada) in collaboration with federal government departments and agencies for internal use by the Government of Canada. The Major Projects Management Office is maintaining two types of Aboriginal Issues Tracking Tables (ITTs) for the Trans Mountain Expansion Project ("the Project" or "TMX"):

- 1) Aboriginal group-specific ITTs; and
- 2) Issues Based Tracker (IBT)

The IBT below, serves as a singular master table of key issues raised by Aboriginal groups during the National Energy Board (NEB) review and associated Crown consultation process, mitigation proposed to address the issue, and Crown analysis as to what extent the issue may be addressed by proposed mitigation at this stage in the process. The identification, documentation and analysis of the information in this IBT was primarily informed by a review of the NEB hearing record, supplemented by Aboriginal group correspondence and meetings with the Crown.

Guidance followed by federal departments for conducting analysis in the IBT can be found in the TMX Phase III Consultation Approach and Work Plan. As the IBT is high-level and generic in nature, please refer to the Aboriginal group-specific ITTs or original source material on the NEB hearing record for further context on the issues raised by a particular group.

The information contained in the IBT and ITTs is iterative in nature and will be updated as new information becomes available. Issues Tracking Tables can help inform the Crown's ongoing assessment of the depth of consultation owed to a particular group, and will help identify whether outstanding issues exist, and if further consultation and accommodation may be required. Efforts will continue throughout the post-NEB hearing phase (Phase III) of consultation, to refine the IBT and ITTs, which will ultimately be summarized in the Crown Consultation Report for the Project and inform the adequacy of consultation assessment.
