- The BC Oil and Gas Commission sent an inspector to the site to ensure the work has proper authorizations and is in compliance with permits under its limited jurisdiction.
- DFO Conservation and Protection officers attended the site on August 8 and 9th, and determined sediment was being managed and monitored appropriately, juvenile fish were being handled appropriately, and all works were in compliance with conditions of the applicable Fisheries Act authorization.
- We will continue to investigate any complaints related to the project construction to ensure B.C.'s environment and sensitive ecosystems are protected.
