Thanks again for meeting earlier this week. As discussed, I've drafted an email (below) in follow-up to the last agenda item we weren't able to discuss, for your review/feedback.

Good morning Committee Members,

Thank you again for a productive meeting on Tuesday morning. Your feedback, comments and dialogue on the various agenda topics are invaluable, and provided important insight into how the CW-ELCC actions and priorities are impacting BC communities, and what we need to pay attention to moving forward as we begin planning for the next three years of the Agreement.

As we ran out of time for our last agenda item, due to our fantastic discussions, and as discussed at the end of our meeting, please find attached the template provided by the Government of Canada meant to inform/guide the development/drafting of the December 1, 2022 Implementation Report. We are planning to start populating the template shortly, in order to be able to move the draft up through various internal approvals before it is finalized and submitted on December 1, 2022. Please note, this one-time report does not replace BC's reporting requirements under the CW-ELCC Agreement – e.g., we will still be producing an Annual Report for each year of the Agreement, that will detail investments, outcomes, across all areas of the Agreement.

We will endeavor to share a draft of the report with this Committee, prior to finalization, so Committee members have the opportunity to review and provide feedback before public release.

Regarding your request for an update on BC's target for \$10 a Day spaces under the CW-ELCC – I believe our comm's teams have been in consultation regarding a potential joint federal-provincial announcement in December.

As you know, BC committed to increase the number of \$10 per day spaces to a total of 12,500, and reduce average parent fees for regulated and funded child care for children aged 0 to 5 by 50%, for a combined impact of \$21 per day on average, by December 2022.

BC is on track to significantly reduce parent fees to \$21 a day for children 5 years and under in December 2022 through the fee reductions we announced with Minister Gould on September 23. We anticipate reaching a total of 10,500 \$10 a

Day spaces by December. The remaining 2,000 are now expected to be in place by February 2023. The primary reasons for this delay are due to receiving the majority of applications in the last week of the intake, and most applications requiring longer than expected to rectify incomplete information. We have also had numerous applicants withdraw from consideration and opt to participate in the fee reduction program instead following the announcement in September.

We are working as quickly as we can to confirm the remaining 2,000 \$10 a Day spaces and look forward to sharing confirmation of reaching the 12,500 target early in 2023.
