Background

Earl Marriott Secondary School (EMS) in School District 36 Surrey is the fourth largest secondary school in BC. EMS teaches grades 8-12 in English and French Immersion, with each grade level having about 300-400 students. The school is designed to accommodate 1,500 students; however, the total enrollment is currently 1,859 students. There are 11 portables onsite.

In mid-December 2020, a number of exposures occurred at EMS linked to four Physical Education/Active Living classes. There is no confirmed transmission to other classes or cohorts. In total there were 47 confirmed cases of COVID-19.

Timeline of Events

December 10-16: Exposures occur in four PE/Active Living classes.

December 14-28: Fraser Health Authority (FHA) issues COVID-19 notifications for EMS.

December 23 & January 3: Surrey School District issues two additional letters in response to parent and community questions about the number of exposures. Letters written in collaboration with FHA.

All exposure dates were reported to the Ministry through the established reporting process.

Contributing Factors

A review by the Surrey School District and public health determined the following activities may have contributed to the exposures at EMS:

Key Learnings

- The situation at EMS appears to be the result of the <u>provincial health and safety guidelines</u> for physical and health education either not being followed or being misinterpreted. There is no indication that the guidelines were inadequate in this situation.
- COVID-19 cases related to the EMS exposures were contained to the four PE/Active Living classes and did not spread throughout the school thanks to other health and safety measures in place.
- PE activities that include close physical contact or high-intensity stationary indoor workouts should be avoided in favour of outdoor activities or activities where 2m physical distancing can be maintained.
- Sharing ideas between PE teachers across the district has proved helpful in identifying innovative ways to run PE classes.
- Space was a contributing factor in this situation. EMS is currently at excess capacity and all indoor PE spaces are in use. The new Grandview Heights Secondary, which is scheduled to open in September 2021, will address the overcrowding at EMS.
