SUBJECT: Collective Bargaining – Class Composition Provisions

PURPOSE: Overview of BCPSEA's Guide for Districts to Implement the Jackson Award

on Class Composition

BACKGROUND:

The 2016 Supreme Court of Canada decision to restore class size and composition language
required developing a process to assess and place students based on language that had not
been in place for many years. The employer and the union did not agree on the approach
for two specific categories and ultimately Arbitrator Jackson determined in 2019 that class
composition should be based on the criteria in place when the language was removed in
2002 (the "Jackson Award").

- This decision impacted class composition requirements for two special education categories that have changed significantly since 2002:
 - o Category G (Autism) has become Category G (Autism Spectrum Disorder)
 - o Category J (Severe Learning Disabilities) has become Category Q (Learning Disability)
- In particular, the shift from "Autism" to "Autism Spectrum Disorder" was fairly significant moving to a spectrum disorder encompassed a much broader range of criteria and a larger number of students were eligible for the designation and to receive funding.
- The Jackson award means that although students in Category G who meet the newer criteria are still funded, school districts take into consideration the narrower criteria used in 2002 (which describes cases on the more severe side of the autism spectrum) for class composition purposes.
- While BCPSEA shared information about the Jackson Award with school districts in 2019, they did not provide sector-wide direction on how it should be implemented.
- Since then, nine school districts have recalculated their class composition requirements based on the Jackson Award (see Attachment 1), all of which the BCTF grieved, stating that the districts were too stringent in their calculations.
- BCPSEA and the BCTF have now reached local settlement agreements for these grievances.
