Dear Minister Fleming,

The historic Metchosin Elementary School was established in 1872 by early settlers in the area and was turned over by the community in 1946 to School District 62. The school, and the property surrounding it, is in the centre of the Metchosin Village and has become an integral part of the community, despite not hosting regular classes by School District 62 since 2001.

The school district has identified the property as a surplus asset and is hoping to sell the property as part of its long-term plan to build more desperately needed schools in the rapidly growing Sooke and West Shore region. The District of Metchosin is interested in purchasing the property so that it can continue as an important community gathering place, hub of community learning and support local arts and culture.

The purchase will also help to enhance Metchosin's capacity as a regional resource centre of training for professionals across first responder services. The property is in a unique position to deliver on the ground training and is already supported by a number of departments in this vision. The proposal for purchase between the School District and Metchosin is also designed to be part of a comprehensive plan to meet the School District's overall facilities plan.

As you will see in the enclosed documentation from Metchosin Mayor John Ranns, there are a variety of local and regional groups interested in putting the property to unique and exceptional use. There are exciting proposals from the Metchosin Arts and Cultural Centre Association, West Shore Arts Council, Justice Institute, University of Northern British Columbia, local fire departments and the provincial search and rescue team. Additionally, the property would deliver some of the playing fields required by the School District, feature prominently in the new Metchosin Village Centre and provide facilities for Westshore Parks and Recreation to use as part of its programs.

Minister, I am writing to request that you consider the request for funds laid out in the documentation attached. The success of this proposal will not only benefit Metchosin, also the West Shore, Sooke School District and the Capital Regional District.

Dear Minister Fleming:

I am writing on behalf of my constituent s.22 who is concerned for the safety of s.22 who is attending Stoney Creek Community School.

We have learned from the District Facilities Department of School District #41 that the school building presents with all three rating levels for seismic risk. The second floor is high risk and requires a structural upgrade. The gymnasium is medium risk and requires non-structural upgrades. The main floor classrooms meet current structural safety requirements. | \$.22 | classroom is on the second floor which is the high risk part of the school building.

A budget of \$4 million has been submitted to the Ministry but the School District has not received funding for the upgrades and nor have they begun a Preliminary Design Review.

The recent earthquake in Mexico is a tragic reminder that we live in a seismically active region. The children of our province are our most precious resource. We must do everything in our power to protect them. Can you please tell my constituent what your plans are for the seismic upgrading of Stoney Creek Community School.
