- Nearly 9,000 are Status First Nations learners living on-reserve who choose to attend a B.C. public school;
- Nearly 6,000 learners choose to study at one of more than 130 First Nation band-operated schools;
- More than 5,500 choose to study at one of B.C.'s independent schools (including approximately 700 Status First Nations learners).


