**SUBJECT:** Funding to ARC Foundation

**PURPOSE:** Approval to transfer funds to ARC Foundation to support Sexual

Orientation and Gender Identity inclusive schools

#### **BACKGROUND:**

• In September 2016, the Minister of Education announced a partnership with the ARC Foundation of Vancouver to support schools in developing Sexual Orientation and Gender Identity (SOGI) inclusive policies. As a result of this announcement, the Ministry formalized the partnership through a Memorandum of Understanding (MOU).

- In October 2016, ARC Foundation, in collaboration with the Ministry of Education, BC
  Teachers' Federation and other provincial partners, launched the SOGI 1 2 3 initiative.
  SOGI 1 2 3 provides accessible and ready-to-use resources, and includes a BC SOGI
  Educator Network that facilitates the accessing and sharing of resources and information
  within and across school districts. Within the Network, a SOGI District Lead in each school
  district provides consistent support to district staff and SOGI School Leads.
- In October 2017, the Ministry funded a Provincial SOGI District Lead Summit with attendance from school districts participating in the BC SOGI Educator Network.

## **DISCUSSION:**

• The partnership with the ARC Foundation has resulted in a number of significant accomplishments including the development of guiding principles for SOGI inclusive education, provincial SOGI policy and leadership summits, and integration of SOGI into school districts' and independent schools' codes of conduct. SOGI 1 2 3 resources developed by ARC, including videos, eLearning modules and instructional samples have been very well received by school districts and K-12 education partners – \$.13

- Results from a June 2017 survey of participating school districts in the BC SOGI Educator Network included:
  - 100% of District Leads reported educators in their district are confident engaging in SOGI-inclusive education/activities at least some of the time, compared to 0% in October 2016
  - 77% of School Leads reported that their school has the support and resources to plan and deliver SOGI initiatives and activities compared to 48% in January 2017
  - 34% of School Leads agree that educators in their school incorporate SOGI into the curriculum compared to 19% in January 2017

- The BC SOGI Educator Network has expanded from nine school districts in 2016/17 to 49 school districts in 2017/18, far surpassing the target of 20 school districts for this fiscal year.

# SOGI Education Initiative Educational Materials Publication Agreement

#### BETWEEN:

Her Majesty in Right of the Province of British Columbia, as represented by the Minister of Education (the "Province")

#### AND:

ARC Foundation ("ARC") (collectively, the "Parties")

#### Whereas:

- A. The Parties entered into a non-binding memorandum of agreement dated [date] regarding the Sexual Orientation and Gender Identity (SOGI) Education Initiative (the "Initiative");
- B. Both Parties want materials developed in support of the Initiative (the "Materials") to be available to the public;
- C. ARC has agreed to host the Materials on its website; and
- D. The Parties wish to document the Terms under which the Materials will be used by each party and posted to the site by ARC.

#### The Parties agree as follows:

- 1. In this Agreement,
  - (a) "Provincial Material" means any material provided to ARC for posting on the publicly accessible site under section x of this agreement;
  - (b) "ARC Material" means materials produced by ARC;
  - (c) The "Website" means [need address or other identifying terms]
- 2. The Province may, from time to time, provide Provincial Material to ARC for publication on the Website.
- 3. When ARC receives Provincial Material under paragraph 2, it will post that Material within [30] days, or as otherwise agreed.
- ARC will remove Provincial Material from the Website immediately, upon request by the Province.
- 5. The Province exclusively owns all property rights in the Provincial Material.
- By posting Provincial Material on its site, ARC does not acquire any ownership in that Material.
- 7. Each Party may use the Material of the other Party for the purposes of [??]. If a Party incorporates Material owned by the other Party into its own publications, it will acknowledge the other Party's ownership of copyright as follows:

#### RECIPROCAL LICENSE AGREEMENT

OF THE SECOND PART

#### WHEREAS:

- A. The ARC Foundation is a private foundation set up as a trust with the vision to bring awareness of the issues of the disenfranchised and the impact of prejudice and is the owner of the ARC SOGI Materials:
- B. As a result of the Province's initiative to make public and independent schools SOGI inclusive through codes of conduct and anti-bullying policies, the Province has developed and is the owner of certain Province SOGI Materials;
- C. The Province wishes to obtain a license from ARC to use, reproduce, publish and telecommunicate to the public the ARC SOGI Materials and ARC wishes to obtain a license from the Province to use, modify, reproduce, publish and telecommunicate to the public the Province SOGI Materials; and
- D. Both parties wish to grant each other such a license, on the terms and subject to the conditions contained in this Agreement.

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the

mutual promises and respective obligations set out below and of other good and valuable consideration (the receipt and sufficiency of which is hereby acknowledged by each party), the parties agree as follows:

# **DEFINITIONS:**

- 1.01 In this Agreement and the Recitals:
  - (a) "Event of Default" means, in the case of a default by ARC, each of the events specified in paragraph 9.01, and in the case of a default by the Province, each of the events specified in paragraph 9.02;
  - (b) "ARC Marks" means the trade marks, trade names, design marks and other commercial symbols designated by ARC for use with the ARC SOGI Materials, as described in Schedule "A" to this Agreement;
  - (c) "ARC SOGI Materials" means ARC's materials relating to the SOGI education initiative and as further described in Schedule "A" to this Agreement, and as Schedule "A" may be amended by written notice from ARC to the Province from time to time;
  - (d) "Event of Force Majeure" has the meaning set out in paragraph 15.08;
  - (e) "Intellectual Property" includes, without limitation, any and all artistic, photographic or literary works (including reports, designs, compilations of data, working drawings and technical documentation), or any compilations thereof or modifications thereto, trade-marks, trade secrets, confidential information, industrial designs, design patents, preliminary and final concepts, ideas, inventions (whether or not patentable or reduced to practice), all patents and applications therefor and the right to apply for patents thereon in any and all countries of the World;
  - (f) "Modifications" means any changes, revisions, additions, deletions, updates, or any other modifications whatsoever, made by or on behalf of ARC, in any format or method of delivery whatsoever and whether created through technology in existence on the Effective Date or which may be developed in the future, that are derived from or based upon the Province SOGI Materials;
  - (g) "Province Mark" means the official mark of the Province described in Schedule "B" to this Agreement;
  - (h) "Province SOGI Materials" means the Province's materials relating to the SOGI education initiative and as further described in Schedule "B" to this Agreement, and as Schedule "B" may be amended by written notice from the Province to ARC from time to time;

- (i) "SOGI" means sexual orientation and gender identity;
- (j) "Term" means the period set out in paragraph 4.01 and includes any renewal pursuant to paragraph 4.02; and
- (k) "Website" means ARC's website located at http://www.sogieducation.org/ or such other alternate internet address of which ARC may advise the Province in writing.

# **ARC SOGI MATERIALS LICENSE**

- 2.01 Subject to the terms and conditions of this Agreement, ARC hereby grants to the Province, a non-exclusive, non-assignable, royalty-free, worldwide license for the Term to:
  - use, reproduce, publish and telecommunicate to the public the ARC SOGI Materials, in whole or in part;
  - (b) make Modifications to the ARC SOGI Materials; and
  - (c) use and reproduce the ARC Marks in association with the ARC SOGI Materials, with the Province SOGI Materials and the Modifications.
- 2.02 All rights not expressly granted to the Province in this Agreement are reserved by ARC including the rights to license to other licensees, sublicense, use for its own purposes, reproduce, modify and distribute the ARC SOGI Materials directly to the public.
- 2.03 Upon execution and delivery of this Agreement, ARC will provide the Province with a copy of the ARC SOGI Materials on a flash drive.

# PROVINCE SOGI MATERIALS LICENSE

- 3.01 Subject to the terms and conditions of this Agreement, the Province hereby grants to ARC a non-exclusive, non-assignable, royalty-free, worldwide license for the Term to:
  - (a) make Modifications to the Province SOGI Materials; and
  - (b) use, reproduce, publish and telecommunicate to the public the Province SOGI Materials and the Modifications.
  - (c) subject to paragraph 3.03 and 3.04, use and reproduce the Province Mark in association with the Province SOGI Materials, the ARC SOGI Materials and the Modifications.

- 3.02 All rights not expressly granted to ARC in this Agreement are reserved by the Province including the rights to license to other licensees, sublicense, use for its own purposes, reproduce, modify and distribute the Province SOGI Materials directly to the public.
- 3.03 ARC agrees that its reproduction and use of the Province Mark will at all times be under the control of the Province and that it will only reproduce or use the Province Mark in accordance with this Agreement, and the Province's BCID Graphic Standards guide relating to the Mark (a copy of which is attached as Schedule "1" to Appendix B), and any additional terms, conditions or instructions provided by the Province from time to time in its sole discretion.
- 3.04 Prior to publication, ARC will:
  - a) provide the Province with samples of materials prepared by, for or with the permission of ARC that bears or refers to the Province Mark; and
  - comply with all further policies, specifications, regulations and standards authorized or stipulated by the Province from time to time forthwith upon being notified of same.
- 3.05 Within 60 days of the execution and delivery of this Agreement, the Province will provide ARC with a copy of the Province SOGI Materials on a flash drive.
- 3.06 Within 14 days of receiving the Province SOGI Materials, ARC will ensure that the Province SOGI Materials are posted to the Website.

# TERM

- 4.01 This Agreement will commence on the Effective Date of this Agreement and will end on the fifth anniversary thereof (the "Initial Term") unless renewed pursuant to paragraph 4.02 or terminated pursuant to paragraph 9.04.
- 4.02 Unless either party provides prior written notice to the other party at least 60 days prior to the end of the Initial Term, this Agreement will be renewed automatically for an additional five year period on the same terms and conditions contained herein, except this provision as to renewal.

#### REPRESENTATIONS AND WARRANTIES

- 5.01 ARC represents and warrants to the Province that:
  - (a) it has the power and capacity to accept, execute and deliver this Agreement;

- (b) this Agreement is binding upon and enforceable against ARC in accordance with its terms;
- (c) all necessary proceedings have been taken and done to authorize the execution and delivery of this Agreement by ARC;
- it has no knowledge of any fact that materially adversely affects or, so far as it can foresee, might materially affect its abilities to fulfill its obligations under this Agreement;
- (e) the observance and performance of the terms and conditions of this Agreement will not constitute a breach by it of, or a default by it under
  - (i) any applicable laws,
  - (ii) its constating documents, or
  - (iii) any contract or agreement to which it is a party;
- it has no knowledge of any untrue or inaccurate representation or assurance, whether verbal or written, given by ARC, its directors or officers to the Province in connection with this Agreement;
- (g) it is the owner of all intellectual property rights, including without limitation copyright and trade mark, in and to the ARC SOGI Materials and the Marks;
- it has sufficient rights in the ARC SOGI Materials to grant to the Province the license described in paragraph 2.01; and
- the grant of license in paragraph 2.01 does not and will not infringe upon the proprietary rights or interest of any person or entity.
- 5.02 The Province represents and warrants to ARC that:
  - it is the owner of all intellectual property rights, including without limitation copyright, in and to the Province SOGI Materials;
  - it has sufficient rights in the Province SOGI Materials to grant to ARC the license described in paragraph 3.01; and
  - (c) the grant of license in paragraph 3.01 does not and will not infringe upon the proprietary rights or interest of any person or entity.
- 5.03 All representations, warranties, covenants and agreements made by ARC in this

- Agreement are material and will conclusively be deemed to have been relied upon by the Province, notwithstanding any prior or subsequent investigation by the Province.
- 5.04 All representations, warranties, covenants and agreements made by the Province in this Agreement are material and will conclusively be deemed to have been relied upon by ARC, notwithstanding any prior or subsequent investigation by ARC.
- 5.05 ARC acknowledges that the Province SOGI Materials are being provided to ARC by the Province "as is", and that except as expressly set out in this Agreement, the Province makes no warranty, condition or representation, whether oral or written, express or implied, or arising by law, custom, prior oral or written statements, or otherwise with respect to the Province SOGI Materials, and expressly disclaims all warranties and conditions, including without limitation warranties and conditions of satisfactory quality, merchantability, fitness for a particular purpose, title, error free or uninterrupted use.
- 5.06 The Province acknowledges that the ARC SOGI Materials are being made available to the Province by ARC "as is", and that except as expressly set out in this Agreement, ARC makes no warranty, condition or representation, whether oral or written, express or implied, or arising by law, custom, prior oral or written statements, or otherwise with respect to the Province SOGI Materials, and expressly disclaims all warranties and conditions of satisfactory quality, merchantability, fitness for a particular purpose, title, error free or uninterrupted use.

## REPRODUCTION

- 6.01 The Province will include on all copies of the ARC SOGI Materials an indication that ARC is the copyright owner of the ARC SOGI Materials, in form and content satisfactory to ARC.
- 6.02 In the event that portions of the ARC SOGI Materials are incorporated into other works, the Province will acknowledge ARC as contributing that portion.
- 6.03 ARC will include on all copies of the Province SOGI Materials an indication that the Province is the copyright owner of the ARC SOGI Materials, in form and content satisfactory to Province.
- 6.04 The Province will be solely responsible for all costs of performing its obligations and exercising its rights under this Agreement, including but not limited to the use, reproduction, publishing and telecommunication to the public of the ARC SOGI Materials, in whole or in part.

6.05 ARC will be solely responsible for all costs of performing its obligations and exercising its rights under this Agreement, including but not limited to making Modifications to the Province SOGI Materials and the use, reproduction, publishing and telecommunicating to the public the Province SOGI Materials and the Modifications.

#### **OWNERSHIP**

- 7.01 The Province acknowledges and agrees that ARC or its licensors, as applicable, are the owners of all proprietary rights, including copyright and other Intellectual Property rights, in the ARC SOGI Materials and the Marks.
- 7.02 ARC acknowledges and agrees that the Province is the owner of all proprietary rights, including copyright and other Intellectual Property rights, in the Province SOGI Materials and any Modifications.

# INFRINGEMENT

- 8.01 Notwithstanding any other provision of this Agreement, nothing in this Agreement will serve to obligate the Province to commence or maintain any legal proceedings against a third party for infringement of any proprietary rights of the Province or rights of ARC under this Agreement.
- 8.02 ARC may, at its expense, commence legal proceedings in its own name for the infringement of the rights of the Province in and to the ARC SOGI Materials, or any rights of ARC under this Agreement.

# **DEFAULT AND TERMINATION**

- 9.01 Any of the following events will constitute an ARC Event of Default:
  - (a) ARC fails to observe, perform or comply with any provision of this Agreement;
  - (b) an order is made, a resolution is passed or a petition is filed for the liquidation or winding-up of ARC;
  - (c) ARC becomes insolvent, commits an act of bankruptcy, makes an assignment for the benefit of its creditors or otherwise acknowledges its insolvency;
  - (d) ARC assigns, sells or in any manner disposes of or encumbers other than by floating charges all or any of the rights acquired under this Agreement;
  - (e) a receiver or receiver-manager of any property of ARC is appointed;

- any representation or warranty made by ARC in accepting this Agreement is or becomes untrue or incorrect; or
- (g) ARC ceases, in the opinion of the Province, to operate.
- 9.02 The following event will constitute an Event of Default by the Province:
  - the Province fails to observe, perform or comply with a material provision of this Agreement.
- 9.03 On the happening of an Event of Default, or at any time thereafter, the non-defaulting party may do any one or more of the following:
  - (a) pursue any remedy available to it at law or in equity;
  - (b) waive the Event of Default; and
  - (c) deliver written notice to the defaulting party specifying the Event of Default and requiring rectification within 30 days of the date of delivery of such notice, or within any other such reasonable period as specified by the nondefaulting party in such notice.
- 9.04 Where an Event of Default is not remedied within 30 days of delivery of notice, or such other period as specified by the non-defaulting party under subparagraph 9.03(c), the non-defaulting party may, in its sole discretion, terminate this Agreement by notice in writing to the defaulting party.
- 9.05 Immediately following the Expiry Date or date of earlier termination of this Agreement, both parties will cease exercising the rights under paragraph 2.01 or 3.01, as applicable.
- 9.06 Within 30 days after the Expiry Date or date of earlier termination of this Agreement, both parties will:
  - ensure that all physical copies of the Licensed Materials are destroyed and all electronic copies are deleted from that party's servers; and
  - (b) confirm in writing to the other party that such destruction and deletion is complete.

# LEGAL RELATIONSHIP / ASSIGNMENT

- 10.01 No partnership, joint venture or agency will be created or will be deemed to be created by this Agreement or any action of the parties under this Agreement.
- 10.02 Neither party will, without the prior written consent of the other party, assign, either directly or indirectly, this Agreement or any rights thereunder, except that

- the Province may assign this Agreement or its rights thereunder to a "government body" as defined in the *Financial Administration Act* (British Columbia).
- 10.03 Neither party will commit the other party to pay money to any person, firm or corporation.
- 10.04 Nothing in this Agreement is to be construed as interfering with the exercise by either the Province or its agencies, or ARC, of any statutory power or duty.

# RELEASE AND INDEMNITY

- 11.01 ARC will indemnify and hold harmless and forever releases and discharges the Province from and against any and all claims, causes of action, loss, damage, costs, expenses or liability suffered or sustained by the Province at any time (either before or after the termination of this Agreement) of any kind and every nature, including any claim of infringement of third party intellectual property rights, where the same or any of them are based upon, arise out of or occur, directly or indirectly, from or by reason of breach of the Agreement by ARC or any of ARC's agents, employees, officers, or directors.
- 11.02 The Province will indemnify and hold harmless and forever releases and discharges ARC from and against any and all claims, causes of action, loss, damage, costs, expenses or liability suffered or sustained by ARC at any time (either before or after the termination of this Agreement) of any kind and every nature, including any claim of infringement of third party intellectual property rights, where the same or any of them are based upon, arise out of or occur, directly or indirectly, from or by reason of any breach of the Agreement by the Province or employees or agents of the Province.

## ARBITRATION

- 12.01 All disputes between the parties arising out of or in connection with this Agreement will be referred to and finally resolved by arbitration administered under the Arbitration Act.
- 12.02 The place of arbitration will be Vancouver, B.C.

# NOTICES

13.01 Any notice, approval, consent, waiver, statement, or other document that either party may desire or be required to give or deliver to the other will be conclusively deemed validly given or delivered to and received by the addressee, if delivered personally on the date of delivery or, if mailed, on the fifth business day after the mailing of the same in Canada by prepaid post addressed,

- 13.02 In addition to paragraph 13.01, any notice, approval, consent, waiver, statement or other document may be delivered by facsimile transmission from a party and will be conclusively deemed to have been given to and received by the intended recipient when so transmitted if transmitted by facsimile numbers, as applicable, that the parties may, from time to time advise.
- 13.03 Either party may, from time to time, advise the other by notice in writing of any change of address or facsimile number of the party giving such notice and from and after the giving of such notice the address or facsimile number therein specified will, for purposes of this Agreement, be deemed to be the address or facsimile number of the party giving such notice.

#### NON-WAIVER

- 14.01 No provision of this Agreement and no breach by either party of any such provision will be considered to have been waived unless such waiver is in writing by the other party.
- 14.02 The written waiver by a party of any breach of any provision of this Agreement will not be deemed a waiver of such provision itself or of any subsequent breach by the other party of the same or any other provision of this Agreement.

#### GENERAL

- 15.01 Time will be of the essence of this Agreement.
- 15.02 The headings in this Agreement are inserted for convenience only and do not form part of this Agreement.
- 15.03 This Agreement will enure to the benefit of and be binding upon the parties and their respective successors and permitted assigns.
- 15.04 This Agreement constitutes the entire agreement between the parties with respect to the subject matter of the Agreement.
- 15.05 Any amendment to the terms and conditions of this Agreement must be in writing and duly executed by both parties.
- 15.06 If any provision of this Agreement is found to be invalid, illegal or unenforceable it will be severable from this Agreement and the remaining provisions will not be affected thereby and will be valid, legal and enforceable.
- 15.07 Each of the parties will, upon the reasonable request of the other, make, do, execute or cause to be made, done or executed all further and other lawful acts, deeds, things, devices, documents, instruments and assurances whatever for the better or more perfect and absolute performance of the terms and conditions of this Agreement.
- 15.08 Neither party will be liable for any failure or delay to perform that party's obligations resulting from any cause beyond that party's reasonable control from and including, but not limited to, fires, explosions, floods, strikes, work stoppages or slowdowns or other industrial disputes, accidents, riots or civil disturbances, acts of civil or military authorities, inability to obtain any necessary license or consent, or delays caused by carriers, contractors or material shortages (each an "Event of Force Majeure").
- 15.09 Each party will promptly notify the other party in writing upon the occurrence of

an Event of Force Majeure.

- 15.10 This Agreement may be executed by the parties in one or more counterparts, which may be delivered by facsimile transmission or email with the executed counterpart attached in PDF format. Each counterpart when so executed and delivered will be deemed an original, and all such counterparts together constitute one and the same document.
- 15.11 In this Agreement, the singular includes the plural, and vice versa, as the context requires.
- 15.12 A reference in this Agreement to a statute, whether or not that statute has been defined, means a statute of the province of British Columbia unless otherwise stated and includes every amendment to it, every regulation made under it and any enactment enacted in substitution for or replacement of it.
- 15.13 This Agreement will be governed by and construed and interpreted in accordance with the laws of the province of British Columbia and the laws of Canada applicable therein.

IN WITNESS WHEREOF the parties have executed this Agreement on the date first above written.



# Tips for reproducing the BC Mark in print

To simulate any shade of colour in a print document, printers usually employ varying sizes and patterns of tiny halftone spots (spots made up of many dots of Cyan, Magenta, Yellow and Block ink or toneri created with a line screen. A line screen is the measure of how many halftone dots of ink are printed in a linear inch. The value is expressed as Lines Per Inch (LPD. This important measure also defines the necessary resolution of an image.

For most print projects, the general BC Marks described previously and below are downloadable from the BCID Graphic Standards Guide Online website. These files are usually suitable.

However, some printing and reproduction methods do not use line screens or halftone spots. For those special projects that do not use line screens, several artwork variations of the provincial mark have been created. These are illustrated below.

# **BACKGROUND:**

On September 8, 2016, the Minister of Education announced that Boards of Education and Independent School Authorities will now be required to reference sexual orientation and gender identity/expression (SOGI) in their anti-bullying policies. Boards of Education and Independent School Authorities are required to make the policy changes by December 31, 2016.

The Minister also announced the role of a SOGI Education Liaison in partnership with the ARC Foundation. The ARC Foundation will provide SOGI expertise to the Ministry, Boards of Education and independent school authorities to support SOGI inclusive anti-bullying policy development. Currently a MOU is being finalized that outlines expectations, responsibilities, resourcing and timelines for this arrangement between the ARC Foundation and the Ministry.

Prior to the Province's September 8 announcement, the ARC Foundation had been planning a SOGI Education Summit for October 21 to bring together 7-9 pilot districts that have or are putting in place district SOGI coordinators and school SOGI leads. As a result of the Province's recent announcement, Ministry of Education staff have been engaging the ARC Foundation in discussions of how this summit might support the provincial goal of seeing every school district and independent school have SOGI inclusive anti-bullying policies in place by the end of the calendar year. s.13

The Minister has been invited to speak at the October 21<sup>st</sup> summit, along with Glen Hansman, President of the British Columbia Teachers Federation (BCTF).

# **DISCUSSION:**

Ministry staff are now proposing that the Ministry, in partnership with the ARC Foundation, hold a separate policy summit with the senior leadership teams of school districts and independent schools on October 25. This date coincides with an already planned Ministry Partner-Liaison meeting involving superintendents and board chairs.

The intent of the policy summit would be to bring together all 60 school districts and approximately 20 Federation of Independent School Associations (FISA) representatives to cocreate SOGI inclusive anti-bullying policies and explore how to translate these policies into action at the local level.

**ARC** Foundation

## WHEREAS:

- The Ministry is responsible for overseeing all aspects of BC's K-12 education system, including setting policies and guidelines for boards of education, allocating funding, establishing curriculum, and governance of boards of education and independent school authorities through the School Act and the Independent School Act, respectively.
- ARC Foundation is trust settled on June 3, 2008 to act as a charitable foundation.
  It supports projects related to awareness, respect and capacity in improving those
  marginalized in society based on sexual orientation, gender identity, ethnicity or
  financial status.
- 3. ARC Foundation's current focus is the Sexual Orientation and Gender Identity (SOGI) Education Initiative, which aims to facilitate collaboration, programming and funding to ensure every school in British Columbia provides a safe and inclusive environment for every child.
- 4. The parties wish to provide provincial leadership to support SOGI inclusive education, help schools to build inclusive cultures, and provide educators with K-12 tools and resources.

## THE PARTIES AGREE AS FOLLOWS:

- 5. The Ministry will lead a provincial SOGI strategy the goal of which is to ensure that students of all sexual orientations and gender identities can thrive and live authentic lives throughout their K-12 education journey.
- ARC Foundation will support the strategy by:
  - a. Creating a SOGI Education Lead position that will support the provincial SOGI strategy. In furtherance of this goal, the Ministry will contribute to ARC Foundation's costs. Details regarding the Ministry's contribution, and key responsibilities and deliverables related to the position that is to be established by ARC Foundation, are described in separate correspondence between ARC Foundation and the Ministry.

**SUBJECT:** Sexual Orientation and Gender Identity (SOGI) Inclusive Education

### **BACKGROUND:**

Earlier this year, the Minister and Deputy Minister met with representatives from the LGBT2SQ+ community to discuss opportunities to strengthen inclusive education in BC schools. From these discussions, the Deputy Minister recommended the establishment of a SOGI working group to identify opportunities to foster and support an inclusive BC education school environment and education system for all students.

On September 8, 2016, the Minister of Education announced that Boards of Education and Independent School Authorities will now be required to reference sexual orientation and gender identity/expression in their anti-bullying policies consistent with recent changes to the BC Human Rights Code. Boards of Education and Independent School Authorities are required to make the policy changes by December 31, 2016. It was also announced that Ministry and the ARC (Aware Respect Capacity) Foundation will be partnering to leverage SOGI expertise through a SOGI Education Liaison role intended to directly support boards of education and independent school authorities with anti-bullying policy development or enhancements.


The NDP Critic Spencer Herbert, MLA (Vancouver West-End) has strongly advocated for the protection of transgender people in BC's Human Rights Code. Since 2011, he tried four times to introduce the *Gender Identity and Expression Human Rights Recognition Act*, a private members' bill, to ensure transgender individuals are explicitly protected in BC's human rights code and called on the BC government to ensure that all health authorities in the province have transgender health programs. It is expected that Mr. Herbert would like to know more about the partnership announcement between the Ministry and the ARC Foundation as well as next steps that are planned to support SOGI inclusive education.

## **DISCUSSION:**

Currently a Memorandum of Understanding (MOU) is being finalized that outlines expectations, responsibilities, resourcing and timelines for the partnership between the ARC Foundation and the Ministry. \*s.13\*

The Ministry along with the ARC Foundation are exploring the opportunity to host two SOGI leadership conferences this fall focused on building capacity of SOGI district and school leaders, as well as policy and procedure development for school district and independent school association leaders.



Government's comprehensive ERASE Bullying Prevention Strategy promotes inclusion, and supports the diversity of all BC students, including students who identify as LGBT2SQ+. This includes training for educators and community partners that focuses specifically on addressing systemic racism, homophobia and creating inclusive schools for LGBT2SQ+ children and youth. To date, 4 levels of training have been provided to 15,000 educators and community partners in 60 school districts and 152 independent schools.

Other areas within the Ministry that support SOGI inclusive education includes the redesigned curriculum where sexual orientation and gender identity understanding are part of the content of the Physical and Health Education curriculum. As well, the MyED BC system enables students to indicate their preferred name and gender.

## **CONCLUSION**

Encouraging districts/schools to adopt SOGI inclusive education ensures all students across British Columbia, regardless of where they live or which school they attend, are able to lead an authentic life.

## Appendix 1 - Q&As

# 1. What does the Ministry's September 8th announcement mean for public schools and independent school authorities?

School districts and independent school authorities will need to include all applicable elements of the human rights code into local anti- bullying policies. Elements in the Human Rights Code include race, colour, ancestry, place of origin, political belief, religion, marital status, family status, physical or mental disability, sex, sexual orientation and gender identity or expression.

It requires Boards of Education to have codes of conducts in all their schools that explicitly reference and provide protection for persons who are LGBT2SQ+ by referencing sexual orientation and gender identity/expression.

It requires independent school authorities to have bullying and harassment prevention policies that explicitly reference the prohibited grounds of discrimination, including sexual orientation and gender identity.

# 2. How is this different from the previous requirement of boards to include the prohibited grounds of discrimination in their codes of conduct?

We are amending the Provincial Standards for Codes of Conduct Order and requiring boards to explicitly reference sexual orientation and gender identity/expression in their school codes of conduct.

# 3. Independent school authorities are already required to have bullying and harassment prevention policies in place. How does this announcement impact independent schools?

Independent school authorities are required to have anti-bullying and harassment policies in place; however, local policies will need to be reviewed and where applicable amended to include the specific elements outlined in the Order, including reference to the prohibited grounds of discrimination which now includes sexual orientation and gender identity/expression.

# 4. Does this change run contrary to an independent school authority's rights/freedoms under the BC Human Rights Code?

No. Independent school authorities are bound by the BC Human Rights Code which provides prohibited grounds for discrimination. However, Section 41 also provides exemptions for non-profit religious educational organizations, among others, that have as a primary purpose the promotion of the interests and welfare of an identifiable group, such as a faith-based independent school. This exemption is provided so that faith-based school authorities can grant preference in hiring staff whose beliefs and values are consistent with the faith-based school, and to expect students to respect the school's values if they choose to attend the school.

## **Exemptions**

41 (1) If a charitable, philanthropic, educational, fraternal, religious or social organization or corporation that is not operated for profit has as a primary purpose the promotion of the interests and welfare of an identifiable group or class of persons characterized by a physical or mental disability or by a common race,

religion, age, sex, sexual orientation, gender identity or expression, marital status, political belief, colour, ancestry or place of origin, that organization or corporation must not be considered to be contravening this Code because it is granting a preference to members of the identifiable group or class of persons.

5. Will this change parallel what has taken place in Alberta where the Minister of Education has released provincial guidelines for SOGI policy and have mandated boards to have comprehensive SOGI policies in place that provide wide-ranging support to students with diverse sexual orientations, including the creation of student-led clubs, such as gay-straight alliances, ensuring those with diverse gender identity would be allowed to use washrooms of their choosing, try out for all sports teams, or be addressed with different pronouns instead of "he" or "she?

The Ministry is committed to developing a robust SOGI education strategy and is partnering with the ARC Foundation to support school districts and independent school authorities in developing their policies and programs to be inclusive of sexual orientation and gender identity.

# 6. What are the timelines for schools to include sexual orientation and gender identity in their anti-bullying policies?

Boards of Education and independent school authorities will be required to have their policies in place by December 31, 2016. Note: some districts may not have them formally approved by their Boards until January due to board meeting schedules.

# 7. What resources are in place to support Boards of Education and independent school authorities in updating their anti-bullying policies?

The Ministry of Education is partnering with the ARC Foundation to support school districts and independent school authorities in updating their anti-bullying policies to be inclusive of sexual orientation and gender identity.

Through this partnership, the ARC Foundation will leverage its network of SOGI experts and act as a SOGI Education liaison, providing expertise to the Ministry, Boards of Education and independent school authorities. The ARC Foundation will also help identify and/or develop appropriate resources in support of this work.

Several school districts are already participating in a SOGI Education initiative led by the ARC Foundation. Through this work, additional resources and tools for schools will be identified and developed.

# 8. How will the ARC Foundation and newly created SOGI Education Advisor be engaging with Boards of Education and independent school authorities?

The ARC Foundation will be working closely with Ministry of Education staff on a detailed project plan and engagement strategy.

The Ministry, in collaboration with the ARC Foundation, are planning a SOGI policy summit for October 25. Superintendents and/or their delegate and representatives of the FISA will be invited to participate in the policy summit. The focus of the summit will be to co-create policy and discuss how to translate this policy into action.

# 9. What kind of reporting will be required of Boards of Education and independent school authorities?

The Ministry of Education will be asking Boards of Education to report back to the Ministry by the end of the school year (2016/17) the status of their anti-bullying policies.

Independent school authorities' policies will be verified through the regular school inspection process and reporting to the Ministry

# 10. What Are Other Jurisdictions Doing to Support SOGI Inclusive Education?

Four provinces and one territory have introduced education policies/best practice guidelines to support LGBT2SQ+ students/SOGI education. (Alberta, Saskatchewan, Nova Scotia, New Brunswick and the Yukon).

Five provinces and one territory mandate GSA clubs. (Alberta, Manitoba, Ontario, Nova Scotia, New Brunswick and the Yukon.)

The federal government has introduced a Bill, which adds gender identity as a prohibited ground for discrimination under the Canadian Human Rights Act and to the list of distinguishing characteristics of 'identifiable group' protected by the hate speech provisions of the Criminal Code.

# 11. Are There Districts Proactively Supporting SOGI Inclusive Education?

## 12. How is the Ministry Helping Districts Adopt SOGI Inclusive Education Practices?

Through the partnership with the ARC Foundation, Ministry staff will be working with District leaders this fall to better understand what schools/districts/educators need to fostering safe and inclusive schools.

It is expected that developing policies, procedures, language, awareness and education will be identified as key actions. Depending on the outcome of these discussions, the Ministry may consider developing provincial guidelines to support districts in their efforts to support LGBT2SQ+ children and youth.

# 13. What is the Ministry Doing to Support Gender Neutral Facilities and Gender Sexuality Alliances (GSAs) in all Schools?

Based on the outcome of the discussions with district leaders this fall, more information will be gathered on the number of schools/districts that have gender neutral facilities and GSAs and an understanding of the challenges districts face. Once this information is understood, districts can share best practices, build capacity and increase ways to adopt more inclusive measures to support LGBT2Q+ students.

Many schools have already designated staff washrooms into gender neutral washrooms at no cost. There can still be a barrier for transgendered students as often they need a key to access the staff washroom leaving them vulnerable to harassment by other students. In order for some schools to make gender neutral facilities available, funding may be required to support infrastructure changes that are needed. As this time, it is recommended that all new school builds and upgrades consider adding gender neutral facilities as part of the planning process.

Currently any school can establish a GSA; however, it is dependent on a school staff member to facilitate the club. A *School Act* amendment would be required to give student's the right to have a Gender Sexuality Alliance (GSA) club in their school. This is something the SOGI Working Group and District Leaders will consider as part of the broader SOGI inclusive education discussions taking place this fall.

## 14. What Work Has the SOGI Working Group Done to Date?

Actions to date include:

- The identification of short, medium and long term policy options (provided to the DM/Minister);
- The development of gender identity instructional samples in coordination with the Ministry of Health that complement the curriculum redesign;

- Collaboration to hosts two sessions:
  - October 21st Capacity building session for SOGI district and school leaders
  - October 25th Policy and procedures development session for school district and independent school association leaders
- Initial discussion of policy, regulatory, legislative levers to advance SOGI education in B.C.

## Gender Sexuality Alliances (GSAs)

Any public or independent school can establish a GSA; however, a *School Act* amendment would be required to give student's the explicit right to have a Gender Sexuality Alliance (GSA)

club in their school. As part of the SOGI Policy Submit this fall, Ministry staff will be sharing best practices around SOGI policies, including the benefits of GSAs for translating policy into action.

## **Training**

Government's comprehensive ERASE Bullying Prevention Strategy promotes inclusion, and supports the diversity of all BC students, including students who identify as LGBT2SQ+. This includes training for school administrators, school counsellors and community partners that focuses specifically on addressing systemic racism, homophobia and creating inclusive schools for LGBT2SQ+ children and youth. To date, 4 levels of training have been provided to over 15,000 educators and community partners in 60 school districts and 152 independent schools.

The Ministry is also exploring ways to increase education and understanding of students, teachers and school communities beyond policy changes to SOGI Education. Last school year, the Ministry invited the Out In Schools program to provide an educational workshop to all Safe School Coordinators. The Out in Schools program brings interactive presentations to schools using film and facilitated group discussions to educate young people about the impact of discrimination toward LGBT2SQ+ people. Out in Schools has delivered over 750 presentations to more than 60,000 students, educators and support staff in 37 school districts across the province s.13

### Curriculum

All public and independent schools (with the exception of...??) are required to teach the BC curriculum. The new curriculum includes discussion of sexual identity and gender as part of the Physical and Health Education (PHE) curriculum. In collaboration with the Ministry of Health, the Ministry of Education and the ARC Foundation produced instructional samples for Sexual Orientation and Gender Identity in support of the PHE curriculum. As well, ERAC (Educational Resource Acquisition Consortium) provides an extensive list of LGBT2SQ+ resources available to public and independent schools.

It should also be noted that MyED BC system supports inclusion for all students by allowing a student to indicate their preferred name and gender.

The Ministry is committed to developing a robust SOGI education strategy and is partnering with the ARC Foundation to support school districts and independent school authorities in developing their policies and programs to be inclusive of sexual orientation and gender identity.

7. What are the timelines for schools to include sexual orientation and gender identity in their anti-bullying policies?

Boards of Education and independent school authorities will be required to have their policies in place by December 31, 2016. Note: some districts may not have them formally approved by their Boards until January due to board meeting schedules.

8. What resources are in place to support Boards of Education and independent school authorities in updating their anti-bullying policies?

The Ministry of Education is partnering with the ARC Foundation to support school districts and independent school authorities in updating their anti-bullying policies to be inclusive of sexual orientation and gender identity.

Through this partnership, the ARC Foundation will leverage its network of SOGI experts and act as a SOGI Education liaison, providing expertise to the Ministry, Boards of Education and independent school authorities. The ARC Foundation will also help identify and/or develop appropriate resources in support of this work.

Several school districts are already participating in a SOGI Education initiative led by the ARC Foundation. Through this work, additional resources and tools for schools will be identified and developed.

9. How will the ARC Foundation and newly created SOGI Education Advisor be engaging with Boards of Education and independent school authorities?

The ARC Foundation will be working closely with Ministry of Education staff on a detailed project plan and engagement strategy.

The Ministry, in collaboration with the ARC Foundation, are planning a SOGI policy summit for October 25. Superintendents and/or their delegate and representatives of the FISA will be invited to participate in the policy summit. The focus of the summit will be to co-create policy and discuss how to translate this policy into action.

# **10.** What kind of reporting will be required of Boards of Education and independent school authorities?

The Ministry of Education will be asking Boards of Education to report back to the Ministry by the end of the school year (2016/17) the status of their anti-bullying policies.

Independent school authorities' policies will be verified through the regular school inspection process and reporting to the Ministry

Four provinces and one territory have introduced education policies/best practice guidelines to support LGBT2SQ+ students/SOGI education. (Alberta, Saskatchewan, Nova Scotia, New Brunswick and the Yukon).

Five provinces and one territory mandate GSA clubs. (Alberta, Manitoba, Ontario, Nova Scotia, New Brunswick and the Yukon.)

The federal government has introduced a Bill, which adds gender identity as a prohibited ground for discrimination under the Canadian Human Rights Act and to the list of distinguishing characteristics of 'identifiable group' protected by the hate speech provisions of the Criminal Code.

# 13. How is the Ministry Helping Districts Adopt SOGI Inclusive Education Practices?

Through the partnership with the ARC Foundation, Ministry staff will be working with District leaders this fall to better understand what schools/districts/educators need to fostering safe and inclusive schools.

It is expected that developing policies, procedures, language, awareness and education will be identified as key actions. Depending on the outcome of these discussions, the Ministry may consider developing provincial guidelines to support districts in their efforts to support LGBT2SQ+ children and youth.

# 14. What is the Ministry Doing to Support Gender Neutral Facilities and Gender Sexuality Alliances (GSAs) in all Schools?

Based on the outcome of the discussions with district leaders this fall, more information will be gathered on the number of schools/districts that have gender neutral facilities and GSAs and an understanding of the challenges districts face. Once this information is understood, districts can share best practices, build capacity and increase ways to adopt more inclusive measures to support LGBT2Q+ students.

Many schools have already designated staff washrooms into gender neutral washrooms at no cost. There can still be a barrier for transgendered students as often they need a key to access the staff washroom leaving them vulnerable to harassment by other students. In order for some schools to make gender neutral facilities available, funding may be required to support infrastructure changes that are needed. As this time, it is recommended that all new school builds and upgrades consider adding gender neutral facilities as part of the planning process.

**SUBJECT:** Sexual Orientation and Gender Identity (SOGI) Inclusive Education

#### **BACKGROUND:**

Fostering inclusive and caring schools has benefits for all, including LGBT2SQ+ \*students and staff. Compared with their heterosexual peers, LGBT2SQ+ youth are more likely to report substance use problems, are at greater risk of suicide and self-injurious behaviours and are least likely to attend post-secondary.

<u>Earlier</u> <u>This</u> year, <u>the</u> <u>Minister</u> and Deputy Minister met with representatives from the LGBT2SQ+ community to discuss opportunities to strengthen inclusive education in BC schools. **s.13**

On September 8, 2016, the Minister of Education announced that Boards of Education and Independent School Authorities will now be required to reference sexual orientation and gender identity/expression in their anti-bullying policies consistent with recent changes to the BC Human Rights Code. Boards of Education and Independent School Authorities are required to make the policy changes by December 31, 2016. It was also announced that Ministry and the ARC (Aware Respect Capacity) Foundation will be partnering to leverage SOGI expertise through a SOGI Education Liaison roleposition-intended to directly support boards of education and independent school authorities with anti-bullying policy development or enhancements.

The NDP Critic Spencer Herbert, MLA (Vancouver West-End) has strongly advocated for the protection of transgender people in BC's Human Rights Code. Since 2011, he tried four times to introduce the *Gender Identity and Expression Human Rights Recognition Act*, a private members' bill, to ensure transgender individuals are explicitly protected in BC's human rights code and called on the BC government to ensure that all health authorities in the province have transgender health programs. #### **ERASE Bullying Strategy**

Government's comprehensive ERASE Bullying Prevention Strategy promotes inclusion, and supports the diversity of all BC students, including students who identify as LGBT2SQ+. This includes training for educators and community partners that focuses specifically on addressing systemic racism, homophobia and creating inclusive schools for LGBT2SQ+ children and youth. To date, 4 levels of training have been provided to 15,000 educators and community partners in 60 school districts and 152 independent schools.

Other areas within the Ministry that support SOGI inclusive education includes the redesigned curriculum where sexual and gender identity understanding <u>areis a-part</u> of the content of the Physical and Health Education curriculum. As well, the MyED BC system enables students to indicate their preferred name and gender.

### CONCLUSION

Encouraging districts/schools to adopt SOGI inclusive education ensures all students across British Columbia, regardless of where they live or which school they attend, are able to lead an authentic life.

## Appendix 1 - Q&As

What does the Ministry's September 8 announcement mean for public schools and independent school authorities?

School districts and independent school authorities will need to include all applicable elements of the human rights code into local anti- bullying policies. Elements in the Human Rights Code include race, colour, ancestry, place of origin, political belief, religion, marital status, family status, physical or mental disability, sex, sexual orientation, gender identity or expression,

It requires Boards of Education to have codes of conducts in all their schools that explicitly reference and provide protection for persons who are LGBTQ by referencing sexual orientation and gender identity/expression.

It requires independent school authorities to have bullying and harassment prevention policies that explicitly reference the prohibited grounds of discrimination, including sexual orientation and gender identity.

How is this different from the previous requirement of boards to include the prohibited grounds of discrimination in their codes of conduct?

We are amending the Provincial Standards for Codes of Conduct Order and requiring boards to explicitly reference sexual orientation and gender identity/expression in their school codes of conduct.

<u>Independent school authorities are already required to have bullying and harassment</u> prevention policies in place. How does this announcement impact independent schools?

Independent school authorities are required to have anti-bullying and harassment policies in place; however, local policies will need to be reviewed and where applicable amended to include the specific elements outlined in the Order, including reference to the prohibited grounds of discrimination. Human Rights code, including sexual orientation and gender identity.

<u>Does this change run contrary to an independent school authority's rights/freedoms under the BC Human Rights Code?</u>

No. Independent school authorities are bound by the BC Human Rights Code which provides prohibited grounds for discrimination. However, Section 41 also provides exemptions for non-profit religious educational organizations, among others, that have as a primary purpose the promotion of the interests and welfare of an identifiable group, such as a faith-based independent school. This exemption is provided so that faith-based school authorities can grant

# PROVINCE OF BRITISH COLUMBIA MINISTRY OF EDUCATION

### TRANSFER UNDER AGREEMENT

THIS AGREEMENT dated for reference the 8th day of March, 2017

### **BETWEEN:**

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, represented by the Minister of Education

(the "Province", "Board", "Tribunal", "we", "us" or "our", as applicable)

#### OF THE FIRST PART

### AND:

ARC Foundation PO Box 20064, Fairview Post Office 525 West Broadway Vancouver BC V5Z 4B3 (the "Recipient", "you" or "your" as applicable)

## OF THE SECOND PART

The parties to this Agreement agree as follows:

### **SECTION 1 - APPOINTMENT**

1.01 The Province retains the Recipient to provide the services (the "Services") during the term (the "Term"), both described in Schedule "A".

### SECTION 2 - PAYMENT OF A FINANCIAL CONTRIBUTION

- 2.01 Subject to the provisions of this Agreement, the Province will provide the Recipient with a financial contribution (the "Financial Contribution"), in the amount and manner, and at the times set out in Schedule "B" attached to this Agreement.
- 2.02 Notwithstanding any other provision of this Agreement the payment of the Financial Contribution" by the Province to the Recipient pursuant to this Agreement is subject to:
  - (a) there being sufficient monies available in an appropriation, as defined in the *Financial Administration Act* ("FAA"), to enable the Province, in any fiscal year when any payment of money by the Province to the Recipient falls due pursuant to this Agreement, to make that payment; and

(b) Treasury Board, as defined in the FAA, not having controlled or limited, pursuant to the FAA, expenditure under any appropriation referred to in subparagraph (a) of this paragraph.

## 2.03 The Recipient must:

- (a) apply for any refund or remission of federal or provincial tax or duty available with respect to any items that the Province has paid for or agreed to pay for under this Agreement (the "Refund"), and
- (b) on receipt of the Refund, comply with the requirements concerning the use, application or remittance of the Refund set out in Schedule "B" to this Agreement.
- 2.04 Paragraph 2.03 continues in force indefinitely, even after this Agreement expires or is terminated.

## **SECTION 3 - REPRESENTATIONS AND WARRANTIES**

- 3.01. The Recipient represents and warrants to the Province with the intent that the Province will rely thereon in entering into this Agreement that:
  - (a) all information, statements, documents and reports furnished or submitted by it to the Province in connection with this Agreement are true and correct;
  - (b) it has no knowledge of any fact that materially adversely affects, or so far as it can foresee, might materially adversely affect, its properties, assets, condition (financial or otherwise), business or operations or its ability to fulfill its obligations under this Agreement;
  - (c) it is not in breach of, or in default under, any law, statute or regulation of Canada or of the Province of British Columbia applicable to or binding on it or its operations;
- 3.02 All statements contained in any certificate, application, proposal or other document delivered by or on behalf of the Recipient to the Province under this Agreement or in connection with any of the transactions contemplated hereby will be deemed to be representations and warranties by the Recipient under this Agreement.
- 3.03 All representations, warranties, covenants and Agreements made herein and all certificates, applications or other documents delivered by or on behalf of the Recipient are material and will have been relied upon by the Province and will continue in full force and effect during the continuation of this Agreement.

### **SECTION 4 - RELATIONSHIP**

4.01 No partnership, joint venture, agency or other legal entity will be created by or will be deemed to be created by this Agreement or any actions of the parties pursuant to this Agreement.

- 4.02 The Recipient will be an independent contractor and not the servant, employee or agent of the Province.
- 4.03 The Recipient will not in any manner whatsoever commit or purport to commit the Province to the payment of money to any person, firm or corporation.
- 4.04 The Province may, from time to time, give instructions to the Recipient in relation to the carrying out of the Services, and the Recipient will comply with those instructions but will not be subject to the control of the Province regarding the manner in which those instructions are carried out except as specified in this Agreement.

## **SECTION 5 - RECIPIENT'S OBLIGATIONS**

## 5.01 The Recipient will:

- (a) carry out the Services in accordance with the terms of this Agreement during the Term stated in Schedule "A" of this Agreement;
- (b) comply with the payment requirements set out in Schedule "B", including all requirements concerning the use, application and expenditure of the Financial Contribution provided under this Agreement;
- (c) comply with all applicable laws;
- (d) hire and retain only qualified staff;
- (e) without limiting the provisions of subparagraph (c) of paragraph 5.01, carry out criminal record checks as required by the *Criminal Records Review Act*, in accordance with Schedule "D", if attached to this Agreement; and
- (f) Unless agreed otherwise supply, at its own cost, all labour, materials and approvals necessary to carry out the Services.
- (g) co-operate with the Province in making such public announcements regarding the Services and the details of this Agreement as the Province requests; and
- (h) acknowledge the financial contribution made by the Province to the Recipient for the Services in any Materials, by printing on each of the Materials the following statement:
  - "We gratefully acknowledge the financial support of the Province of British Columbia through the Ministry of Education."

### **SECTION 6 - RECORDS**

## 6.01 The Recipient will:

- (a) establish and maintain accounting and administrative records in form and content satisfactory of the Province, to be used as the basis for the calculation of the Financial Contribution:
- (b) establish and maintain books of account, invoices, receipts and vouchers for all expenses incurred in form and content satisfactory to the province; and
- (c) permit the Province at any time or times during normal business hours, to copy or audit, or both, any or all of the books of account and records (including original supporting documents) referred to in sub-paragraphs (a) and (b) of this paragraph.

6.02 The Recipient will not, without the express written consent of the Province, dispose of any time records, books of account, invoices, receipts or vouchers relevant to this Agreement.

## SECTION 7 - STATEMENTS AND ACCOUNTING

- 7.01 Within 3 months of being requested to do so by the Province, the Recipient will:
  - (a) Provide the Province, financial statements(s) for the Recipients' last fiscal year, covering the term of this Agreement;
- 7.02 At the sole option of the Province, any portion of the Financial Contribution provided to the Recipient under this Agreement and not expended at the end of the Term shall be:
  - (a) returned by the Recipient to the Minister of Finance;
  - (b) retained by the Recipient as supplemental funding provided for under an amendment to this Agreement; or
  - (c) deducted by the Province from any future funding requests submitted by the Recipient and approved by the Province.

## **SECTION 8 - REPORTS**

- 8.01 Upon the Province's request, the Recipient will:
  - (a) in a timely manner, fully inform the Province of the work completed and remaining to be done by the Recipient under this Agreement, and
  - (b) permit the Province at all reasonable times to inspect, audit, examine, review and copy any findings, data, specifications, drawings, working papers, reports, surveys, spread sheets, evaluations, documents, databases and material, (both printed and electronic, including, but not limited to, hard disk or diskettes), whether complete or not, that is produced or otherwise acquired by the Recipient as a result of this Agreement (collectively, the "Material").

## **SECTION 9 - CONFLICT OF INTEREST**

9.01 The Recipient will not, during the Term, perform a service for or provide advice to any person, or entity where the performance of such service or the provision of the advice may, in the reasonable opinion of the Province, give rise to a conflict of interest between the obligations of the Recipient to the Province under this Agreement and the obligations of the Recipient to such other person, or entity.

### **SECTION 10 - CONFIDENTIALITY**

10.01 The Recipient will treat as confidential all information or material supplied to or obtained by the Recipient, or any sub-contractor, as a result of this Agreement and will not, without the prior written consent of the Province, except as required by applicable law including *the Freedom of Information and Protection of Privacy Act*, permit its disclosure except to the extent that such disclosure is necessary to enable the Recipient to fulfill its obligations under this Agreement.

### **SECTION 11 - DEFAULT**

- 11.01 Any of the following events will constitute an Event of Default, namely:
  - (a) the Recipient fails to comply with any provision of this Agreement;
  - (b) any representation or warranty made by the Recipient in accepting this Agreement is untrue or incorrect:
  - any information, statement, certificate, report or other document furnished or submitted by or on behalf of the Recipient pursuant to or as a result of this Agreement is untrue or incorrect;
  - (d) the Recipient ceases, in the opinion of the Province, to operate;
  - (e) a change occurs with respect to any one or more, including all, of the properties, assets, condition (financial or otherwise), business or operations of the Recipient which, in the opinion of the Province, materially adversely affects the ability of the Recipient to fulfill its obligations under this Agreement;
  - an order is made or a resolution is passed or a petition is filed for the liquidation or winding up of the Recipient;
  - (g) the Recipient becomes insolvent or commits an act of bankruptcy or makes an assignment for the benefit of its creditors or otherwise acknowledges its insolvency;
  - (h) a bankruptcy petition is filed or presented against, or a proposal under *the Bankruptcy and Insolvency Act* (Canada) is made by, the Recipient;
  - (i) a receiver or receiver-manager of any property of the Recipient is appointed; or
  - (j) the Recipient permits any sum which is not disputed to be due by it to remain unpaid after legal proceedings have been commenced to enforce payment thereof.

### **SECTION 12 - TERMINATION**

- 12.01 Upon the occurrence of any Event of Default and at any time thereafter the Province may, notwithstanding any other provision of this Agreement, at its option, elect to do any one or more of the following:
  - (a) terminate this Agreement, in which case the payment of the amount required under paragraph 12.03 of this Agreement will discharge the Province of all liability to the Recipient under this Agreement;
  - (b) require the Event of Default be remedied within a time period specified by the Province;

- (c) suspend any installment of the Financial Contribution or any amount that is due to the Recipient while the Event of Default continues;.
- (d) waive the Event of Default;
- (e) pursue any other remedy available at law or in equity.
- 12.02 The Province may also, at its option, either:
  - (a) terminate this Agreement on 30 days' written notice, or
  - (b) terminate this Agreement immediately if the Province determines that the Recipient's failure to comply places the health or safety of any person receiving the Services at immediate risk,
  - and in either case, the payment of the amount required under paragraph 12.03 of this Agreement will discharge the Province of all liability to the Recipient under this Agreement.
- 12.03 Where this Agreement is terminated before 100% completion of the Services, the Province will pay to the Recipient that portion of the Financial Contribution which is equal to the portion of the Services completed to the satisfaction of the Province prior to termination.

### **SECTION 13 - DISPUTE RESOLUTION**

13.01 All disputes arising out of or in connection with this Agreement will be referred to and finally resolved by arbitration pursuant to the *Commercial Arbitration Act*.

### SECTION 14 - INSURANCE AND INDEMNITY

- 14.01 During the Term of this Agreement, the Recipient will provide, maintain and pay for insurance as specified in Schedule "C", if any, which may be amended from time to time at the sole discretion of the Province.
- 14.02 Without limiting the provisions of subparagraph (c) of paragraph 5.01, the Recipient will comply with the Workers' Compensation Legislation for the Province of British Columbia.
- 14.03 The Recipient will indemnify and save harmless the Province, its employees and agents, from and against any and all losses, claims, damages, actions, causes of action, costs and expenses that the Province may sustain, incur, suffer or put to at any time either before or after the expiration or termination of this Agreement, where the same or any of them are based upon, arise out of or occur, directly or indirectly, by reason of any act or omission of the Recipient, or of any agent, employee, officer, director or sub-contractor of the Recipient pursuant to this Agreement, excepting always liability arising out of the independent negligent acts of the Province.

## SECTION 15 - ASSIGNMENT AND SUB-CONTRACTING

- 15.01 The Recipient will not, without the prior, written consent of the Province:
  - (a) assign, either directly or indirectly, this Agreement or any right of the Recipient under this Agreement; or
  - (b) sub-contract any obligation of the Recipient under this Agreement.
- 15.02 No sub-contract entered into by the Recipient will relieve the Recipient from any of its obligations under this Agreement or impose upon the Province any obligation or liability arising from any such sub-contract.
- 15.03 This Agreement will be binding upon the Province and its assigns and the Recipient, the Recipient's successors and permitted assigns.

### **SECTION 16 - OWNERSHIP AND COPYRIGHT**

- 16.01 Copyright in the Material will be the exclusive property of the Province and, at the request of the Province, the Recipient will provide documents confirming the vesting of copyright in the Province.
- 16.02 The Recipient acknowledges and agrees that the Province exclusively owns:
  - (a) all documents received by the Recipient from the Province as a result of this Agreement, including findings, software, data, specifications, drawings, reports, and documents, and
  - (b) any property that is provided by the Province to the Recipient for the purposes of this Agreement, unless the Province has indicated in writing that the property provided is to be owned by the Recipient.
  - (the documents and property referred to in subparagraphs (a) and (b) collectively referred to as the "Province's Property").
- 16.03 The Recipient will deliver the Material and the Province's Property forthwith following the expiration or sooner termination of this Agreement; provided that the Province may, at any time or times prior to the expiration or sooner termination of this Agreement, give written notice to the Recipient requesting delivery by the Recipient to the Province of any or all of the Material and Province's Property, in which event the Recipient will forthwith comply with that request.
- 16.04 If the Recipient is a person, or a sole proprietorship, the Recipient warrants that the Recipient is the only person who has or will have moral rights in the Material and the Recipient hereby waives in favour of the Province all of the Recipient's moral rights, as provided for in the law of copyright, in the Material produced by the Recipient, and upon that Material coming into existence, the Recipient agrees to execute documents provided by the Province acknowledging the waiver of the Recipient's moral rights in such Material.

16.05 If the Recipient is a corporation, professional association. or joint venture, the Recipient will cause any of its employees, sub-contractors, partners, or members as the case may be, who have moral rights in the Material to execute a waiver of moral rights on any form of waiver provided by the Province, and to forward the waiver to the Province.

### **SECTION 17 - OTHER FUNDING**

17.01 If the Recipient receives funding for or in respect of the Services from any person, firm, corporation or other government or governmental body, then the Recipient will immediately provide the Province with full and complete details thereof.

## **SECTION 18 - NOTICES**

18.01 Any written communication from the Recipient to the Province must be mailed, personally delivered or faxed to the following address:

- 18.03 Any written communication from either party will be deemed to have been received by the other party on the third business day after mailing in British Columbia; on the date of personal delivery if personally delivered; or on the date of transmission if faxed;
- 18.04 Either party may, from time to time, notify the other party in writing of a change of address and, following the receipt of such notice, the new address will, for the purposes of paragraph 18.01 or 18.02 of this Agreement, be deemed to be the mailing address of the party giving notice.

## **SECTION 19 - NON-WAIVER**

19.01 No term or condition of this Agreement and no breach by the Recipient of any such term or condition will be deemed to have been waived unless such waiver is in writing signed by the Province and the Recipient. 19.02 The written waiver by the Province or any breach by the Recipient of any term or condition of this Agreement will not be deemed to be a waiver of any other provision of any subsequent breach of the same or any other provision of this Agreement.

## **SECTION 20 - ENTIRE AGREEMENT**

20.01 This Agreement constitutes the entire Agreement between the parties with respect to the subject matter of this Agreement.

## **SECTION 21 - SURVIVAL OF PROVISIONS**

21.01 All of the provisions of this Agreement in favour of the Province including, without limitation, paragraphs 2.02, 4.03, 6.01, 7.02, 8.01, 10.01, 12.03, 14.03, 16.01 to 16.05, 18.01 to 18.04 and all of the rights and remedies of the Province, either at law or in equity, will survive any expiration or sooner termination of this Agreement.

## **SECTION 22 - MISCELLANEOUS**

- 22.01 This Agreement will be governed by and construed in accordance with the laws of the Province of British Columbia.
- 22.02 The Schedules to this Agreement are an integral part of this Agreement as if set out at length in the body of this Agreement.
- 22.03 No amendment or modification to this Agreement will be effective unless it is in writing and duly executed by the parties.
- 22.04 If any provision of this Agreement or the application to any person or circumstance is invalid or unenforceable to any extent, the remainder of this Agreement and the application of such provision to any other person or circumstance will not be affected or impaired thereby and will be enforceable to the extent permitted by law.
- 22.05 Nothing in this Agreement operates as a consent, permit, approval or authorization by the Government of the Province of British Columbia or any Ministry or Branch thereof to or for anything related to the Services that by statute, the Recipient is required to obtain unless it is expressly stated herein to be such a consent, permit, approval or authorization.
- 22.06. Where the Recipient is a corporation, the Recipient warrants that the signatory has been duly authorized by the Recipient to execute this Agreement without corporate seal on behalf of the Recipient.
- 22.07 This Agreement may be executed by the parties in separate counterparts each of which when so executed and delivered shall be an original, and all such counterparts may be delivered by facsimile transmission and such transmission shall be considered an original.

- 22.08 For the purpose of paragraphs 22.09 and 22.10, an "Event of Force Majeure" includes, but is not limited to, acts of God, changes in the laws of Canada, governmental restrictions or control on imports, exports or foreign exchange, wars (declared or undeclared), fires, floods, storms, strikes (including illegal work stoppages or slowdowns), lockouts, labour shortages, freight embargoes and power failures or other cause beyond the reasonable control of a Party, provided always that lack of money, financing or credit will not be and will not be deemed to be an "Event of Force Majeure".
- 22.09 Neither party will be liable to the other for any delay, interruption or failure in the performance of their respective obligations if caused by an Event of Force Majeure, in which case the time period for the performance or completion of any such obligation will be automatically extended for the duration of the Event of Force Majeure.
- 22.10 If an Event of Force Majeure occurs or is likely to occur, then the party directly affected will notify the other Party forthwith, and will use its reasonable efforts to remove, curtail or contain the cause of the delay, interruption or failure and to resume with the least possible delay compliance with its obligations under this Agreement.

# **SOGI E-Learning Proposal**

The ARC Foundation has approached the Ministry of Education for a financial commitment of \$50k, to support the implementation of a multi-phased Educator SOGI Learning and Development Strategy \$.13,s.17 s.13.s.17

Phase 1 –SOGI 1 2 3 Videos will share information in two to three minute learning segments. # Advancing Sexual Orientation and Gender Identity (SOGI) Inclusive Education in British Columbia September, 2016

#### CONCEPT PAPER

#### OVERVIEW AND CONTEXT

The Ministry of Education is focused on supporting inclusive and respectful school environments where all students are at their best. To support this work the Ministry has established a Sexual Orientation and Gender Identity (SOGI) Working Group, in partnership with the Awareness, Respect, Capacity (ARC) Foundation, to explore and identify opportunities to foster and support an inclusive British Columbia education system for all students.

The Minister is considering implementing a strategy to compel boards of education and independent school authorities to have policies that prevent bullying and harassment of all students including specific reference to SOGI. To support this important work, it is recommended that a SOGI Education Liaison position be established in partnership with the ARC Foundation.

#### SOGI EDUCATION LIAISON POSITION OVERVIEW

The SOGI Education Liaison will provide leadership, expertise and support to both public schools and independent schools in establishing or enhancing anti-bullying policies with specific focus on SOGI. This includes sharing best practises, being a conduit of information and building capacity and understanding throughout the Education Sector. The position will also support with advising and recommending on SOGI teacher training, learning resources and tools. The SOGI Education Liaison will have responsibility for working with boards of education and independent school authorities to ensure policies are in place across public and independent schools and consideration has been given to how these policies will be supported, implemented and actioned.

The ARC Foundation is recognised for its leadership and expertise in supporting SOGI education and has been a key partner with the Ministry of Education. As such, it is recommended that the SOGI Education Liaison be funded and resourced within the ARC Foundation and provide support to the Ministry through the establishment of a Memorandum of Understanding. The position would be a one year term, commencing September 2016 and concluding September 2017. The position would be part-time (40% full-time equivalent) until December 2016 with the option of full-time for the remainder of the term.

#### TIMELINE AND KEY DELIVERABLES

The SOGI Education Liaison will be established September 2016. The work will be organized into three phases of design, implementation and reporting.

#### DESIGN

From September 2016 to December 2016, the SOGI Education Liaison will work in partnership with the Ministry of Education to establish a memorandum of understanding, terms of reference and a project plan. Once these are in place, the position will work on behalf of the Ministry and focus on consultations and communications with boards of

education and independent school authorities to outline expectations and support for establishing or enhancing antibullying policies with specific focus on SOGI.

#### IMPLEMENTATION

From January 2017 to May 2017, the SOGI Education Liaison will work closely with the Ministry to support implementation and enhancement of anti-bullying policies with specific focus on SOGI. Key deliverables of this phase include sharing of best practises, providing awareness and training as well as supporting districts and independent schools with tools and resources.

#### REPORTING

From June 2017 to September 2017, the SOGI Education Liaison will work with School Districts and Independent School Authorities to ensure policies are established and consideration has been given to how these policies will be supported, implemented and actioned. A key deliverable of this phase will be a summary status report as well as recommendations for next steps.

#### **SOGI Education Lead Position**

The Recipient will create a one year, temporary full time equivalent (FTE) position that will support the Province in delivering on its priorities related to sexual orientation and gender identity (SOGI) inclusive education. The purpose of the SOGI Education Lead is to act as a provincial subject matter expert in SOGI education for the Ministry of Education and the ARC Foundation. The position will focus on the implementation of provincial SOGI education activities and supporting the BC SOGI Educator Network, and driving systemic change through experiential learning.

The term of this position will be one year, from August 1, 2017 to July 31, 2018. *Qualifications* 

- K-12 educator with a BC Teaching Certificate (in good standing) that has subject matter expertise
  in SOGI-inclusive education. Preference will be given to candidates with a combination of
  Master's Degree and significant classroom experience.
- Extensive experience developing and delivering SOGI-related content to students and educators including training, curriculum and legislation/policy awareness
- A leader and connecter in the BC education and LGBTQ communities with the ability to establish and maintain effective relationships
- A collaborative style which values connecting people, both in the community and within organizations such as the Ministry of Education, BCTF and UBC
- Strong communication and interpersonal skills, including facilitation and presentation skills to support working with a wide variety of people.
- Entrepreneurial spirit and in-field approach to building community capacity.

Key Responsibilities and Deliverables

The position would support provincial priorities and the BC SOGI network (50/50 split). These responsibilities and deliverables would include:

Provincial:

- Act as Province-wide subject matter expert for SOGI, including providing advice to the Ministry of Education on potential legislation and policy
- Support Boards of Education and Independent School Authorities in developing SOGI related policies and procedures
- Work with education partners and subject matter experts to identify key trends and issues that impact BC schools
- Advise on the development and delivery of content for SOGI learning and development across BC
- Advise on the development and delivery of SOGI content for special events, including provincial SOGI Summits and school-based campaigns and initiatives
- Lead SOGI community collaboration, maintaining relationships with local, provincial and national LGBTQ community organizations on behalf of Ministry of Education and ARC Foundation

- Work with Ministry of Education communications team to advise on SOGI-focused communications
- Work with the Student Wellness and Safety team to increase internal knowledge, tools and process related to SOGI
- Support the sharing of expertise and resources between Ministry of Education, BCTF, UBC Faculty of Education and ARC Foundation
- Coordinate meetings and liaise with members of the MOE SOGI Working Group or other body the Ministry decides to establish

#### BC SOGI Network:

- Lead BC SOGI Educator Network communications, meetings and activities, maintaining engagement and ensuring the timely sharing of information
- Act as Province-wide subject matter expert for District SOGI Leads, providing guidance, coaching and issue resolution support
- Develop and deliver content for District SOGI Lead and SOGI School Lead presentations and training throughout the year, including the annual Summit
- Support District SOGI Leads with the resolution of SOGI issues/situations as they arise in their district
- Share age-appropriate resource materials to SOGI District Leads for use in their district e.g. key messaging and language, including books, online, videos, activities and literacy kits
- Provide District SOGI Leads with support and issue resolution related to BC SOGI Educator
   Network process and tools, including the SOGI School Lead role and District SOGI Toolkit
- Support the sharing of SOGI expertise and resources across school districts and independent schools

#### Reporting

The position would report to the Executive Director of the ARC Foundation, who would consult with the designated Ministry of Education representative regarding key priorities. The Executive Director will regularly report on the status and progress of work undertaken by this position. The ARC Foundation will provide the Ministry with a 6 month report and 12 month report on the work undertaken by the position.

#### **BACKGROUND:**

In September 2016, the Minister of Education announced a partnership with the ARC Foundation of Vancouver to support schools in developing Sexual Orientation and Gender Identity (SOGI) inclusive policies. As a result of this announcement, the Ministry formalized the partnership through a MOU. The MOU is set to end on September 30, 2017, with the option to renew.

The MOU did not involve financial commitments from either party.

#### **DISCUSSION:**

The partnership with the ARC Foundation has resulted in a number of significant accomplishments including the development of guiding principles for SOGI inclusive education, provincial SOGI policy and leadership summits, and integration of SOGI into school districts' and independent schools' codes of conduct. s.13

In the current MOU, the ARC Foundation's role involves providing access to SOGI expertise, and supporting boards of education and independent school authorities in developing SOGI inclusive policies and procedures.
