

Gentlemen

Congratulations on your recent election and on forming government. Most of you are well versed in the RDV case and indicated during the election campaign that your government would solve the constitutional breach at RDV.

As you all know, the Supreme Court of Canada declared a prima facie breach to section 23 of the Charter back in April 2015. At that time your predecessors chose to continue with legal arguments rather than address the urgent situation at RDV. I remind you that right holders have been leaving the school since at least 2010 because of the non-equivalent facilities offered at RDV. In September 2016 the BC Supreme Court confirmed the SCC declaration of a breach of section 23 at RDV and neither the Conseil Scolaire Francophone de la Colombie-Britannique (the CSF) nor the Minister of Education appealed that part of Justice Russell's decision. The legal wrangling over RDV is therefore finally over: as the parents advised back in 2008 prior to launching their petition against the CSF and the Minister of Education, a breach of section 23 of the Charter exists at RDV because the CSF and the Province are not affording equivalent services to right holders west of Main street and that breach, as confirmed by the SCC, has been ongoing since at least 2010.

The Minister of Education along with the CSF is presently in negotiations with the Federal Government via CLC and MST on a possible school site for RDV at Heather Lands (former RCMP location). As it turns out, the Federal Government did not live up to its obligations under the Official Languages Act when it transferred the Heather Lands to the CLC back in 2014. Despite this frustrating oversight by the Federal Government, the Charter Breach at RDV is yours alone to resolve as education is a provincial matter. These Heather Lands negotiations have not yet borne fruit as understandably, the MST group has raised concerns. We also learned last month from Mr. Heyman that the VSB is actively negotiating the subdivision of the Southlands Elementary School site (W 38th Avenue and Camosun) in order to allow the construction of a French school at that location. We urge you to get that site secured prior to announcing a by-election for the VSB as that election will only serve to bog down further the transfer of this site to the CSF.

To further exasperate the situation, the CSF on the Minister's urging, accepted in May a lease of Henderson Annex to temporarily address the overcrowding at RDV. Unfortunately that annex is on the east side of the catchment area (Henderson Annex is east of Fraser St at E 54 Ave) and has forced some right holders to withdraw their children from the CSF, choosing instead the VSB or private schools. This temporary solution was announced without a parallel announcement of at least 1 permanent site for RDV! This is completely unacceptable and only serves to further the breach existing at RDV. Why would the CSF and the Minister accept such an outcome after clearly being scolded by the SCC and the BCSC over the constitutional breach at RDV?

The RDV parents certainly do not want to return to court to force the Province and the CSF to act. However as you have witnessed since 2008, the parents are steadfast in defending their right and will not stop until a permanent solution for RDV is announced. Our children and grandchildren, and dare I say our Country, is depending on us to see this through to resolution.

We are available to discuss this pressing matter at your convenience.

The Kamloops SD has done some analysis of historic spending by school district to see how they compare with other SDs in capital funding since 2002. (see attachment.)

Sorted by capital program \$s they indicate they are 46th with \$4.6M in capital while being 13th in enrolment.

Their premise is that they should be getting more capital dollars invested in their schools based a distributed capital dollars on an enrolment basis instead of a condition basis. (Note: This comparison excludes there annual AFG which is in the range of been ~\$3M per year for a total of \$46,843,812 over this period and is based on a student enrolment formula.)

Kamloops has not received significant capital investment above AFG because there schools are in good condition, they have very limited enrolment growth pressure (although there is a bit emerging now in a couple areas) and they do not have any high risk seismic schools.

The dry climates great for maintaining schools and much easier on schools than humid, wet coastal environments.

We are looking at options for some expansions in the future on the west shore and potentially out near Valleyview.

- Ministry of Education staff prepared a three-year forecast for projected school district spending
- Recognition that the ministry has ownership of the SD forecast as it has not been signed off by the SDs
- The Ministry of Education staff have reviewed and agree with all of the School District financial information included in the Fiscal Plan, prepared by the Ministry of Finance (tables and texts in the attached).

We have reviewed a copy of the school district sector forecast information, both tables and text, as they will appear in the Province's Budget and Fiscal Plan, and confirm there are no issues.

I am told the confirmation letter is required back to the Ministry of Finance on Tuesday, August 29 @ noon.

Background:

- As per the *School Act*, school districts are required to provide annual budgets to the Province by June 30 and Audited Financial Statements by September 30.
- The Ministry of Education consolidates the information from the 60 school districts to form the financial statements for SD99.
- These financial statements are used to build a forecast for school districts over the three-year fiscal plan, which includes expected revenues and expenses. This forecast is then consolidated into the results of the GRE.

This will be Scott's first confirmation, so please let me know if you require additional information.


