Thank you for taking the time to review both our email, and attachments, from *Be Well Canada*. As a new not-for-profit society, our mission is to improve health and wellness outcomes for children and their families by providing education, support and healthy in-school food programs. We are advocates for universal ways for children to develop a love of learning, the natural world, health and sustainable food in their communities.

We are pleased to share our current proposal and work which is based on a single site project we

undertook between 2012 and 2014, at a high-needs middle school in the Greater Victoria School District. With well over 30% of our youth facing poverty, food scarcity, obesity and malnutrition, we needed to act. Our goal at that time was to have an impact on our student's attendance and achievement, and reduce the stress load on their families. We developed a universal and sustainable healthy food program that provided locally sourced, organic, sugar-free and home-made breakfasts and lunches to all of our students. As *Be Well* has taken shape, so has our goal: to impact all of BC's children and their families in the area of universal healthy food programs.

We have recently begun to target the health of very young children, providing professional learning to early childhood educators and child-care providers. We have been consistently struck by the significant challenges they are facing in caring for our most vulnerable as related to food scarcity, quality nutritional education and the potential of serving a universal daily meal. Unfortunately, poverty and the practical and philosophical challenges of universality are constant barriers.

We are excited about your Ministerial mandate as outlined by Premier Horgan, and believe that our past project experience and proposal will be of help in reducing poverty and improving the health and education of our children and the communities in which they live at no additional cost to government.

We would be most grateful for any time you have to discuss our full proposal and initial findings. Attached here is a letter sent to Mr. Liam Illife, then Ministerial Assistant for the Minister of Education. I have also attached a draft funding proposal made to *President's Choice Children's Charities* to give you a sense of the project, its scale and measurable objectives.

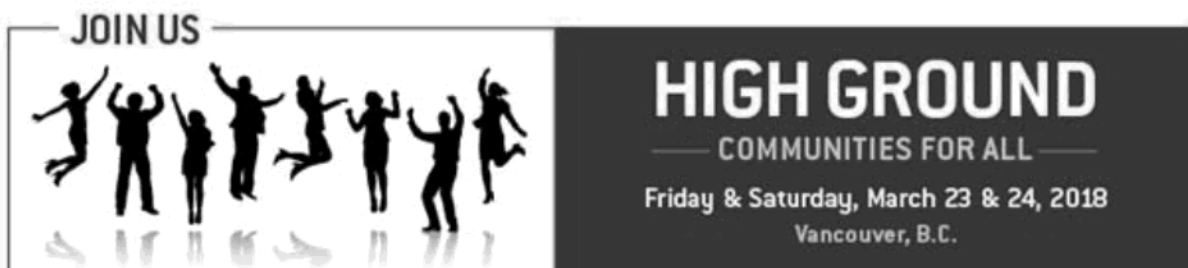

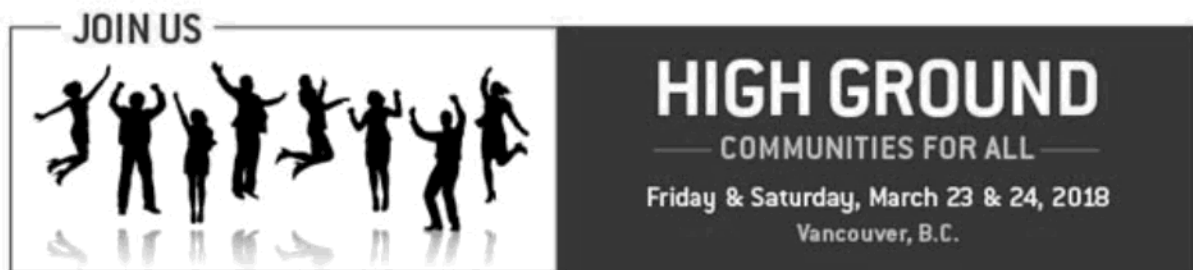
