SUBJECT: Certification for French Speaking Teachers in BC

BACKGROUND:

There is high demand for certified French teachers in British Columbia. The Minister of Education's recent visit to Europe has generated strong interest in recruiting internationally educated French speaking teachers to BC. The visit coincided with the Federal government's announcement of financial support for recruiting French teachers to and in Canada. The Teacher Regulation Branch has been consulted on possibilities for prioritizing French teacher applications.

KEY FACTS:

- BCs Certification Standards are set by the **BC Teachers' Council**. The Council was established in 2012 and receives its mandate from the *Teachers' Act*. It is **responsible for setting the standards** for the education, competence, and professional conduct of all BC educators.
- Certification of teachers is granted by the Director of Certification when the applicant meets BCs required Certification Standards.
- ~~BCs Certification Standards are set by the **BC Teachers' Council**. The Council was established in 2012 and receives its mandate from the *Teachers' Act*. It is **responsible for setting the standards** for the education, competence, and professional conduct of all BC educators.~~
- The Certification Standards were last revised in 2008, in response to the Trade, Investment, and Labour Mobility Agreement (TILMA) between Alberta and BC. Further minor revisions were made in 2010 to align with the Agreement of Internal Trade (AIT), now the Canadian Free Trade Agreement (CFTA). **s.13**

Hi Kapka,

Tina has forwarded your inquiry to me for response.

You asked how we define “expedite” in regards to the files we are processing as priority. Expedited files can still take up to several weeks before they are processed. A file that is flagged to be expedited is placed in a separate category—i.e. “priority files”. Priority files are reviewed ahead of all other applications, but within those priority files, applications are still reviewed in the order they are received, and we currently have a very high volume of priority files.

As for the list of 11 teachers you have provided, all of them have submitted an application to our office except for s.22

s.22 : is the only applicant with a file created because she had submitted her application to our office at the end of November 2017. Her file has been flagged as priority and will be reviewed shortly.

The other 9 applications were all received at the end of December 2017 and are waiting in the queue for a file to be created. These 9 files have now been flagged as priority and files will be created for them as soon as possible.

In the meantime, you should do the following:

1. Ask each teacher to complete a Voluntary Consent Form (attached to this email), authorizing the TRB to discuss their applications with you.
2. Have each teacher review the required items on our website – they should start arranging for documents to arrive (for example, official transcripts, character reference forms, verification of employment, teaching assessment, etc.)

Hi Wendy,

Yes, it has consistently been challenging to recruit teachers from France. While the TRB does not normally issue a Letter of Permission (LOP) as a matter of course. Generally, teachers that go through a university TEP such as those at the School of Education at Strasbourg are likely to at least qualify for a Conditional COQ and would then make up any required coursework such as Canadian studies. It is usually the teachers that do not do any university study in education and challenge the Concours exams that would need to apply for an LOP as they do not generally qualify for certification.
