Hello Honourable Flemming,

My name is Santanna Hernandez and I am the secretary on the Parent Advisory Council for Glenmerry Elementary School in Trail BC. We are the only elementary school in the City of Trail due to closures made by the previous government.

It has been brought to my attention that you plan on traveling to our little corner of the province on April 2nd to take part in our opening of our new Library. I would love the opportunity to take you on a tour of our school. Despite it being closed our staff has agreed to meet me and open the school if I am able to arrange a time for you to come on a tour.

The reason we would like you to come and tour our school is to show you how desperately we are in need of a rebuild. We are over capacity, we currently have 6 portables(which I know may seem like not much compared to lower mainland schools) that have maxed out our electrical grid so we are not able to add anymore, none of which have running water so children have to get on their snow gear to head inside to use the washrooms or even just wash their hands in winter. We will be increasing another division in September which projections showing continual increase over the next 3 years. To accommodate this new division our support service room will be retrofitted to into a classroom and we will be losing our computer lab. Presently our school cannot accommodate physical education classes so students are using Youtube dance videos of PE class because in the winter there is no where else for them to go to ensure they are getting in the required gym blocks.

These are just a few of the issues we are facing at our school, in Premier Horgan's Mandate letter to you one of the priorities he indicated was working in Partnership to build and upgrade schools in every region of the province. We would love the opportunity to show you how our region here could use your help.

My name is Cst. Sue Hamilton. I am a Police Officer with the Victoria Police Department. Between May 2-5, 2018 I will be one of 15 other police officers taking part in a YOUTH for CHANGE and INCLUSION (YCI) Conference/Camp where 80-100 High School Students will be attending.

The reason for this email is to request your endorsement of the Conference in the form of your signature on a Certificate of Completion that the students receive at the end of the Camp.

Here is some information about the Conference/Camp.

The Conference/Camp is called YCI - YOUTH for CHANGE and INCLUSION. The purpose is to expose students to issues surrounding hate, prejudice and intolerance and develop projects to implement within their schools to facilitate a more accepting environment.

There have been 15 past conferences since 2003 and have involved 1000 students from various Victoria schools including: Victoria High, Spectrum, Esquimalt High, Stelly's Secondary, Oak Bay High, Claremont High, Mt. Doug High, Oak Bay High, Lansdowne, Colquitz and the Inter-Cultural Association.

Each school supplies a teacher or teachers to attend the camp, and they work with the students on their projects once back at school.

Officers from the Victoria Police Department, RCMP and Saanich Police Department have participated as camp leaders.

The Camp has proven to be an interesting and valuable experience for all the participants, both students and adults. Presenters are brought in to speak on topics on racism, homophobia, the challenges of immigrants and refugees, the impact of residential schools, the holocaust, hate crimes, bullying, conflict resolution and preventing the spread of hate on the Internet.

Surveys returned by students post-conference indicated it was a life-changing event for many. Their testimonials reflected the enormous personal growth that had taken place in a short period of time.

I have been fortunate to be part of this amazing Program led by Sgt. Paul Brookes. The Program is Sponsored by the Victoria Police Department and other community partners such as Coast Capital Saving who have been long standing contributors.

Upon completion of the camp each participant receives a Certificate recognizing their participation. Past signatures have been obtained by Prime Minister Justin Trudeau, Education Ministers George Abbott, Peter Fassbender and Mike Bernier, and Superintendents of School District 61. 5 years ago International renowned author and speaker Dr. Wayne Dyer (now deceased) signed them. By seeking the endorsement of more prominent figures we are hoping to spread the message and help our school communities recognize the importance and necessity of incorporating these messages into their schools.

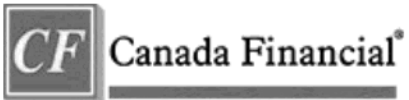
