Good morning Minister

The Craigflower Schoolhouse is located at the western edge of your riding. First opened in 1855, the Schoolhouse is the oldest existing school building in Western Canada, a National Historic Site, and the oldest Provincially-owned building.

It operated as a school until 1911/1912 when a new, four-room school was built across Admirals Road on the site of the existing elementary school. As frequently happens today, old schools are usually demolished but, in this instance, the then Minister of Education, Dr. Edson Young, requested, in the Legislature, that the building be preserved for historic reasons.

The Hallmark Heritage Society currently has a long-term lease on the building from the Province. Due to the historic significance of the Schoolhouse, it's location and your position, the Society would like to offer the Schoolhouse as a possible location for public announcements or other events that you may consider suitable at no cost to the Ministry.

Should you or anyone from your staff wish to view, just let us know and we will so arrange.
