Staff advice on The Whole Dyslexic Society and whether or not staff should meet with Sue Hall.

The Whole Dyslexic Society

- The Whole Dyslexic Society was founded by Sue Hall in 2001.
- The Whole Dyslexic is an organization which offers a “coordinated and central approach in addressing the needs of the dyslexic individual, their families and their community....”
- Sue has based her organization on The Davis® Dyslexia Correction Program (located in California):
 - The Davis® Dyslexia Correction Program was developed by Ronald Dell Davis from independent experimentation and research, beginning in the early 1980's.
 - Davis, who was himself severely dyslexic, had discovered a simple mental technique that radically improved his ability to focus on print (he used a tactile-kinesthetic approach to trace letters).

- Through clinical experience working with dyslexic adults and children, Davis and his colleagues improved and refined the methods over time.
- In 1994, after working with more than 1,000 clients, Davis published the first edition of *The Gift of Dyslexia*, detailing his methods and the theory behind them. Since that time, hundreds of professionals have received advanced training in Davis methods, and licensed Davis Facilitators have collectively worked with more than 20,000 clients.
- I could only find one study related to the program: "The Effect of the Davis Learning Strategies on First Grade Word Recognition and Subsequent Special Education Referrals" coauthored by T.F. McLaughlin, Ph.D. (Gonzaga University), was published in the journal "Reading Improvement" in August, 2001. Pfeiffer, S., Davis, R., Kellogg, E., Hern, C., McLaughlin, T. F., & Curry, G. (2001, Summer).
 - The research showed that students who were in the Davis Learning Strategies (Davis, 1994) classrooms showed significantly higher accuracy on tests of basic sight word recognition. However the study stated that additional research is needed in other settings with larger groups of children. Testing should be conducted on a broader range of skills including qualitative reading samples and comprehension. Generalization to other language arts skills should also be assessed.

Honorable Rob Fleming, Minister of Education, BC

May I introduce myself – I am Sue Hall, Chair of The Whole Dyslexic Society, author of *Fish Don't Climb Trees*, and over the past 20 years have worked with 500+ children and adults who are so-called learning disabled as Sue Hall-Positive Dyslexia. I would like to meet you, preferably for real, but virtually (Zoom) if need be, to share some significant information with you.

- As many as one third of the children at school, who currently struggle to learn to read, could successfully be taught to read in the regular classroom without extra interventions, resources or tutors.
- This is the result of our present education methods reaching the verbal conceptualisers, but not the non-verbal conceptualisers.
- As a result many of these children are erroneously labelled 'learning disabled'. They are in fact learning able, they simply don't learn in the way they are taught.
- These children are entitled to a cognitive equal opportunity alongside their peers.
- In 2 days K-3 teachers can learn a method that will reach every child in the regular classroom (with the exception of some physically challenged learners) regardless of whether they are verbal, or non-verbal learners, enabling them to read, write, spell, and do basic Math
- Teachers also learn how to deliver self-regulation tools to the students, alleviating then onerous task of class management.

In summary, if one third of the population were taught in the way they learned, the majority of learning disabilities would cease to exist. If you remove the reason for the problem (the current method of teaching basic skills) the problem ceases to exist. This benefits the children, their parents, the teachers and the education budget, the children who really need their EAs and SEAs, not to mention having a positive impact on reducing the potential prison population. As you know, 75% of all felons have a so-called learning disability.

I attach research connections presented by the mother of one of my students, who is an avid researcher, homeschooler and author. I would be happy to provide more details/information when needed. I look forward to hearing from you, and meeting you at your earliest convenience, thank you for your consideration.

Dear Minister Fleming

Thank you very much for meeting with Linda Kaser and me on May 8. It was great to meet you in person and to talk about our mutual respect for our colleague Catherine McGregor (copied here).

We feel privileged to work with educators from across BC and the Yukon through our work with NOII and AESN and to see the growing impact of our work in BC in other jurisdictions.

We are grateful that Scott MacDonald was able to speak to the 350 attendees at our recent symposium. Among those present were educators from New South Wales, California, Sweden and England. The response to Scott's message of high expectations and clarity of direction was very positive. We know - and appreciate - how fortunate we are to live and work as educators in BC.

We mentioned at our meeting that Catherine has been leading two research studies associated with NOII AESN. The first is a three year connected to improving transitions for Indigenous learners in ten secondary schools. Catherine presented the initial findings at the symposium and a final report will be available during the summer. The findings have been highlighted in a poster form that is still a working draft attached for your interest. We are hoping to extend this study next year by bringing on a new cohort of schools and using some of the leaders from the first group to serve as coaches to the new schools.

The second research study involves a group of districts whose joint interest is to learn from each other about the ways in which a disciplined approach to inquiry can lead to improved results for learners. A forthcoming American publication on the superintendency will include a chapter authored by Catherine on the findings that are emerging from this BC network. We would be pleased to share this with you if you would like.

We very much appreciate the on-going support of the Ministry that is allowing BC educators to learn from each other and to make powerful changes in their practice in support of their learners.

We would welcome the opportunity to follow up with you at any time about the work of NOII and AESN and very much appreciate your interest and support.

we have a really great educational system overall in BC, with highly professional teachers deeply committed to supporting their students in the best way they can. However, you and I both know that the system and the teachers in it aren't perfect—and that in some jurisdictions the challenges are significant. But I have been following the impacts of inquiry based practice on groups of teachers in diverse locations across BC (Nanaimo, Prince Rupert, Fort St. John, Vernon, Parksville, Surrey, Haida Gwaii, Port Hardy, Smithers and South Okanagan)... and have seen the deep learning that is manifested when inquiry is applied to supporting Aboriginal learners. The reports I've done on this work (the first in 2013, the most recent in 2017) shows the incredible power of inquiry to affect change to teachers practices as it shifts their beliefs about the success of their learners. Its pretty exciting research I have to say! I've also been working with 15 school districts from around BC to map how they are supporting inquiry in their districts- and we are learning that inquiry practices are profoundly altering the cultures of districts, with teachers, district leaders and principals sharing commitments to enhancing student success. In some of these districts the growth in student graduation rates is pretty significant. I know our paths have similar trajectories given our shared commitment to politics and issues of social justice. I know that's been at the heart of your work since being elected. Now that you are in a position to effect change in the one Ministry I know best, I hope you'll take advantage of my knowledge about the system, my later career skills as a researcher, but someone equally grounded in the real world of politics, and provide me with an opportunity to point you in a positive direction. I know that funding can be hard to come by, but these networks (NOII/AESN) are having a profound impact on practice and the success of students. I am hoping you can see clear a way to provide some

funding to them—to keep the network active and help teams at the local, regional and provincial level find ways to share their successes and expand those successes to new locations.

I'd love to have a chat one day; I did talk briefly to Scott when he was at NOII in Vancouver on May 12th. I don't know that he was there when I did my presentation on the AESN (Aboriginal Enhancement Schools Network) transitions research I've been doing for the past three years, but it was well received. I think Linda and Judy sent you a poster link... I'm working hard at making my research accessible to practitioners so it can be more easily translated into teaching practice. That is, in part, what I hope the poster will do. I also plan on developing a short executive summary that can be easily circulated... that too will, I hope, be shared in educational jurisdictions across Canada and perhaps in other jurisdictions. If you are interested, I can send you a couple of reports, just let me know.

Hello,

On **June 27**, the Canada West Foundation is hosting a Pop Up Policy discussion on Bill C-69 and reforming Canada's energy regulatory system.

Bill C-69, introduced this year, would overhaul Canada's energy project assessment process, replace the NEB with the CER (Canadian Energy Regulator) and create a new Impact Assessment Agency (IAA). But the bill retains some of the same features that are causing problems in the current system. Last month, we released ***Unstuck: Recommendations for reforming Canada's regulatory process for energy projects***. According to the report, the proposed new system remains flawed, will be mired in delay and will leave decisions vulnerable to eleventh hour changes based on political whim - leaving no one with more confidence in the system. In May, an extensive series of amendments to Bill C-69 were presented to the House. They're a step in the right direction, but some fundamental issues

remain.

Our Pop Up Policy events are an informal gathering of staff and our CWF friends at our office over lunch to hear from guest speakers and talk about interesting policy issues. 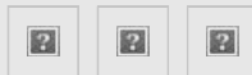



I wanted to take a minute to invite you to The Fraser Region Aboriginal Friendship Centre's 3rd annual Guiding Youth Home Gala. To introduce myself, I am Kyla Bains, Youth Services Program Manager here at the Fraser Region Aboriginal Friendship Centre Association. I do know some of the great work that you and our government do in support on Indigenous Peoples and particularly youth aging out of care.

The Fraser Region Aboriginal Friendship Centre Association (FRAFCA) is hosting their 3rd Annual Fundraising Gala, Guiding Youth Home. FRAFCA has expanded its youth services throughout the agency over the past 3 years to better provide services to youth. FRAFCA holds the contract for All Nations Youth Safe House (ANYSH) in Surrey. ANYSH opened in 2006 as a residential facility which provides up to 6 beds at a time for homeless youth, serving male, female and trans gendered youth. ANYSH serves homeless youth all year round, 24 hours a day 7 days a week. We hold the only youth safehouse for all of Surrey. In 2017 ANYSH served 162 youth who were experiencing homelessness. Out of the 162 youth ANYSH served in 2017, 66 youth were set to age out of care and youth supportive services. Our agency serves many youths both under and over the age of 19 years old. What most of our youth have in common is that they are experiencing homelessness. Our goal as an organization is to expand our youth services further by building transitional housing to serve youth who are aging out of Ministry Care and aging out of youth supportive services. Our youth have voiced their needs to enable them to live in a safe a supportive environment to aid in their transition into adulthood and independence. FRAFCA's vision includes transitional living units supported by wraparound services for the youth who both live in the facility and do not. This would include addictions services, mental health services, life skills workshops, work experience and support, health care services, outreach support and 1-1 workers as well as Cultural Connections with the community. We plan to provide multiple services regarding financial literacy and education expansion for youth as well. Hosting Guiding Youth Home this year will continue to raise funds towards our visions as well as build our community networks and partnerships and raise more awareness in our community for the youth we serve. We are asking for sponsorship support to help in hosting yet another amazing night of fun, entertainment, relationship building and making a difference in the lives of the youth we serve as a community. This night will bring together our community for an amazing cause. The annual Co-op Congress is attended by hundreds of co-operators from coast-to-coast, ranging across sectors, including housing, natural resources, retail, agriculture, and financial services. These community owned and operated enterprises start with the goal of solving local and national challenges, rather than simply generating profits. Hundreds of co-operatives operate in British Columbia, with substantial overlap in objectives with your government. For example, there are 30 housing co-operatives in Victoria alone.

It would be CMC's honour to host Minister Fleming for remarks. I can check the flexibility of schedule to make sure we accommodate the Minister at a time that works for him, as well. If you or your colleagues have any questions I would be happy to answer them at your convenience.

Here is a sketch I did for the mural.

During the consultation with the kids, we did an exercise where each participant got 30 seconds each to say what they would say on every TV and radio in Victoria if they could. Many talked about how there is more going on in people's lives and communities than the eye can see, and how it is important to be empathetic and curious about the world. The participants talked also about how we are all interconnected (people with other people as well as the natural habitat). The survey results conveyed a desire for a mural that would represent diversity in our communities as well as nature. This all seems fitting in a riding that is so diverse, and that has so much more richness than meets the eye when driving through.

In order to represent these ideas, we came up with a water scene in which you can see both over and under the water. The underwater scene is a curvy, flowy, diverse collection of plants and animals (including ones you would normally see on land, such as birds and deer, as well as some first nations animal designs by one of the students). The sky component seems uneventful, with just a few clouds. (This design is a strategic choice too, because this way the kids don't have to climb too high to paint the animals. I can do the clouds.)

I was thinking that we could write something poetic in the sky that makes the message of the mural a bit more clear..."below surface level", "look under the surface"... or we could leave it up to the viewers interpretation. What do you think?

With the work flow for the workshop days, I would like to think of it as "outline-fill-outline". I will outline the mural in advance, we can all fill it in with spraypaint (on day 1), and then we can outline with brush paint (hopefully starting on day 2 then going into day 3).

Here are some things left to do:

- Approve the sketch
- Collect supplies such as paint, rollers, ladders
- Power wash the wall
- Prime the wall
- Sketch out the mural on the wall
- Please add anything if you think of it! :)

I will be pretty busy by the end of next week so if we could get as much possible done during this weekend/the later part of this week, I would be very grateful.

I hope you like the sketch! I'm getting excited for this!
