Good Afternoon

Apologies off the top for this lengthy email but I wanted to provide you with sufficient information for you to assess interest. I also apologize for the late notice but my travel to Victoria has just been arranged.

My name is Gary Rabbior and I am President of the Canadian Foundation for Economic Education. I am contacting you with the hope that there might be interest in the work of CFEE and the possibility of exploring collaboration - not financially, but in ways that could help further economic, financial, and enterprise education in BC.

I am going to be in Victoria on Wednesday and I am exploring the off chance that there may be

interest in our work and a possible meeting.

In a nutshell, CFEE is a federally chartered, national, non-profit, non-partisan organization working to support four areas of learning that we see as associated with building a successful future – economic, financial, enterprise, and career development education and capability.

I have attached a Backgrounder on CFEE should that be of interest to you.

CFEE has a number of target audiences and we work from coast to coast to coast. We do extensive work with the schools, educators, and students throughout Canada. We also work with newcomers to Canada, parents, seniors, and members of Indigenous communities. We have also undertaken programs for employees in the workplace. And our resources are often used by members of the general public. As a result, we have quite extensive experience with all of these target groups in the learning areas I have noted.

In terms of education, CFEE develops and provides resources and programs for free to teachers and students – both in English and in French - and sometimes in additional languages. Many of our resources have been used, and are used, by teachers in BC. We find partners to fund our work so that we can provide them for free to our target audiences. We know how tight budgets are these days.

We also work through trusted intermediaries - e.g. education officials and teachers to reach students, immigrant serving agencies to reach newcomers, parent councils to reach parents, city and town mayors to reach seniors, and Indigenous leaders to support indigenous schools and communities. We also guard our non-partisan status religiously – so there is no commercial aspect to our work at all - and that has resulted in a great deal of trust - and also a capability to reach and deliver to our target audiences in almost unprecedented ways.

As an example, we have earned the trust of the provincial ministries and departments of education across Canada to the point where CFEE coordinates an annual meeting of the Curriculum Directors from all provinces. This includes Brent Munro, the Curriculum Director from BC. We are finding though, at this time, as interest in financial education has grown, that Ministers, and even Premiers in some cases, are taking an interest in this area of learning

As an example of our reach and impact, our Money and Youth book has over 450,000 copies in circulation across Canada and has been translated for use in a number of other countries. Our Newcomers to Canada DayPlanner has over 650,000 copies in circulation - and over the last three years we have organized approximately 100 workshops for newcomers - including a series specially organized for Syrian refugees. Quite a number of these workshops have been in BC.

Last year, our upcoming Talk With Our Kids About Money Day program (April 18th this year) engaged approximately 6,000 schools across the country. It has been an incredible success. We are hoping to get more teachers and parents involved this year. (Please see www.talkwithourkidsaboutmoney.com). We would be delighted if the Minister saw value in this program and might have an interest in helping us engage more parents and teachers in BC. Of course both parents and teachers also learn a great deal once they get involved.

There are many ways in which we are able and willing to support economic, financial, enterprise, and career development efforts in BC. If there was interest, and if someone might have some time on Wednesday, I would welcome the opportunity to provide an in-person briefing and discuss possible ways in which we could assist programs and efforts in BC.

I would look forward to a chance to get together. Thank you.

Hello Liam and William,

My name is Trevor Zimmer and I am a Senior Development Officer at Kids Help Phone. I am reaching out in hopes of arranging a conversation with Minister Fleming.

We have some alarming trends to share with the Minister regarding the challenges young people in BC are facing and how they are utilizing our service. In particular, we found that BC youth had a higher than average proportion of returning/repeat service users, at 40% of all counselling sessions in 2017. We also saw that older youth received counselling second most frequently of any province in Canada.

Kids Help Phone has solutions to the complex challenges facing youth in BC. Our CEO, Kathy Hay, and VP of Counselling, Alisa Simon, will be in Victoria on April 13th. Kathy and Alisa would be open to meeting with the Minister to discuss how we might work with the government on solutions to some of the student mental health challenges in the province. We have significant expertise and offer real value to the conversation, as we talk to thousands of young people a year. We also have a proven school-based solution called Counsellor in the Classroom that we could bring to BC.
