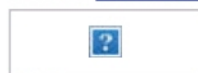

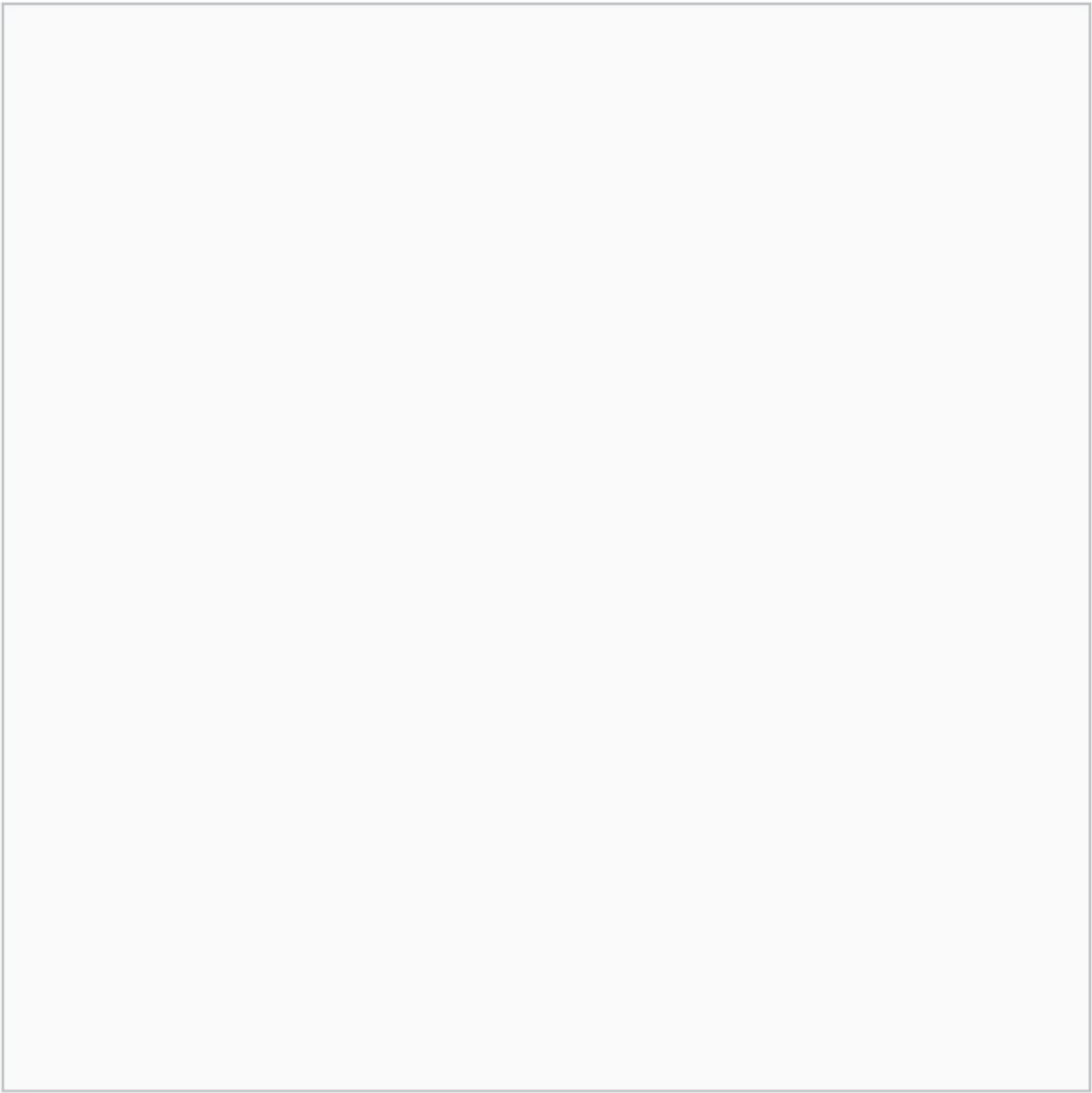

Thanks so much for your time for our recent meeting. And thank you for all your work to improve the lives of all British Columbians. I am hoping you keep time in your life to take care of yourself as well.

I want to also take a moment to thank your incredibly efficient staff who have shown me every consideration and courtesy while organizing our chance to touch base on issues of concern for the gender diverse community of BC.

I have attached digital copies of the materials we reviewed for your reference. Here is the quick summary.

The gender diverse community has a range of issues of concern from SOGI 123 to surgical access. We are a cross sectional community and our opinions on how these issues should be addressed is wide ranging.

As a community owned and controlled co-op, our focus is that everyone's voice across BC is heard - in a way that matches social democratic convention, one person, one vote, and an effective means to collectively act on what is decided. To do this, the Gender Diverse Communities Council of BC (GDCC) includes a community designated representative from each of the 17 Health Districts plus Indigenous representation as determined by their leadership.

We have been working towards this since 2015 when we concluded the first province wide consultation with the gender diverse community. We are fortunate to have acquired federal funding to move forward on the next steps necessary to engage the community as a full partner in the process. We need just a few things from you to ensure success.

Our primary funding is a research project to assess trans healthcare in BC. To make this work, we need a copy of the original committee's recommendations. Although we participated for six months in this consultation, there was never any distribution of the final report. We have requested this directly and we are looking for your written support requesting that it be provided without delay.

There is a lot to do to make this consultation happen, and our resources limits our abilities. We need all BC government ministries to support this community led effort in a collaborative way and grant the time necessary to ensure the results are meaningful. We are requesting that consultation needed by government with the gender diverse community support this process rather than create other, unrelated processes.

Finally, while recognizing the limit of any MLA, budgets and other pressing needs, please consider any way you might be able to lend assistance. We are great at stretching a dollar - but first need that dollar to stretch. I remind you of the opportunity to direct marketing dollars to XQQ, the co-op's community resource magazine. The magazine is the keystone in making sure the results of our research project are available to the community, so your marketing dollars get used at least three times, showing your support, providing resource info across BC and making sure our research remain accessible to the community.

Dear Minister Fleming,

Today marks BC Family Day and while most families are taking extra time to enjoy activities with their loved ones, The Burke Mountain Parents School Group are instead meeting to address the ongoing concerns of the lack of schools on Burke Mountain. We understand that the second elementary school is awaiting your impendent financial approval.

In September 12, 2016, the board of education of SD43 approved a five-year capital plan requesting the province for funding, with Sheffield Elementary being the top project priority. It has been over a year since that initial request was made and funding has not yet been approved. SD43 has resubmitted the funding request this February and is awaiting a response from the Ministry of Education to commence building the new school.

There is a strong need for a second elementary school in our community. Burke Mountain is one of the fastest growing communities in BC and the City of Coquitlam's plan is to grow it into a city of 38 thousand residents. The enclave of families moving into this community have mostly young children that are elementary school aged.

As a result of the large number of young children and the limited space in our only neighbourhood school, parents lined up as early as 5:00 am on the first day of Smiling Creek Elementary registration to ensure that their children secured a spot at the new school. Numerous families who live only blocks away were told that they are not in the catchment area of the new school and they are forced to go through the cross catchment application with no certainty that their children will be able to go to their neighbourhood school.

Even with the opening of Smiling Creek Elementary, SD43 is still playing catch up on elementary schools to meet the needs of the community. The lack of schools in our neighbourhoods continues to be a source of undue duress for families. Families are forced to drive their children outside of their own neighbourhoods to get into schools, sometimes even outside of Coquitlam.

We urge you to work with SD43 by approving their funding request by the April 2018 announcement in order to start building the much needed second elementary school on Burke Mountain as soon as possible.

Our community has been waiting a long time for a school funding approval announcement since the last one that was made by the Liberal government for funding Smiling Creek Elementary back in 2015. We look forward to seeing you again in person, in particular to make the funding announcement that has been approved for Sheffield Elementary as part of the NDP's commitment to build social infrastructures that are needed for our neighbourhood.
