Thanks for your help with the Closer Commutes initiative.

Have you been able to talk with Minister Fleming about indicating his support in principle for the proposed pilot projects?

Recapping: Exploratory discussions have been ongoing for an employee wellness pilot project called "Closer Commutes" involving School Districts 61, 62 & 63. This project would see the Districts identifying and offering closer/greener commutes for teachers and other staff on a voluntary basis. The BCTF has a longstanding resolution advocating the concept of "green lateral exchange/transfers." The parties are hesitant about committing without knowing the Ministry is fully on side also – even though Districts do not legally require Ministry approval. The initiative is expected to improve employee retention and the learning experience, could reduce the \$150 million spent annually on absenteeism, plus there are environmental benefits."

I hope you had a great long weekend. I am unaware of holiday schedules at the legislature – is Minister Fleming available this week to discuss Closer Commutes with me on the phone?

- I discussed Closer Commutes in person with Minister Carole James two weeks ago. She is also supportive and will be discussing potential action with her Cabinet colleagues. She recommends pilot projects be conducted with larger private and public sector employers ASAP as a first step.
- I told Minister James that exploratory discussions have been ongoing for a pilot involving School Districts 61, 62 & 63, and that the parties were hesitant about committing without knowing the Ministry is fully on side – even though Districts do not legally require Ministry approval.
- Minister James asked her constituency assistant Shayli Robinson to arrange for a meeting for me with Minister Fleming and/or people in his office to update Minister Fleming and arrange that such an assurance (I called it his "blessing") be secured.
- Ideally this file would be assigned to someone senior in the Minister's or DM's office, so I have a contact to liaise with for any Ministry involvement and monitoring of progress.

THANKS, Melissa! This could make a huge difference to so many teachers, their families, students, the environment...
