Hi Veronica

It was great to speak with you earlier this week. As promised, attached is a one page summary of our BC Lions Skills for Life program which we ran in partnership with the provincial government and Pacific Northwest LNG from 2014-2016. We were not able to run the program last year with the change in government and PNW LNG backing away from their FID, but we are hoping to be able to resurrect the program once again in 2018 with provincial and private business support. The targeted date for the summit weekend would be scheduled around our final home game on Saturday, November 3rd vs Calgary with the learning session to take place on Sunday November 4th. The Skills for Life Summit is a compilation of three different school programs that our players activate in schools around the province and are then focused around a one day learning session for over 500 students that have been brought in from all school districts in the province.

The first step for us to make this happen is to hopefully meet with Rob and have his approval for the program to take place. We could walk him through a more detailed summary to give him a greater understanding on the benefits the Skills for Life program provided to the students and also provide a short summary of our provincial school programs to make him aware of what our players are currently involved in. Once we have approval from Rob for the program, we would then work on sourcing funding. I do not believe funding was provided by education in the past.

I am hoping you are able to arrange a meeting with the Minister in the next few weeks between myself and Jamie Taras and we are happy to make the trip over to Victoria.

Hi Veronica

It was great to speak with you earlier this week. As promised, attached is a one page summary of our BC Lions Skills for Life program which we ran in partnership with the provincial government and Pacific Northwest LNG from 2014-2016. We were not able to run the program last year with the change in government and PNW LNG backing away from their FID, but we are hoping to be able to resurrect the program once again in 2018 with provincial and private business support. The targeted date for the summit weekend would be scheduled around our final home game on Saturday, November 3rd vs Calgary with the learning session to take place on Sunday November 4th. The Skills for Life Summit is a compilation of three different school programs that our players activate in schools around the province and are then focused around a one day learning session for over 500 students that have been brought in from all school districts in the province.

The first step for us to make this happen is to hopefully meet with Rob and have his approval for the program to take place. We could walk him through a more detailed summary to give him a greater understanding on the benefits the Skills for Life program provided to the students and also provide a short summary of our provincial school programs to make him aware of what our players are currently involved in. Once we have approval from Rob for the program, we would then work on sourcing funding. I do not believe funding was provided by education in the past.

I am hoping you are able to arrange a meeting with the Minister in the next few weeks between myself and Jamie Taras and we are happy to make the trip over to Victoria.

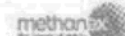
