Dear Minister Fleming,

I am writing on behalf of the Community Action Network (CAN), a group of leaders living in poverty who have gone through our leadership development initiative and now lend their voice and expertise to the BC Poverty Reduction Coalition (BCPRC).

CAN members were excited about plans to speak to you in person before the legislative session was over, but unfortunately government staff were unable to find a day that worked with your busy schedule. We still plan to see you in Victoria in the fall but, in the meantime, CAN members want to make sure that two things remain in the forefront of your mind as you discuss government priorities for the next year: **the devastation of poverty and the unprecedented opportunity you have before you in developing the first ever poverty reduction plan for BC.**

"Life in the Downtown Eastside at times feels like a wasteland, and far too often, more so now than ever before, we're experiencing loss through death, loss of our homes, security and our income, even what we lack is taken away.

I want to be that voice that brings life, that ushers in the well-springs of life—an oasis."

Above is a quote from CAN member, Erica Grant, expressing that devastation of poverty but also the power of her voice in turning it around. She goes on to say: *"The music of a beautiful sounding symphony is made up of many instruments and not just one clanging cymbal."* While we may be the percussion section clanging away in the background, you as government are at the front singing the melody.

So we invite you, as Minister of Education, to use your voice to bring life, to create an oasis. You have a central role to play in this historic moment. As you consider your government and Ministry priorities, how will you ensure that you are raising your voice to contribute to the success of British Columbia's poverty reduction strategy?

I have attached 2 reports to support you in this work: notes from a CAN community workshop; and the submission from the BCPRC. I wish you a happy and productive summer season with your family, friends and constituents.
