## Glossary of final disposition codes:

**CIT Dis** – the citation was dismissed by a hearing panel.

Court ordered suspension – the disposition of a hearing panel was appealed which resulted in a court ordered suspension

**CRA-COND** – a consent resolution agreement indicated conditions, and the matter may have been published or not.

**INI** – indefinite no issue of certification; this occurs usually when the certificate has been relinquished or cancelled for non-payment of fees during the course of the disciplinary proceedings.

**NFA** – no further action; the administrative summary allegation is based on what we received from the information source. Often that was not the finding of the Commissioner, or there was insufficient evidence to verify a sexual misconduct incident or incidents.

**Rel** – the member relinquished certification as part of a hearing panel's order or a consent resolution agreement.

**RM** – a reprimand was issued by the College or the Commissioner

SI – a suspension of indefinite duration

**SNI** – a decision not to issue certification for a specific length of time.

SS – a suspension of specific duration

TC – a termination of certification
