I have met with Minister Fleming previously regarding other health care issues as a Health Sciences Association of BC member. \$.22

I would like to speak to early years mental health \$.22

I currently work in the Early Intervention program at the Queen Alexandra which serves children from 0-5 who are at risk of developmental delay or who in fact have developmental challenges and medical conditions. The multidisciplinary teams are educated in what constitutes normal development and what doesn't. We are an early intervention program similar to other child development centres in the province.

Social and emotional development is critical to outcomes for children. CDC's are perfect for offering attachment based parenting classes as well as working on children's regulation. This often shows up as children who have behaviour issues or present as non responsive.

Child and Youth Mental Health intervenes when issues have become chronic and complex. Their overall mandate is not early intervention. We already employ some disciplines that can help with early signs of mental health issues including Infant Development Consultants, Occupational therapists, Supported Child Development Consultants as well as clinical social workers.

I would ask to see Minister Fleming as soon as possible given the recent airing of Charlie's story. This is one example of the need to find ways to address mental health support needs of children with special needs as well as their families. It is important to note there is research that suggests developmental challenges can be correlated to social determinants of health. Funding needs to be included in the upcoming budget hence my request to meet Minister Fleming in a timely manner.




