I am responding to the request for ministerial approval under authority of section 5 of the Disposal of Land or Improvements Order to dispose of the property referenced above.

Enclosed, please find the required Disposal of Land or Improvements form approved by Michael Nyikes, Director, Standards and Construction. The signed documents will be required by Land Title Office to complete transfer of title for the property.

As you may be aware, the final disposition of board-owned properties continues to be subject to Government's Release of Assets for Economic Generation (RAEG) program. This initiative was first outlined in February 2012, as part of Budget 2012. The intention of the RAEG program is to facilitate the disposition of provincial assets that are surplus to public sector capital needs. Property sales by Government Reporting Entities will not only allow the Province to book sales amounts as revenue, but the use of the proceeds is expected to generate increased economic activity, such as development and new business opportunities, in communities around British Columbia. In the case of surplus school district property disposals, all proceeds will continue to be retained by boards of education for capital reinvestment in their school districts.

Please be reminded that the Order requires boards to submit a copy of a land disposal bylaw to the Ministry, as well as provide written notification regarding the completion of a property sale and the allocation of the resulting proceeds between restricted capital funds and local capital funds in accordance with Section 100 of the *School Act* and the Ministry's Allocation of Proceeds from the Disposition of Capital Assets Policy. 

AND WHEREAS pursuant to Section 96 (1) of the School Act, "land" includes any interest in land, including any right, title or estate in it of any tenure;

AND WHEREAS section 96 (3) of the School Act provides that a board of education may dispose of land or improvements, or both, subject to the orders of the minister;

AND WHEREAS section 3 of the Disposal of Land or Improvements Order provides that boards must not dispose of land or improvements by sale and transfer in fee simple or by way of lease or 10 years or more unless such disposal is to another board or an independent school for educational purposes or is approved by the Minister in accordance with section 5 of the Disposal of Land or Improvements Order;

AND WHEREAS section 5 of the Disposal of Land or Improvements Order provides that the Minister may approve, with any terms and conditions, a disposition of land or improvements;
