I am contacting you today regarding the BC Principal's and Vice-Principals' Associations' recent survey on the impact of the implementation of the Memorandum of Agreement. The BCPVPA has now conducted five members surveys regarding the MoA implementation. Our most recent survey and series of interviews asked our 2440 members to describe the impact of the MoA on their work one year later. As you will see from the survey results, anecdotal comments and our recommendations school leaders still face significant challenges in appropriately staffing and leading their schools.

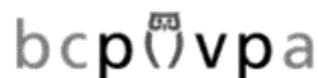
While this is concerning from the perspective of the BCPVPA, we remain optimistic about the future of public education and our role in leading one of the highest performing systems in the world. The PISA results from the past two years clearly demonstrate that BC students often exceed the performance levels of students from all OECD countries. Despite the challenges, BC's principals and vice-principals remain fully committed to operationalizing the Ministry's vision and leading the transformation agenda.
